8 NEW SECTION. SECTION 1. SCHOOL ELECTION INCENTIVE PILOT PROGRAM FOR COUNTIES TO ADMINISTER

9 SCHOOL ELECTIONS. (1) THE OFFICE OF PUBLIC INSTRUCTION SHALL ESTABLISH AN INCENTIVE PILOT PROGRAM FOR  
10 COUNTIES TO ADMINISTER REGULAR SCHOOL ELECTIONS IN MAY 2024.

11 (2) (A) THE OFFICE OF PUBLIC INSTRUCTION SHALL ADMINISTER THE INCENTIVE PILOT PROGRAM AS A  
12 GRANT PROGRAM AND AWARD TO COUNTIES FROM FUNDING APPROPRIATED BY THE LEGISLATURE FOR THE PURPOSES  
13 OF THIS SECTION.

14 (B) THE INCENTIVE PILOT PROGRAM SHALL PROVIDE THAT, SUBJECT TO SUBSECTION (2)(E):

15 (i) COUNTIES THAT CHOOSE TO PARTICIPATE MAY USE THE GRANT MONEY TO PAY PERSONNEL, TRAINING,  
16 AND OPERATING COSTS ASSOCIATED WITH CONDUCTING ONE OR MORE SCHOOL ELECTIONS UNDER THIS SECTION; AND

17 (ii) SCHOOL DISTRICTS THAT CHOOSE TO PARTICIPATE ARE EXEMPT FROM THE PROVISIONS OF 20-20-  
18 417(3) FOR THE MAY 2024 SCHOOL ELECTION AND MAY NOT BE CHARGED BY THE COUNTY FOR THE COST OF  
19 ADMINISTERING THE ELECTION.

20 (C) SUBJECT TO SUBSECTION (2)(E), THE OFFICE OF PUBLIC INSTRUCTION SHALL GRANT TO EACH  
21 PARTICIPATING COUNTY THE AMOUNT REQUESTED BY THE COUNTY TO ADMINISTER ONE OR MORE SCHOOL ELECTIONS  
22 PURSUANT TO THIS SECTION, UP TO THE MAXIMUM OF \$1 FOR EACH REGISTERED ELECTOR IN THE SCHOOL DISTRICT FOR  
23 WHICH THE ELECTION IS ADMINISTERED.

24 (D) TO THE GREATEST EXTENT POSSIBLE, GRANT FUNDING MUST BE PROVIDED TO THE COUNTY BEFORE  
25 THE COSTS ARE INCURRED BASED ON COUNTY ESTIMATES BUT MAY BE PAID AS REIMBURSEMENTS IF NECESSARY.

26 (E) THE OFFICE OF PUBLIC INSTRUCTION SHALL ALLOCATE AVAILABLE FUNDS ON A FIRST-REQUESTED,  
27 FIRST-GRANTED BASIS.

11 **"3-6-201. Number of judges -- election -- term of office -- chief judge -- duties of chief judge. (1)**

12 The governing body of a city shall determine by ordinance the number of judges required to operate the  
13 municipal court.

14 (2) A municipal court judge must be elected at the general election, as provided in ~~13-1-104(3)~~ 13-  
15 1-104. The judge's term commences on the first Monday in January following the election. The judge shall hold  
16 office for the term of 4 years and until a successor is elected and qualified.

17 (3) Except as provided in subsection (2), all elections of municipal court judges are governed by  
18 the laws applicable to the election of district court judges.

19 (4) (a) If there is more than one municipal court judge, the judges shall adopt a procedure by which  
20 they either:

21 (i) select a chief municipal court judge at the beginning of each calendar year; or

22 (ii) select a chief municipal court judge for a specific period of time.

23 (b) If the judges cannot agree, the judge with the most seniority shall serve as the chief municipal  
24 court judge.

25 (5) The chief municipal court judge shall provide for the efficient management of the court, in  
26 cooperation with the other judge or judges, if any, and shall:

- 1 (b) provide for the distribution of cases from the central docket among the judges, if there is more

- 4 (d) if there is more than one judge, temporarily reassign or substitute judges among the  
5 departments as necessary to carry out the business of the court; and
- 6 (e) supervise and control the court's personnel and the administration of the court."

8 **Section 3.** Section 7-2-4107, MCA, is amended to read:

9 **"7-2-4107. Officers elected at first election.** (1) At the election provided for in 7-2-4106, there must  
10 be elected:

11 (a) in a city of the first class, a mayor, a city judge, a city attorney, a city treasurer, a city marshal,  
12 and, except as provided in subsection (3), two city council members from each ward into which the city is  
13 divided;

14 (b) in a city of the second class, a mayor, a city judge, a city treasurer, a city marshal, and two city  
15 council members from each ward;

16 (c) in a town, a mayor and two city council members from each ward.

17 (2) Those elected hold office until the first Monday of January after the first annual election and  
18 until their successors are elected and qualified. The persons elected shall qualify in the manner prescribed by  
19 law for county officers.

20 (3) If the division of a city of the first class into wards represented by two city council members  
21 would result in wards with populations of more than 15,000 inhabitants, then, subject to the limits of 7-5-4401,  
22 the city shall redistrict into twice the number of wards, and each ward must be represented by one city council  
23 member."

26 **"7-4-2611. Role and duties of county clerk and election administrator.** (1) The county clerk of a  
27 county is also clerk of the county commissioners and ex officio recorder. A duty imposed by law upon the

26 (3) An election administrator shall file, code, and cross-index all reports and statements filed as  
27 prescribed by the commissioner of political practices.

4 **"7-4-4402. Term of office.** (1) Except as provided in subsection (2), a city council member shall hold  
5 office for a term of 4 years and until the qualification of a successor.

6 (2) At the first annual election held after the organization of a city or town under this title, the  
7 electors of the city or town shall elect ~~two~~ city council members from each ward, who shall, at the first meeting  
8 of the council, decide by lot their terms of office, with ~~one from each ward to hold half or a simple majority of the~~  
9 ~~council members to hold~~ for a term of 4 years and ~~one the remaining council members~~ for a term of 2 years and  
10 until the qualification of their successors. In the succeeding elections, ~~one city council member from each ward~~  
11 ~~council members who served an initial 2-year term under this section~~ must be elected for a 4-year term."

14 **"7-5-132. Procedure for initiative or referendum election.** (1) The electors of a local government  
15 may, by petition, request an election on whether to enact, repeal, or amend an ordinance. The form of the  
16 petition must be approved by the county election administrator. A petition signed by at least 15% of the local  
17 government's qualified electors is sufficient to require an election.

18 (2) (a) If an approved petition containing sufficient signatures is filed prior to the ordinance's  
19 effective date or within 60 days after the passage of the ordinance, whichever is later, a petition requesting an  
20 election on whether to amend or repeal the ordinance delays the ordinance's effective date until the ordinance  
21 is ratified by the electors.

22 (b) If an approved petition containing sufficient signatures is filed within 60 days after the effective  
23 date of an emergency ordinance, the emergency ordinance is suspended until it is ratified by the electors.

24 (3) The governing body may refer an existing or proposed ordinance to a vote of the people by  
25 resolution.

26 (4) A petition or resolution for an election must:

27 (a) embrace only a single comprehensive subject;

1 (b) set out fully the ordinance sought, the ordinance to be amended and the proposed amendment,

3 (c) be in the form prescribed in Title 13, chapter 27, except as specifically provided in this part; and

4 (d) contain transition provisions if the measure changes terms of office or forms of government.

5 (5) An election held pursuant to this section must be conducted in conjunction with the next local  
6 government election held in accordance with Title 13, chapter 1, part 4, ~~except that if the petition asks for a~~  
7 ~~special election, specifies an election date that complies with 13-1-405, and is signed by at least 25% of the~~  
8 ~~qualified electors, a special election must be held on the date specified in the petition.~~

9 (6) If a majority of those voting on the question approve the proposal, it becomes effective when

13 **"7-6-1504. Resort tax -- election required -- procedure -- notice.** (1) A resort community, resort  
14 area, or resort area district may not impose or, except as provided in 7-6-1505, amend or repeal a resort tax  
15 unless the resort tax question has been approved by a majority of the qualified electors voting on the question  
16 during a general election as described in 13-1-104.

17 (2) The resort tax question may be presented to the qualified electors of:

18 (a) a resort community by a petition of the electors as provided in 7-5-131, 7-5-132, 7-5-134, 7-5-  
19 135, and 7-5-137 or by a resolution of the governing body of the resort community;

20 (b) a resort area by a resolution of the board of county commissioners, following receipt of a  
21 petition of electors as provided in 7-6-1508;

22 (c) an existing resort area district by a resolution of the board of directors of the resort area district  
23 in accordance with special district election procedures provided in 13-1-501 through 13-1-505.

24 (3) If a proposed resort area is in more than one county, the resort tax question must be presented  
25 to and approved by the qualified electors in the resort area of each county.

2 (c) the date when the tax becomes effective, which date may not be earlier than 35 days after the

4 (d) the purposes that may be funded by the resort tax revenue. If the petition or resolution includes  
5 the additional tax provided for in 7-6-1503(1)(b)(i), the revenue from the additional tax must be designated for  
6 infrastructure and the specific uses must be identified in the petition or resolution. The additional levy for  
7 infrastructure authorized under this subsection (4)(d) terminates when the specified infrastructure debts and  
8 project costs are paid unless the board submits and the qualified electors approve another levy for  
9 infrastructure.

10 (5) On receipt of an adequate petition, the governing body shall hold an election in conjunction  
11 with a general election and in accordance with Title 13, chapter 1, part 5.

12 (6) (a) Before the resort tax question is submitted to the electorate of a resort community or resort  
13 area, the governing body of the resort community or the board of county commissioners in the county in which  
14 the resort area is located shall provide notice of the goods and services subject to the resort tax by a method  
15 described in 13-1-108.

16 (b) The notice must be given two times, with at least 6 days separating the notices. The first notice  
17 must be no more than 45 days prior to the election, and the last notice must be no less than 30 days prior to the  
18 election.

19 (7) Notice of the election must be given as provided in 13-1-108 and include the information listed  
20 in subsection (4) of this section.

21 (8) The question of the imposition of a resort tax may not be placed before the qualified electors  
22 more than once in any fiscal year.

23 (9) The governing body, as defined in 7-6-1505, of a resort area, resort area district, or resort  
24 community that already imposes a resort tax may submit to the qualified electors of the resort area, resort area
