4 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING THE DISTRIBUTION OF SURPLUS

14 PROVIDING FUNDING TO LOCAL GOVERNMENTS FOR THE MAINTENANCE OF COUNTY AND CITY
15 ROADS; PROVIDING FOR THE DISTRIBUTION OF FUNDS; PROVIDING STATUTORY APPROPRIATIONS;
16 REVISING CONTRIBUTIONS IN THE PUBLIC EMPLOYEES' RETIREMENT SYSTEM TO PROVIDE FOR AN
17 ACTUARIALLY DETERMINED CONTRIBUTION; CHANGING THE DEFAULT RETIREMENT PLAN TO THE
18 PUBLIC EMPLOYEES' DEFINED CONTRIBUTION PLAN; REVISING THE EMPLOYER CONTRIBUTION TO
19 THE DEFINED CONTRIBUTION PLAN OF THE PUBLIC EMPLOYEES' RETIREMENT SYSTEM; PROVIDING
20 DEFINITIONS; ESTABLISHING A CHILD TAX CREDIT FOR MONTANA RESIDENT TAXPAYERS;
21 PROVIDING A MAXIMUM REFUNDABLE CREDIT AMOUNT FOR A CHILD 5 YEARS OF AGE OR
22 YOUNGER; PROVIDING FOR A SUPPLEMENTAL FUND TRANSFER FOR THE INCOME TAX REBATE
23 THAT IS BASED ON INDIVIDUAL INCOME TAXES PAID; REVISING THE SUPPLEMENTAL PROPERTY
24 TAX REBATE; PROVIDING AN APPROPRIATION APPROPRIATIONS; PROVIDING FOR TRANSFERS;
25 PROVIDING FOR ALLOCATIONS TO COUNTIES; AMENDING SECTIONS 15-30-2303, 17-7-502, 19-2-303,
26 19-2-405, 19-2-409, 19-3-315, 19-3-316, 19-3-319, 19-3-1605, 19-3-2111, 19-3-2117, AND 19-21-214, MCA;
27 AMENDING SECTION 2, CHAPTER 44, LAWS OF 2023 AND SECTION 1, CHAPTER 47, LAWS OF 2023;

1 AND PROVIDING AN IMMEDIATE-EFFECTIVE DATE DATES, AN APPLICABILITY DATE, AND A
2 TERMINATION DATE DATES.”

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

5

6 NEW SECTION. Section 1. Individual income tax rebate. (1) A qualified taxpayer that is entitled to
7 an individual income tax rebate pursuant to [section 2 of House Bill No. 192] may increase the amount of the
8 filing status limits in [section 2(1)(b) of House Bill No. 192] by the bonus amounts provided in subsection (2). In
9 administering the income tax rebate, the department shall add the bonus to the filing status limits and update
10 any rebate forms to reflect the additional amount.

11 (2) (a) Subject to subsection (2)(c), the amount of the bonus for a single taxpayer, a head of
12 household, or a married taxpayer filing a separate return is the quotient of the appropriation in [section 3 39]
13 divided by 350,000.

14 (b) Subject to subsection (2)(c), the amount of the bonus for a married couple filing a joint return is
15 double the amount provided for in subsection (2)(a).

16 (c) The department shall round the quotients provided for in subsections (2)(a) and (2)(b)
17 downward to the nearest \$1.

18 (3) The bonus provided for in this section is administered as part of the individual income tax
19 rebate provided for in [House Bill No. 192]. Any income tax rebate received that is based on this section is
20 exempt from taxation under this chapter.

22 NEW SECTION. SECTION 2. MONTANA HOUSING INFRASTRUCTURE REVOLVING LOAN FUND ACCOUNT. (1)
23 THERE IS A MONTANA HOUSING INFRASTRUCTURE REVOLVING LOAN FUND ACCOUNT WITHIN THE STATE SPECIAL
24 REVENUE FUND TYPE ESTABLISHED IN 17-2-102 TO THE CREDIT OF THE BOARD OF INVESTMENTS. MONEY DEPOSITED IN
25 THE ACCOUNT ESTABLISHED IN THIS SECTION MUST BE INVESTED BY THE BOARD OF INVESTMENTS AS PROVIDED BY LAW.

26 (2) THE PRINCIPAL OF THE ACCOUNT MAY ONLY BE APPROPRIATED BY A VOTE OF TWO-THIRDS OF THE
27 MEMBERS OF EACH HOUSE OF THE LEGISLATURE.

28

1 NEW SECTION. SECTION 3. PURPOSE. THE PURPOSE OF THE LOANS MADE AND THE BONDS OR OTHER
2 SECURITIES ISSUED AND PURCHASED PURSUANT TO [SECTIONS 2 THROUGH 6] ARE:

3 (1) TO INCREASE HOME OWNERSHIP AND PROVIDE MORE LONG-TERM RENTAL OPPORTUNITY;

4 (2) TO INCREASE HOUSING SUPPLY AND OFFER DIVERSE HOUSING TYPES TO MEET THE NEEDS OF
5 POPULATION GROWTH; AND

6 (3) TO CREATE PARTNERSHIPS BETWEEN THE STATE, LOCAL GOVERNMENTS, PRIVATE SECTOR
7 DEVELOPERS, AND APPLICANTS FOR RESIDENTIAL DEVELOPMENT TO FINANCE NECESSARY INFRASTRUCTURE FOR
8 HOUSING.

9

10 NEW SECTION. SECTION 4. ELIGIBILITY. (1) FOR THE COSTS OF AN INFRASTRUCTURE PROJECT TO BE
11 ELIGIBLE TO BE PAID BY THE PROCEEDS OF A LOAN OR BONDS OR OTHER SECURITIES OF AN ELIGIBLE GOVERNMENT UNIT
12 AS DEFINED IN 17-5-1604, THE INFRASTRUCTURE PROJECT MUST PROVIDE FOR RESIDENTIAL DEVELOPMENT AT A
13 MINIMUM GROSS DENSITY OF 10 UNITS FOR EACH ACRE.

14 (2) LENDING OF AT LEAST \$7 MILLION OF AVAILABLE FUNDS MUST BE PRIORITIZED TO COUNTIES THAT HAVE
15 A POPULATION OF LESS THAN 15,000 INHABITANTS THAT ARE LOCATED WITHIN A 30-MILE RADIUS OF A FACILITY THAT, ON
16 AN ANNUAL AVERAGE, HOUSES AT LEAST 100 STATE INMATES OR BEHAVIORAL HEALTH PATIENTS, AND THE FACILITY IS
17 LOCATED IN A COUNTY THAT HAS A POPULATION OF THAT DOES NOT EXCEED 15,000 INHABITANTS.

18

19 NEW SECTION. SECTION 5. FINANCING BY THE BOARD OF INVESTMENTS -- DEED RESTRICTIONS. (1) THE
20 BOARD OF INVESTMENTS MAY MAKE LOANS FROM THE ACCOUNT ESTABLISHED IN [SECTION 2] TO AN ELIGIBLE
21 GOVERNMENT UNIT AS DEFINED IN 17-5-1604 OR AN APPLICANT FOR RESIDENTIAL DEVELOPMENT TO COVER THE COSTS
22 OF DEMOLITION OR EXPANDING OR EXTENDING WATER, WASTEWATER, STORM WATER, STREET, ROAD, CURB, GUTTER,
23 AND SIDEWALK INFRASTRUCTURE TO SERVE NEW OR REHABILITATED RESIDENTIAL DEVELOPMENT.

24 (2) THE BOARD OF INVESTMENTS MAY PURCHASE UP TO 50% OF A BOND OR OTHER SECURITY ISSUED IN
25 ACCORDANCE WITH STATE LAW BY AN ELIGIBLE GOVERNMENT UNIT AS DEFINED IN 17-5-1604 TO COVER ALL OR A
26 PORTION OF COSTS OF EXPANDING OR EXTENDING WATER, WASTEWATER, STORM WATER, STREET, ROAD, CURB,
27 GUTTER, AND SIDEWALK INFRASTRUCTURE TO SERVE NEW OR REHABILITATED RESIDENTIAL DEVELOPMENT AT AN
28 INTEREST RATE TO BE DETERMINED BY THE BOARD OF INVESTMENTS AS AN INVESTMENT OF THE ACCOUNT ESTABLISHED

1 IN [SECTION 2].

2 (3) THE BOARD OF INVESTMENTS SHALL:

3 (A) ESTABLISH THE TERMS AND CONDITIONS OF THE LOAN, INCLUDING THE INTEREST RATE OF THE LOAN,
4 WITH A TERM NOT TO EXCEED 20 YEARS;

5 (B) IF AN ELIGIBLE GOVERNMENT UNIT IS THE ENTITY SEEKING A LOAN OR ISSUING A BOND OR OTHER
6 SECURITY, REQUIRE THAT THE ELIGIBLE GOVERNMENT UNIT WAIVE ALL IMPACT FEES FOR THE DEVELOPER OR THE
7 AMOUNT OF IMPACT FEES UP TO THE AMOUNT OF THE LOAN OR BOND OR OTHER SECURITY, WHICHEVER AMOUNT IS
8 SMALLER;

9 (C) IF AN APPLICANT FOR RESIDENTIAL DEVELOPMENT IS THE ENTITY SEEKING A LOAN, REQUIRE THAT THE
10 APPLICANT PAY ALL IMPACT FEES DUE TO THE LOCAL GOVERNMENT OR THE AMOUNT OF IMPACT FEES UP TO THE AMOUNT
11 OF THE LOAN, WHICHEVER AMOUNT IS SMALLER; AND

12 (D) SET POLICY REQUIRING THAT HOUSING BUILT USING INFRASTRUCTURE FUNDED IN PART BY A SECURITY
13 PURSUANT TO THIS SECTION MUST CONTAIN A DEED RESTRICTION TO PRESERVE LONG-TERM AFFORDABILITY OF THE
14 HOUSING THAT RUNS WITH THE PROPERTY FOR THE TERM OF THE SECURITY.

15 (4) THE BOARD OF INVESTMENTS SHALL INCLUDE THE AMOUNTS LOANED AND THE STATUS OF ALL LOANS IN
16 THE REPORT REQUIRED IN 17-5-1650.

17
18 **NEW SECTION. SECTION 6. WORKFORCE HOUSING APPROPRIATIONS -- ELIGIBLE USES OF FUNDS. (1)**

19 THERE IS APPROPRIATED \$12 MILLION FROM THE GENERAL FUND TO THE BOARD OF INVESTMENTS FOR THE BIENNIUM
20 BEGINNING JULY 1, 2023. THE PURPOSE OF THE FUNDS IS TO ADVANCE THE CONSTRUCTION OF WORKFORCE HOUSING
21 OF EMPLOYEES WHO WORK AT FACILITIES THAT HOUSE STATE INMATES OR BEHAVIORAL HEALTH PATIENTS.

22 (2) FUNDS MUST BE DISTRIBUTED TO THOSE LIVING IN COUNTIES THAT HAVE A POPULATION OF LESS THAN
23 15,000 INHABITANTS THAT ARE LOCATED WITHIN A 30-MILE RADIUS OF A FACILITY THAT, ON AN ANNUAL AVERAGE,
24 HOUSES AT LEAST 100 STATE INMATES OR BEHAVIORAL HEALTH PATIENTS, AND THE FACILITY IS LOCATED IN A COUNTY
25 THAT HAS A POPULATION THAT DOES NOT EXCEED 15,000 INHABITANTS. THE DISTRIBUTION MUST BE MADE PRO RATA
26 BASED ON THE ANNUAL AVERAGE FACILITY POPULATION FOR THE FISCAL YEAR BEGINNING JULY 1, 2021, AND THE
27 NUMBER OF WORKERS RESIDING IN EACH ELIGIBLE COUNTY.

28 (3) ELIGIBLE USES OF THE FUNDS INCLUDE:

- 1 (A) BUYING DOWN CONSTRUCTION INTEREST ON EMPLOYEE HOUSING;
- 2 (B) PROVIDING LOANS FOR UP TO 50% OF THE PROJECTED PROJECT COSTS OF AN ELIGIBLE
- 3 INFRASTRUCTURE PROJECT PURSUANT TO [SECTION 4];
- 4 (C) ACQUIRING THROUGH CONSTRUCTION OR PURCHASE HOUSING FOR EMPLOYEES WITH THE INTENTION
- 5 OF THE HOUSING TO BE PRIVATELY OWNED WITHIN 10 YEARS OF PURCHASE OR CONSTRUCTION;
- 6 (D) PROVIDING FUNDS TO DISCOUNT HOUSING COSTS TO EMPLOYEES WHO WORK IN FACILITIES THAT
- 7 HOUSE, ON AN ANNUAL AVERAGE, AT LEAST 100 STATE INMATES OR BEHAVIORAL HEALTH PATIENTS, AND THE FACILITY IS
- 8 LOCATED IN A COUNTY THAT HAS A POPULATION THAT DOES NOT EXCEED 15,000 INHABITANTS; OR
- 9 (E) ACQUIRING THROUGH CONSTRUCTION OR PURCHASE HOUSING FOR EMPLOYEES OF THOSE FACILITIES
- 10 WITH THE INTENTION OF THE HOUSING TO BE PRIVATELY OWNED WITHIN 10 YEARS OF PURCHASE OR CONSTRUCTION
- 11 UNLESS PRIVATE OWNERSHIP IS CONSIDERED A SECURITY RISK BY THE DEPARTMENT OF PUBLIC HEALTH AND HUMAN
- 12 SERVICES OR THE DEPARTMENT OF CORRECTIONS.

13

14 NEW SECTION. SECTION 7. PURPOSE. THE PURPOSE OF [SECTIONS 7 THROUGH 18] IS TO USE A PORTION

15 OF THE STATE'S GENERAL FUND SURPLUS TO FUND THE MAINTENANCE AND REPAIR OF LOCAL GOVERNMENT

16 INFRASTRUCTURE FACILITIES ON A PARTNERSHIP BASIS WITH LOCAL GOVERNMENT SUPPLYING A CASH MATCH.

17

18 NEW SECTION. SECTION 8. APPROPRIATION. THERE IS APPROPRIATED \$227 MILLION FROM THE GENERAL

19 FUND TO THE DEPARTMENT OF COMMERCE FOR THE BIENNIUM BEGINNING JULY 1, 2023, TO DISTRIBUTE FUNDS AS

20 ALLOCATED IN [SECTION 17] TO GRANT RECIPIENTS AWARDED IN COMPLIANCE WITH [SECTIONS 7 THROUGH 18] FOR

21 ELIGIBLE PROJECTS AS RECOMMENDED BY EACH COUNTY COMMISSION.

22

23 NEW SECTION. SECTION 9. CALCULATION FOR ALLOCATION OF FUNDS. (1) EXCEPT AS PROVIDED IN

24 SUBSECTION (2), EACH COUNTY WILL RECEIVE AN ALLOCATION OF FUNDS BASED ON THE FOLLOWING:

- 25 (A) THE COUNTY'S 2020 POPULATION;
- 26 (B) THE ABILITY OF THE COUNTY'S LOCAL POPULATION TO PAY FOR SERVICES AS MEASURED BY PER CAPITA
- 27 INCOME; AND
- 28 (C) THE COUNTY'S ABILITY TO RAISE TAX REVENUE LOCALLY AS MEASURED BY PER CAPITA TAXABLE

1 VALUATION.

2 (2) IF A COUNTY'S ALLOCATION AS CALCULATED PURSUANT TO THE CRITERIA IN SUBSECTION (1) IS LESS
3 THAN \$300,000, THE COUNTY SHALL RECEIVE \$300,000.

4
5 NEW SECTION. SECTION 10. ELIGIBLE USE OF FUNDS -- ELIGIBLE ENTITIES. (1) EXCEPT AS PROVIDED IN
6 SUBSECTION (2), FUNDS ALLOCATED IN [SECTION 17] MAY BE USED ONLY BY ELIGIBLE ENTITIES TO MAINTAIN OR REPAIR
7 EXISTING LOCAL GOVERNMENT INFRASTRUCTURE, INCLUDING POTABLE DRINKING WATER SYSTEMS, SEWER
8 WASTEWATER TREATMENT SYSTEMS, FIRE SUPPRESSION SYSTEMS IF INDEPENDENT OF THE POTABLE DRINKING WATER
9 SYSTEMS, STREETS, ROADS, BRIDGES, LANDFILLS, STREET LIGHTS, AIRPORTS, AND PUBLIC GROUNDS AND BUILDINGS.

10 (2) FUNDS ALLOCATED IN [SECTION 17] MAY BE USED TO EXPAND EXISTING WATER AND WASTEWATER
11 TREATMENT PLANTS THAT ARE BEING OPERATED AT 90% OF DESIGN CAPACITY OR GREATER.

12 (3) ENTITIES ELIGIBLE FOR GRANTS UNDER [SECTIONS 7 THROUGH 18] INCLUDE INCORPORATED CITIES
13 AND TOWNS, COUNTIES, SCHOOL DISTRICTS, AND SPECIAL DISTRICTS, INCLUDING WATER AND SEWER DISTRICTS.

14
15 NEW SECTION. SECTION 11. GRANT PROCESS -- COMMISSION AND DEPARTMENT OF COMMERCE REVIEW --
16 PRIORITY. (1) THE COUNTY COMMISSION SHALL SOLICIT AND ACCEPT APPLICATIONS FROM ELIGIBLE ENTITIES WITHIN THE
17 COUNTY ON OR BEFORE DECEMBER 31, 2023.

18 (2) WHEN ALL THE APPLICATIONS HAVE BEEN RECEIVED, THE COUNTY COMMISSION SHALL HOLD A PUBLIC
19 HEARING AND, BASED ON THE INFORMATION CONTAINED WITHIN THE APPLICATION AND THE INFORMATION RECEIVED AT
20 THE PUBLIC HEARING, PREPARE A RECOMMENDATION FOR FUNDING IN PRIORITY ORDER AND TRANSMIT THE
21 RECOMMENDATION TO THE DEPARTMENT OF COMMERCE.

22 (3) THE DEPARTMENT OF COMMERCE SHALL REVIEW THE RECOMMENDATIONS OF THE COUNTY
23 COMMISSION AND THE CONTENT OF THE RECOMMENDED APPLICATION AND DETERMINE WHETHER THE APPLICATION
24 COMPLIES WITH [SECTIONS 7 THROUGH 18]. IF THE APPLICATION DOES NOT COMPLY, THE DEPARTMENT SHALL ISSUE
25 NOTICE TO THE APPLICABLE COUNTY COMMISSION.

26 (4) THE DEPARTMENT OF COMMERCE MAY NOT SUBSTITUTE ITS JUDGMENT FOR THAT OF THE COUNTY
27 COMMISSION AND CANNOT REVISE THE RECOMMENDED PRIORITY LIST.

28 (5) PRIORITY IS GIVEN TO PROJECTS THAT MAINTAIN OR REPAIR PUBLICLY OWNED DRINKING WATER

1 SYSTEMS, PUBLICLY OWNED WASTEWATER TREATMENT SYSTEMS, AND MUNICIPAL FIRE SUPPRESSION SYSTEMS THAT
2 ARE INDEPENDENT OF A WATER SYSTEM.

3 (6) A GRANT RECIPIENT'S ENTITLEMENT TO RECEIVE FUNDS IS DEPENDENT ON THE GRANT RECIPIENT'S
4 COMPLIANCE WITH THE CONDITIONS DESCRIBED IN [SECTION 18].

5 (7) THE DEPARTMENT OF COMMERCE SHALL ADMINISTER THE GRANT PROGRAM AND DISBURSE FUNDS
6 DIRECTLY TO THE APPLICANTS PURSUANT TO THE PROVISIONS OF [SECTION 18].

7 (8) THE DEPARTMENT OF COMMERCE IS AUTHORIZED 2 FTE ON A TEMPORARY BASIS THROUGH JUNE 30,
8 2025. IF THE DEPARTMENT'S WORKLOAD FOR THE ADMINISTRATION OF [SECTIONS 7 THROUGH 18] REQUIRES
9 ADDITIONAL STAFF, THE OFFICE OF BUDGET AND PROGRAM PLANNING MAY AUTHORIZE AN ADDITIONAL 2 FTE TO
10 TERMINATE JUNE 30, 2025. IF PROGRAM ADMINISTRATION CONTINUES INTO THE 2027 BIENNIUM, THE DEPARTMENT
11 SHALL SUBMIT A BUDGET MODIFICATION REQUEST WITH ITS 2027 BIENNIUM BUDGET REQUEST TO CONTINUE THE FTE ON
12 A TEMPORARY BASIS.

13
14 NEW SECTION. SECTION 12. GRANT APPLICATION -- CONTENTS -- MATCHING FUNDS REQUIREMENT. EACH
15 APPLICATION FOR GRANT FUNDS MUST CONTAIN THE FOLLOWING INFORMATION:

16 (1) THE NAME OF THE APPLICANT ENTITY AND ITS ADDRESS, TELEPHONE NUMBER, E-MAIL ADDRESS, AND
17 LEGAL STATUS, SUCH AS WHETHER IT IS AN INCORPORATED CITY OR WHAT TYPE OF SPECIAL DISTRICT IT IS;

18 (2) THE NAME, ADDRESS, TELEPHONE NUMBER, E-MAIL ADDRESS, AND TITLE OF THE INDIVIDUAL PERSON
19 WHO WILL BE DIRECTLY RESPONSIBLE FOR THE MANAGEMENT OF THE PROJECT OR PROJECTS TO BE FUNDED BY THE
20 APPLICATION, SUCH AS A PUBLIC WORKS DIRECTOR OR A CONSULTING ENGINEER, AND A COPY OF THE INDIVIDUAL'S
21 RESUME ATTESTING TO THE INDIVIDUAL'S QUALIFICATIONS AND ABILITY TO MANAGE THE PROJECT;

22 (3) A NARRATIVE DESCRIPTION OF THE PROSPECTIVE PROJECT, INCLUDING A DESCRIPTION OF THE
23 PROBLEMS TO BE ADDRESSED AND THE NEED TO UNDERTAKE THE REPAIRS. THE APPLICANT SHALL EXPLAIN WHY THE
24 PROPOSED PROJECT IS APPROPRIATE, COST-EFFECTIVE, AND A LONG-TERM SOLUTION TO THE PROBLEM. THE APPLICANT
25 SHALL ALSO SUBMIT A LIST OF TASKS TO BE UNDERTAKEN TO ADDRESS THE PROBLEM. A MAP OR DIGITAL PHOTO
26 SHOWING THE PROJECT IS ALSO REQUIRED. PHOTOGRAPHS DOCUMENTING THE NATURE OF THE PROBLEMS ARE
27 ADVISABLE BUT NOT REQUIRED.

28 (4) A PROJECT COST ESTIMATE SHOWING THE TOTAL COST OF THE PROJECT, PREPARED BY A LICENSED

1 PROFESSIONAL ENGINEER OR QUALIFIED CONTRACTOR. THE COST ESTIMATED MUST BE ITEMIZED BY THE LIST OF TASK
2 ELEMENTS AS REQUIRED IN SUBSECTION (3).

3 (5) A TIME SCHEDULE SHOWING EACH STEP IN THE REPAIR PROCESS STARTING WITH THE PREPARATION OF
4 THE BID DOCUMENTS THROUGH COMPLETION OF THE WORK. SPECIFIC CALENDAR DATES ARE RECOMMENDED.

27 (5) "Actuarial liabilities" means the excess of the present value of all benefits payable under a defined
28 benefit retirement plan over the present value of future normal costs in that retirement plan.

1 (6) "Actuary" means the actuary retained by the board in accordance with 19-2-405.

2 (7) "Additional contributions" means contributions made by a member of a defined benefit plan to
3 purchase various types of optional service credit as allowed by the applicable retirement plan.

4 (8) "Annuity" means:

5 (a) in the case of a defined benefit plan, equal and fixed payments for life that are the actuarial
6 equivalent of a lump-sum payment under a retirement plan and as such are not benefits paid by a retirement
7 plan and are not subject to periodic or one-time increases; or

8 (b) in the case of the defined contribution plan, a payment of a fixed sum of money at regular
9 intervals.

10 (9) "Banked holiday time" means the hours reported for work performed on a holiday that the
11 employee may use for equivalent time off or that may be paid to the employee as specified by the employer's
12 policy.

13 (10) "Benefit" means:

14 (a) the service retirement benefit, early retirement benefit, or disability retirement or survivorship
15 benefit payment provided by a defined benefit retirement plan; or

16 (b) a payment or distribution under the defined contribution retirement plan, including a disability
17 payment under 19-3-2141, for the exclusive benefit of a plan member or the member's beneficiary or an annuity
18 purchased under 19-3-2124.

19 (11) "Board" means the public employees' retirement board provided for in 2-15-1009.

20 (12) "Contingent annuitant" means:

21 (a) under option 2 or 3 provided for in 19-3-1501, one natural person designated to receive a
22 continuing monthly benefit after the death of a retired member; or

23 (b) under option 4 provided for in 19-3-1501, a natural person, charitable organization, estate, or trust
24 that may receive a continuing monthly benefit after the death of a retired member.

25 (13) "Covered employment" means employment in a covered position.

26 (14) "Covered position" means a position in which the employee must be a member of the retirement
27 system except as otherwise provided by law.

28 (15) "Defined benefit retirement plan" or "defined benefit plan" means a plan within the retirement

1 systems provided for pursuant to 19-2-302 that is not the defined contribution retirement plan.

2 (16) "Defined contribution retirement plan" or "defined contribution plan" means the plan within the
3 public employees' retirement system established in 19-3-103 that is provided for in chapter 3, part 21, of this
4 title and that is not a defined benefit plan.

5 (17) "Department" means the department of administration.

6 (18) "Designated beneficiary" means the person, charitable organization, estate, or trust for the benefit
7 of a natural person designated by a member or payment recipient to receive any survivorship benefits, lump-
8 sum payments, or benefit from a retirement account upon the death of the member or payment recipient,
9 including annuities derived from the benefits or payments.

10 (19) "Direct rollover" means a payment by the retirement plan to the eligible retirement plan specified
11 by the distributee or a payment from an eligible retirement plan to the retirement plan specified by the
12 distributee.

13 (20) "Disability" or "disabled" means a total inability of the member to perform the member's duties by
14 reason of physical or mental incapacity. The disability must be incurred while the member is an active member
15 and must be one of permanent duration or of extended and uncertain duration, as determined by the board on
16 the basis of competent medical opinion.

17 (21) "Distributee" means:

18 (a) a member;

- 23 (26) "Employer" means a governmental agency participating in a retirement system enumerated in 19-
