11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

13 **Section 1.** Section 16-12-223, MCA, is amended to read:

14 **"16-12-223. Licensing of cultivators.** (1) (a) The department shall license cultivators according to a
15 tiered canopy system. Except as provided in subsection (6), all cultivation that is licensed under this chapter
16 may only occur at an indoor cultivation facility.

17 (b) Except as provided in subsection (6), the system shall must include, at a minimum, the
18 following license types:

19 (i) A micro tier canopy license allows for a canopy of up to 250 square feet at one indoor
20 cultivation facility.

21 (ii) A tier 1 canopy license allows for a canopy of up to 1,000 square feet at one indoor cultivation
22 facility.

23 (iii) A tier 2 canopy license allows for a canopy of up to 2,500 square feet at up to two indoor
24 cultivation facilities.

25 (iv) A tier 3 canopy license allows for a canopy of up to 5,000 square feet at up to three indoor
26 cultivation facilities.

27 (v) A tier 4 canopy license allows for a canopy of up to 7,500 square feet at up to four indoor

1 ~~(3)~~(4) A combined-use marijuana licensee shall operate its cultivation and dispensary facilities on
2 land that is located:

3 (a) within 150 air-miles of the exterior boundary of the associated tribal reservation or, for the Little
4 Shell Chippewa tribe only, within 150 air-miles of the tribal service area; and

5 (b) in a county that has satisfied the local government approval provisions in 16-12-301 if the
6 majority of voters in the county voted against approval of Initiative Measure No. 190 in the November 3, 2020,
7 general election.

8 ~~(4)~~(5) An applicant under this section must satisfy all licensing requirements under this chapter and is
9 subject to all fees and taxes associated with the cultivation and sale of marijuana or marijuana products
10 provided for in this chapter.

11 ~~(5)~~(6) A license granted under this section must be operated in compliance with all requirements
12 imposed under this chapter.

13 ~~(6)~~(7) After a tribe or a majority-owned business of that tribe is licensed under this section, that tribe
14 or another majority-owned business of that tribe may not obtain another combined-use license until the prior
15 license is relinquished, lapses, or is revoked by the department."

17 **Section 3.** Section 16-12-226, MCA, is amended to read:

18 **"16-12-226. Marijuana worker permit -- requirements -- temporary worker permit -- certification**
19 **and safety courses -- application -- course requirements -- rulemaking.** (1) A marijuana worker permit is
20 required for an employee who performs work for or on behalf of a marijuana business if the individual
21 participates in any aspect of the marijuana business.

22 (2) (a) Except as provided in subsection (2)(b), a marijuana business may not allow an employee
23 to perform any work at the licensed premises until it has verified that the employee has obtained a valid
24 marijuana worker permit issued in accordance with this chapter.

25 (b) ~~(i) An employee of a former medical marijuana licensee in good standing with the department~~
26 ~~as of January 1, 2022, shall obtain a marijuana worker permit within 90 days of January 1, 2022. An employee~~
27 ~~may perform work for a licensed dispensary, licensed cultivator, or licensed testing lab for up to 60 days from~~

3 (ii) An employee without a marijuana worker permit under subsection (2)(b) shall always carry a
4 yellow card with "temporary cannabis worker" printed on both sides of the card in place of a marijuana worker
5 permit while performing work on behalf of a marijuana business.

19 department-approved safety training for workers employed in manufacturing and cultivation facilities; and

20 (d) a fee established by the department.

21 (4) An applicant is responsible for verifying the training in subsection (3)(c) is approved by the
22 department.

23 ~~(4)(5)~~ (a) Except as provided in subsection ~~(4)(b)~~ ~~(5)(b)~~, an application that does not contain the
24 elements set forth in subsection (3) is incomplete.

25 (b) The department may review an application prior to receiving the fee but may not issue a permit
26 until the fee is received.

- 22 (9) (a) A course provider applying to the department must submit a completed application and fee
- 23 no later than November 1 of the year preceding the year for which training is to be approved for use. The

- 4 (b) The department may withdraw its approval of any course or provider if it determines the course
- 5 material or provider is no longer in compliance with requirements as provided by rule. If the department
- 6 withdraws its approval of a course, the department shall give the provider written notification of the withdrawal,
- 7 specifying the reasons for the decision. The provider may appeal the decision by the department as provided in
- 8 16-12-109(7).
- 9 (10) A course provider approved to provide worker permit certification and manufacturing safety
- 10 courses shall provide completion certificates to licensees on successful completion of courses. Course
- 11 completion certificates must contain the following:
- 12 (a) the course provider name;
- 13 (b) the course title;
- 14 (c) the course number;
- 15 (d) the course credit hours; and
- 16 (e) the name of person completing the course.
- 17 (11) A course provider shall keep uniform records for a period of 3 years of attendance of licensees,
- 18 and records must be available for inspection annually by the department. The records must include:
- 19 (a) the course title;
- 20 (b) the course topic;
- 21 (c) the course number;
- 22 (d) the course credit hours;
- 23 (e) the date of the course; and
- 24 (f) the attendance roster.
- 25 (12) Course providers are encouraged to provide online certification courses and must be approved
- 26 if the department determines the course meets:
- 27 (a) content, accessibility, and security requirements established by rule;

4 (13) The department shall provide a directory of course providers and approved courses on the
5 department website, including links to approved online courses. The online directory of course providers and
6 courses must be available in a paper form at the department and must be provided to the public at no cost on
7 request.
8 (14) The department may not provide or host any training, education, or certification course required
9 for a marijuana worker permit."

11 **NEW SECTION. Section 4. Appropriation.** There is appropriated \$1,000 from the state special
12 revenue fund under 16-12-111 to the department of revenue for the biennium ending June 30, 2023, for the
13 purposes of notification to licensees of the provisions of [this act].

15 **NEW SECTION. Section 5. Notification to tribal governments.** The secretary of state shall send a
16 copy of [this act] to each federally recognized tribal government in Montana.

18 **NEW SECTION. Section 6. Effective date.** [This act] is effective on passage and approval.
