10 PROVIDING AN EFFECTIVE DATE."

12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

14 NEW SECTION. **Section 1. Legislative findings -- purpose.** (1) The legislature finds that:

15 (a) the utilization of education and workforce data holds great promise for developing the full  
16 educational potential of Montanans and in maximizing the effectiveness of state investments in education and  
17 workforce systems; and

18 (b) a systems approach with shared governance between relevant agencies is the best way to  
19 utilize education and workforce data while ensuring that the data is only used for appropriate purposes and in  
20 compliance with the Family Educational Rights and Privacy Act of 1974, 20 U.S.C. 1232g, as amended, and its  
21 implementing regulations at 34 CFR, part 99, and all other relevant federal and state privacy laws, and any  
22 other privacy measures required by the education and workforce data governing board.

23 (2) The purpose of [sections 1 through 3] is to create a strong and transparent education and  
24 workforce data governing board with authority over the linkage of education and workforce data gathered and  
25 maintained by state agencies to ensure that the data is used to benefit the people of the state in a secure  
26 manner and only for appropriate purposes.

1            NEW SECTION. **Section 2. Definitions.** As used in this part, the following definitions apply:

2            (1)        "Board" means the education and workforce data governing board established in [section 3].

3            (2)        "Contributing agencies" means the following state agencies that gather and maintain education  
4 and workforce data, serve on the board, and are subject to the policies developed by the board pursuant to  
5 [section 3]:

6            (a)        the office of public instruction;

7            (b)        the office of the commissioner of higher education; and

8            (c)        the department of labor and industry.

9            (3)        "Education data" means data collected or reported at the student level that is included in a  
10 student's educational record, including but not limited to:

11           (a)        career and college readiness indicators;

12           (b)        state and national assessment data;

13           (c)        course-taking and completion data in elementary, secondary, and postsecondary education;

14           (d)        elementary, secondary, and postsecondary grade point average data;

15           (e)        4-year, 5-year, and 6-year high school graduation rate data;

16           (f)        first to second year retainment data;

17           (g)        certificate, diploma, and degree attainment data;

18           (h)        college enrollment course-taking, credit, and contact hour accumulation data;

19           (i)        attendance and transferability data;

20           (j)        special education data;

21           (k)        remediation data; and

22           (l)        demographics data.

23           (4)        "Workforce data" means data related to an individual's workforce outcomes, including but not  
24 limited to, an individual's:

25           (a)        labor and workforce training program participation and completion information data;

26           (b)        wage information;

27           (c)        unemployment claim eligibility information;

4 **NEW SECTION. Section 3. Education and workforce data governing board -- membership --**

5 **duties.** (1) There is an education and workforce data governing board. The board is administratively attached  
6 to the department of administration as provided in 2-15-121.

7 (2) The board is comprised of five voting members:

8 (a) the director of the department of administration or the director's designee;

9 (b) the superintendent of public instruction or the superintendent's designee;

10 (c) the commissioner of higher education or the commissioner's designee;

11 (d) the commissioner of labor and industry or the commissioner's designee; and

12 (e) the presiding officer of the board of public education or the presiding officer's designee.

13 (3) The nonvoting members of the board ~~include the following~~ ARE:

14 (a) the state chief information officer or the officer's designee;

15 (b) the legislative fiscal analyst or the analyst's designee;

16 (c) the legislative auditor or the auditor's designee; and

17 (d) the director of legislative services or the director's designee.

18 (4) The presiding officer of the board is the director of the department of administration or the  
19 director's designee.

20 (5) The board shall meet at least quarterly. The presiding officer may call special meetings  
21 whenever necessary. The presiding officer shall notify each member of the board of any special meeting before  
22 the fixed time for the special meeting. A majority of the board may petition the presiding officer to call a special  
23 meeting.

24 (6) Meetings of the board must be open to the public. Archived videos of the board's meetings  
25 must be made available to the public through the website.

26 (7) The board shall:

12 ESTABLISH, MAINTAIN, AND CONTINUALLY IMPROVE A statewide K-12 data system ~~must that,~~ at a minimum:

13 (a) ~~include~~ includes data entry and intuitive reporting options that school districts can use to make  
14 timely decisions that improve instruction and impact student performance while creating a collaborative  
15 environment for parents, teachers, and students to work together in improving student performance. Options  
16 that the office of public instruction shall incorporate and make available for each school district must include  
17 data linkages to provide for automated conversion of data from systems already in use by school districts or by  
18 the office of public instruction that allow districts to collect, manage, and present local classroom assessment  
19 scores, grades, attendance, and other data to assist in instructional intervention alongside the existing school  
20 accountability and statewide student achievement results. The office of public instruction shall ensure that the  
21 design of the system is enhanced to prioritize collaborative support of each student's needs by classroom  
22 educators, administrators, and parents.

23 (b) eliminates redundant data collections and siloed data systems and facilitates data sharing

9 working agreement the district has with any organized labor organization and the district's costs, if any,  
10 associated with employee union representation, collective bargaining, and union grievance procedures and  
11 litigation resulting from union employee grievances.

1           (7) In accordance with [sections 1 through 3] and except as otherwise provided and explicitly  
2 directed in state law, the superintendent of public instruction may not share or restrict the sharing of student  
3 educational records beyond what is allowed or restricted under the Family Educational Rights and Privacy Act  
4 of 1974, 20 U.S.C. 1232g, as amended, and its implementing regulations at 34 CFR, part 99."

5  
6           **NEW SECTION. Section 5. Appropriation.** (1) There is appropriated \$100,000 from the general fund  
7 to the department of administration for each year of the biennium beginning July 1, 2023, for the purposes of  
8 [sections 1 through 3].

9           (2) The legislature intends that the appropriation in this section be considered part of the ongoing  
10 base for the next legislative session.

11  
12           **NEW SECTION. Section 6. Transition.** Data sharing agreements between the office of public  
13 instruction, the department of labor and industry, and the commissioner of higher education made under the  
14 authority of 20-7-104(9) prior to [the effective date of this act] remain in effect until the earlier of the expiration  
15 date of the agreement or the adoption by the education and workforce data governing board of policies  
16 governing the linkage and sharing of education and workforce data relevant to the agreement. The legislature  
17 intends that the policies of the education and workforce data governing board replace the need for ad hoc data  
18 sharing agreements to the greatest extent possible.

19  
20           **NEW SECTION. Section 7. Codification instruction.** [Sections 1 through 3] are intended to be  
21 codified as an integral part of Title 20, chapter 7, part 1, and the provisions of Title 20, chapter 7, part 1, apply  
22 to [sections 1 through 3].

23  
24           **COORDINATION SECTION. Section 8. Coordination instruction.** If both Senate Bill No. 480 and  
25 [this act] are passed and approved and both contain a section amending 20-7-104, then Senate Bill No. 480 is  
26 void.
