1 (I) AMEND AN URBAN RENEWAL PLAN OR COMPREHENSIVE DEVELOPMENT PLAN TO ADOPT A TAX

2 INCREMENT PROVISION PURSUANT TO 7-15-4282;

3 (II) EXTEND A TAX INCREMENT PROVISION PURSUANT TO 7-15-4292;

4 (III) ISSUE BONDS TO FINANCE THE UNDERTAKING OF ANY URBAN RENEWAL PROJECT OR TARGETED

5 ECONOMIC DEVELOPMENT DISTRICT PROJECT PURSUANT TO 7-15-4301; OR

6 (IV) USE TAX INCREMENT TO PURCHASE LAND.

7 (B) THE FORM OF THE PETITION MUST BE APPROVED BY THE COUNTY ELECTION ADMINISTRATOR. A

8 PETITION SIGNED BY AT LEAST 15% OF THE QUALIFIED ELECTORS OF THE URBAN RENEWAL AREA OR TARGETED

9 ECONOMIC DEVELOPMENT DISTRICT IS SUFFICIENT TO REQUIRE AN ELECTION.

10 (2) IF AN APPROVED PETITION CONTAINING SUFFICIENT SIGNATURES IS FILED WITHIN 60 DAYS OF THE

11 PUBLIC HEARING ON THE ITEMS PROVIDED FOR IN SUBSECTION (1)(A), A PETITION REQUESTING AN ELECTION ON

12 WHETHER TO PROCEED DELAYS THE EFFECTIVE DATE UNTIL THE QUESTION IS RATIFIED BY THE ELECTORS.

13 (3) A PETITION OR RESOLUTION FOR AN ELECTION MUST:

14 (A) EMBRACE ONLY A SINGLE COMPREHENSIVE SUBJECT; AND

15 (B) BE IN THE FORM PRESCRIBED IN TITLE 13, CHAPTER 27.

16 (4) AN ELECTION HELD PURSUANT TO THIS SECTION MUST BE CONDUCTED IN CONJUNCTION WITH THE

17 NEXT LOCAL GOVERNMENT ELECTION HELD IN ACCORDANCE WITH TITLE 13, CHAPTER 1, PART 4, EXCEPT THAT IF THE

18 PETITION ASKS FOR A SPECIAL ELECTION, SPECIFIES AN ELECTION DATE THAT COMPLIES WITH 13-1-405, AND IS SIGNED

19 BY AT LEAST 25% OF THE QUALIFIED ELECTORS, A SPECIAL ELECTION MUST BE HELD ON THE DATE SPECIFIED IN THE

20 PETITION.

21 (5) IF A MAJORITY OF THOSE VOTING ON THE QUESTION APPROVE THE PROPOSAL, IT BECOMES EFFECTIVE

22 WHEN THE ELECTION RESULTS ARE OFFICIALLY DECLARED, UNLESS OTHERWISE STATED IN THE PROPOSAL.

25 **"7-15-4206. Definitions.** The following terms, wherever used or referred to in part 43 or this part,

26 have the following meanings unless a different meaning is clearly indicated by the context:

27 (1) "Agency" or "urban renewal agency" means a public agency created by 7-15-4232.

28 (2) "Blighted area" means an area that is conducive to ill health, transmission of disease, infant

1 mortality, juvenile delinquency, and crime, that substantially impairs or arrests the sound growth of the locality
 2 OR IS DETRIMENTAL TO OR CONSTITUTES A MENACE TO PUBLIC HEALTH, SAFETY, OR WELFARE. ~~city or its environs, that~~
 3 ~~retards the provision of housing accommodations, or that constitutes an economic or social liability or is~~
 4 ~~detrimental or constitutes a menace to the public health, safety, welfare, and morals in its present condition and~~
 5 ~~use, by reason of:~~

6 (a) ~~the substantial physical dilapidation, deterioration, age obsolescence, or defective construction,~~
 7 ~~material, and arrangement of buildings or improvements, whether residential or nonresidential;~~

8 (b) ~~inadequate provision for ventilation, light, proper sanitary facilities, or open spaces as determined~~

27 (5) "Elected" means chosen by vote or acclamation or appointed to a vacancy in an otherwise
 28 elected position.

1 (6) "Federal government" means the United States of America or any agency or instrumentality,
2 corporate or otherwise, of the United States of America.

3 (7) "Local governing body" means the elected members of a council or other elected members of a
4 legislative body charged with governing a municipality or consolidated city-county.

5 (8) "Mayor" means the chief executive of a city or town.

6 (9) "Municipality" means any incorporated city or town in the state.

7 (10) "Neighborhood development program" means the yearly activities or undertakings of a
8 municipality in a blighted area of an urban renewal area ~~or areas~~ if the municipality elects to undertake activities
9 on an annual increment basis.

10 (11) "Obligee" means any bondholder or agent or trustee for any bondholder or lessor conveying to
11 the municipality property used in connection with an urban renewal project or any assignee or assignees of the
12 lessor's interest or any part of the interest and the federal government when it is a party to any contract with the
13 municipality.

14 (12) "Person" means any individual, firm, partnership, corporation, company, association, joint-stock
15 association, or school district and includes any trustee, receiver, assignee, or other person acting in a similar
16 representative capacity.

17 (13) "Public body" means the state or any municipality, township, board, commission, district, or
18 other subdivision or public body of the state.

19 (14) "Public officer" means any officer who is in charge of any department or branch of the
20 government of the municipality relating to health, fire, building regulations, or other activities concerning
21 dwellings in the municipality.

22 (15) "Public use" means:

23 (a) a public use enumerated in 70-30-102; or

24 (b) a project financed by the method provided for in 7-15-4288.

25 (16) "Real property" means all lands, including improvements and fixtures on the land, all property
26 of any nature appurtenant to the land or used in connection with the land, and every estate, interest, right, and
27 use, legal or equitable, in the land, including terms for years and liens by way of judgment, mortgage, or
28 otherwise.

1 (17) "Redevelopment" may include:

2 (a) acquisition of a blighted area or portion of the area;

3 (b) demolition and removal of buildings and improvements in a blighted area;

4 (c) installation, construction, or reconstruction of streets, utilities, parks, playgrounds, and other
5 improvements necessary for carrying out in the blighted area the urban renewal provisions of this part in
6 accordance with the urban renewal plan; and

7 (d) making the land available in a blighted area for development or redevelopment by private
8 enterprise or public agencies, including sale, initial leasing, or retention by the municipality itself, at its fair value
9 for uses in accordance with the urban renewal plan. If the property is condemned pursuant to Title 70, chapter
10 30, the private enterprise or public agencies may not develop the condemned area in a way that is not for a
11 public use.

12 (18) (a) "Rehabilitation" ~~may include~~ means the restoration and renewal of a blighted area or portion
13 of the area in accordance with an urban renewal plan by:

14 (i) carrying out plans for a program of voluntary or compulsory repair and rehabilitation of
15 buildings or other improvements;

16 (ii) acquisition of real property and demolition or removal of buildings and improvements on the
17 property when necessary to eliminate unhealthful, unsanitary, or unsafe conditions, to lessen density, to reduce
18 traffic hazards, to eliminate obsolete or other uses detrimental to the public welfare, to otherwise remove or
19 prevent the spread of blight or deterioration, or to provide land for needed public facilities;

20 (iii) installation, construction, or reconstruction of streets, utilities, parks, playgrounds, and other
21 improvements necessary for carrying out in the area the urban renewal provisions of this part; and

22 (iv) subject to 7-15-4259(4), the disposition of any property acquired in the urban renewal area,
23 including sale, initial leasing, or retention by the municipality itself, at its fair value for uses in accordance with
24 the urban renewal plan.

25 (b) Rehabilitation may not include the development of the condemned area in a way that is not for
26 a public use if the property is condemned pursuant to Title 70, chapter 30.

27 (19) "Urban renewal area" means a blighted area that the local governing body designates as
28 appropriate for an urban renewal project or projects.

1 (20) "Urban renewal plan" means a plan for one or more urban renewal areas or for an urban
2 renewal project. The plan:

3 (a) must conform to the growth policy if one has been adopted pursuant to Title 76, chapter 1; and

4 (b) must be sufficiently complete to indicate, on a yearly basis or otherwise:

5 (i) any land acquisition, demolition, and removal of structures; redevelopment; improvements; and
6 rehabilitation that is proposed to be carried out in the urban renewal area;

7 (ii) zoning and planning changes, if any, including changes to the growth policy if one has been
8 adopted pursuant to Title 76, chapter 1;

9 (iii) land uses, maximum densities, building requirements; and

10 (iv) the plan's relationship to definite local objectives respecting appropriate land uses, improved
11 traffic, public transportation, public utilities, recreational and community facilities, and other public
12 improvements.

13 (21) (a) "Urban renewal project" may include undertakings or activities of a municipality in an urban
14 renewal area for the elimination ~~and for the prevention of the development or spread of~~ blight and may involve
15 redevelopment in an urban renewal area, rehabilitation ~~or conservation~~ in an urban renewal area, or any
16 combination or part of redevelopment, or rehabilitation, ~~or conservation~~ in accordance with an urban renewal
17 plan.

18 (b) An urban renewal project may not include using property that was condemned pursuant to Title
19 70, chapter 30, for anything other than a public use."

20

21 **Section 3.** Section 7-15-4210, MCA, is amended to read:

22 **"7-15-4210. Resolution of necessity required to utilize provisions of part.** A municipality may not
23 exercise any of the powers authorized by part 43 and this part until after its local governing body has adopted a
24 resolution finding that:

25 (1) one or more blighted areas exist in the municipality ~~by finding that at least three of the factors~~
26 ~~listed in 7-15-4206(2) apply to the area or a part of the area~~ BY FINDING THAT THE DEFINITION OF BLIGHTED AREA
27 PROVIDED FOR IN 7-15-4206 APPLIES TO THE AREA; and

28 (2) the rehabilitation, redevelopment, or both of an area or areas are necessary in the interest of

1 the public health, safety, morals, or welfare of the residents of the municipality."

2

3 **Section 4.** Section 7-15-4211, MCA, is amended to read:

4 **"7-15-4211. Preparation of comprehensive development plan for municipality.** For the purpose
5 of approving an urban renewal plan and other municipal purposes, a municipality may:

6 (1) prepare, adopt, and revise from time to time a comprehensive plan or parts of a plan for the
7 physical development of the municipality as a whole, with consideration for the county and school districts that
8 include municipal territory;

9 (2) establish and maintain a planning commission for that purpose and related municipal planning
10 activities; and

11 (3) make available and appropriate necessary funds for municipal planning activities to address
12 blight."

14 **Section 4.** Section 7-15-4215, MCA, is amended to read:

15 ~~**"7-15-4215. Notice of hearing on urban renewal plan.** (1) The notice required by 7-15-4214 (1)
16 must be given by publication as provided in 7-1-4127 and by mailing a notice of the hearing, not less than 10
17 days prior to the date of the hearing, to the persons whose names appear on the county treasurer's tax records
18 as the owners, reputed owners, or purchasers under contracts for deed of the property, at the address shown
19 on the tax record.~~

21 ~~(a) describe the time, date, place, and purpose of the hearing;~~

22 ~~(b) specify the proposed boundary of the urban renewal area affected;~~

1 **"7-15-4221. Modification of urban renewal project plan.** (1) An urban renewal project plan may be
2 modified at any time by the local governing body. If modified after the lease or sale by the municipality of real
3 property in the urban renewal project area, the modification is subject to any rights at law or in equity that a
4 lessee or purchaser or the lessee's or purchaser's successor or successors in interest may be entitled to assert.

5 (2) An urban renewal plan may be modified by ordinance.

6 (3) (a) Before modifying an urban renewal plan to provide tax increment financing for the district or
7 to use bonds as provided in 7-15-4218, the municipality shall provide notice to the county ~~and the school district~~
8 in which the urban renewal ~~district~~area is located and provide the county ~~and the school district~~ with the
9 opportunity to meet and consult in a public meeting with the opportunity for public comment regarding the effect
10 on the county ~~or school district~~.

11 (b) The tax increment financing provision must be proposed with consideration for the county ~~and~~
12 ~~school districts that include~~includes municipal territory.

13 ~~(4) All urban renewal plans approved or modified by resolution prior to May 8, 1979, are validated.~~

25 the municipality or to any existing public body corporate; or

26 ~~(2)~~(b) the legislative body of a city may create an urban renewal agency in ~~such~~the municipality, to

21 70, chapter 30, any interest in real property that it considers necessary for urban renewal.

22 ~~(2) — Condemnation for urban renewal of blighted areas, as defined in 7-15-4206 (2)(a), (2)(h),~~
23 ~~(2)(k), or (2)(n), is a public use, and property already devoted to any other public use or acquired by the owner~~
24 ~~or the owner's predecessor in interest by eminent domain may be condemned for the purposes of this part.~~

25 ~~(3) — The award of compensation for real property taken for an urban renewal project may not be~~
26 ~~increased by reason of any increase in the value of the real property caused by the assembly, clearance, or~~
