18 capability to transmit data to and receive data from all or substantially all internet endpoints. The term includes
19 capabilities that are incidental to and enable the operation of the communications service.

20 (b) The term does not include dial-up internet access service.

22 ~~deployed technology having the capacity to transmit data from or to the internet at minimum speeds~~

24 ~~applications for residential, commercial, or government use. "Broadband equity, access, and deployment~~
25 ~~program" means the program established by the Infrastructure Investment and Jobs Act, Public Law 117-58,~~
26 ~~and implemented by the national telecommunications and information administration.~~

15 during the proposal selection process in which a proposal may be declined if use of an alternative technology
16 meeting the broadband, equity, access, and deployment program program's technical requirements would be
17 less expensive.

18 ~~(5)~~(10) "FCC" means the federal communications commission.

19 ~~(6) "Frontier area" means an area where there is no or extremely limited terrestrial broadband service.~~

20 (11) "High-cost area" means an unserved area in which the cost of building out broadband service
21 is fiscally imprudent, and the area contains no less than 80% of unserved broadband-serviceable locations.

22 (12) "Last mile" means broadband infrastructure that serves as the final leg connecting the
23 broadband service provider's network to the end-user customer's premises.

24 ~~(7) "Low latency" means latency that is sufficiently low to allow multiple, simultaneous, real time~~
25 ~~interactive applications.~~

26 (13) "Middle mile" means broadband infrastructure that does not connect directly to an end-user
27 location, including a community anchor institution, and includes leased dark fiber, interoffice transport,

6 proposal for funding authorized under this part.

7 ~~(9)(15)~~ "Project area" means a shapefile area in an unserved or underserved area where the proposed
8 broadband service infrastructure would be built as described in a proposal for funding authorized under this
9 part.

10 ~~(10)(16)~~ "Shapefile" means a GIS file format for storing, depicting, and analyzing geospatial data
11 depicting broadband coverage. It is made up of several component files, such as a main file (.shp), an index file
12 (.shx), and a dBASE table (.dbf).

13 ~~(11)(17)~~ "Underserved area" means ~~an area where at least 10% of the delivery points have no access~~
14 ~~to broadband service offered with a download speed range of at least 100 megabits per second and an upload~~
15 ~~speed of at least 20 megabits per second or less with low latency~~ a location or area that is not an unserved
16 location and that lacks access to broadband service offered with a speed of not less than 100 megabits per
17 second for downloads, a speed of not less than 20 megabits per second for uploads, and latency less than or
18 equal to 100 milliseconds.

19 ~~(18)~~ "Underserved service project" means a project in which not less than 80% of broadband-
20 serviceable locations served by the project are unserved areas or underserved areas.

21 ~~(12)(19)~~ "Unserved area" means ~~a project area where at least 10% of delivery points have no access to~~
22 ~~broadband service or have no access to services operating with a download speed of at least 25 megabits per~~
23 ~~second and upload speed of at least 10 megabits per second with low latency~~ broadband-serviceable location
24 or area that has no access to broadband service or lacks service offered with a speed of not less than 25
25 megabits per second for downloads, a speed of not less than 3 megabits per second for uploads, and a latency
26 less than or equal to 100 milliseconds.

4 **Section 2.** Section 90-1-603, MCA, is amended to read:

5 **"90-1-603. (Temporary) Establishment of program -- administration and funding.** (1) There is a
6 communications advisory commission that consists of nine members who must be appointed as follows:

7 (a) six legislators appointed by the president of the senate;

8 (b) the governor's director of the office of budget and program planning;

9 (c) the governor's chief economic development officer; and

10 (d) the governor's director of administration.

11 (2) The commission may provide parameters governing the submission and funding of broadband
12 deployment grants as allowed by state and federal law or regulation.

13 ~~(4)(3)~~ The department shall establish the broadband infrastructure deployment program and shall
14 administer and act as the fiscal agent for the program and is responsible for receiving and reviewing responsive
15 proposals and awarding contracts after review by the communications advisory commission provided for in
16 Chapter 401, Laws of 2021, and the governor's approval. A request for proposal may be cancelled or any
17 proposal may be rejected in whole or in part when it is in the best interests of the state under the direction of the
18 governor's chief economic development officer and with advice from the commission.

19 (4) The department shall develop parameters in accordance with state and federal law and federal
20 guidance for the deployment of broadband funds with advice from the governor's chief economic development
21 officer and the commission. The department shall make all materials available for public comment at least 14
22 days in advance of consideration by the commission.

23 (5) The governor's chief economic development officer, with advice from the commission, shall
24 review materials as required by the national telecommunications and information administration prior to
25 submission for approval, deployment plans, and grant award recommendations made by the department.

17 **"90-1-604. (Temporary) Eligible projects.** (1) An eligible provider ~~proposal~~ proposal may be awarded funding

19 in a project area that, as of the date the proposal is filed, constitutes an unserved or underserved area. Funds
20 may not be used to support noncapital expenses, including general operations of an eligible provider,
21 nonbroadband services, marketing, or advertising. must be used in accordance with the requirements set forth
22 in the Infrastructure Investment and Jobs Act, Public Law 117-58, and as established by the national
23 telecommunications and information administration.

24 (2) The project area, including middle-mile or last-mile proposals, to be served by a project funded
25 under the program must be described on a shapefile basis.

26 (3) The department may issue requests for proposals or accept proposals from eligible providers

4 other valid reasons subject to approval by the national telecommunications and information administration.

5 (5) If no broadband service technology meeting national telecommunications and information
6 administration's technical requirements is deployable for a subsidy of less than the extremely high cost per
7 location threshold at a given location, the commission is authorized to recommend a proposal involving a less
8 costly technology for that location, even if that technology does not provide reliable broadband service but

20 where government funding supports 100% of the proposed project's capital costs;

21 (2)(b) shall commit to paying a minimum of 20% of the project costs not less than the minimum
22 matching amount required by the Infrastructure Investment and Jobs Act, Public Law 117-58, and may not
23 provide a minimum matching amount from any funds derived from government grants or subsidies, except for
24 federal funds designated by the Infrastructure Investment and Jobs Act, Public Law 117-58 for broadband
25 deployment. Priority will be given to the eligible provider who contributes the largest percentage of costs from
26 its own funds. Local and tribal governments, in partnership with an eligible provider, may provide funding for
27 broadband infrastructure projects consistent with the provisions of this part, except that such funds may not be

21 department. A responsive proposal must include the following information:

22 (a)(i) evidence demonstrating the provider's technical, financial, and managerial resources and
23 experience to provide broadband service or other communications services to customers in the state and the
24 ability to build, operate, and manage broadband service networks serving business and residential customers in
25 the state;

26 (b)(ii) a description of the project area, including shapefiles, that the eligible provider proposes to
27 build or serve and specific mapping of currently served areas, if any, including actual speed verification provide

18 application. Applications that fail to provide the requirements in this section must be submitted to the
19 commission for review. The commission may review the applications and cancel those that do not meet the
20 requirements of this section.

21 (3) The department shall treat any information that is not publicly available as confidential and
22 subject to the trade secrets protections of state law upon an eligible provider's request for confidential
23 treatment, except that shapefile information depicting broadband coverage in the proposal must be publicly
24 disclosed in sufficient detail to enable a challenging provider to identify the project area proposed to be covered
