BY REQUEST OF THE OFFICE OF BUDGET AND PROGRAM PLANNING

A BILL FOR AN ACT ENTITLED: "AN ACT APPROPRIATING MONEY FROM THE MONTANA COAL ENDOWMENT SPECIAL REVENUE ACCOUNT TO THE DEPARTMENT OF COMMERCE FOR INFRASTRUCTURE PROJECTS, EMERGENCY GRANTS FOR FINANCIAL ASSISTANCE TO LOCAL GOVERNMENTS, AND INFRASTRUCTURE PLANNING GRANTS; AUTHORIZING GRANTS FROM THE MONTANA COAL ENDOWMENT SPECIAL REVENUE ACCOUNT; PLACING CONDITIONS ON GRANTS AND FUNDS; APPROPRIATING MONEY FROM THE MONTANA COAL ENDOWMENT REGIONAL WATER SYSTEM SPECIAL REVENUE ACCOUNT TO THE DEPARTMENT OF NATURAL RESOURCES AND CONSERVATION FOR FINANCIAL ASSISTANCE TO REGIONAL WATER AUTHORITIES FOR REGIONAL WATER SYSTEM PROJECTS; AND PROVIDING AN EFFECTIVE DATE."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

NEW SECTION. Section 1. Appropriation for Montana coal endowment program grants. (1)

There is appropriated \$23,843,500 from the Montana coal endowment special revenue account established in 17-5-703(3)(a) to the department of commerce for the biennium beginning July 1, 2023, to finance Montana coal endowment program grants authorized by subsection (2).

13 revenue account established in 17-5-703(3)(a) to the department of commerce for the biennium beginning July
14 1, 2023, to finance Montana coal endowment program grants authorized by subsection (4).

1 NEW SECTION. Section 3. Condition of grants -- disbursements of funds. (1) The disbursement
2 of grant funds for the projects specified in [section 1(2) and (4)] is subject to completion of the following
3 conditions:

4 (a) The grant must document that other matching funds required for completion of the project are
5 firmly committed.

6 (b) The grant recipient must have a project management plan that is approved by the department
7 of commerce.

8 (c) The grant recipient must be in compliance with the auditing and reporting requirements
9 provided for in 2-7-503 and have established a financial accounting system that the department can reasonably
10 ensure conforms to generally accepted accounting principles. Tribal governments shall comply with auditing
11 and reporting requirements provided for in 2 CFR 200.

12 (d) The grant recipient shall satisfactorily comply with any conditions described in the application's
13 project summaries section of the Montana coal endowment program 2025 biennium project funding
14 recommendations to the 68th legislature.

15 (e) The grant recipient shall satisfy other specific requirements considered necessary by the
16 department of commerce to accomplish the purpose of the project as evidenced by the application to the
17 department.

18 (f) Pursuant to 90-6-710(6), the grant recipient shall comply with all Montana coal endowment
19 program requirements as determined by the department of commerce in order to qualify for reimbursement of
20 project expenses.

21 (g) The grant recipient shall execute a grant agreement with the department of commerce.

22 (2) With the exception of bridges, all projects must adhere to the design standards required by the
23 department of environmental quality. Recipients of Montana coal endowment program funds that are not
24 subject to the department of environmental quality design standards shall adhere to generally accepted industry
25 standards, such as Recommended Standards for Wastewater Facilities or Recommended Standards for Water
26 Works, published by the Great Lakes-Upper Mississippi River board of state and provincial public health and
27 environmental managers, latest edition.

28 (3) Recipients of Montana coal endowment program funds are subject to the requirements of the

1 department of commerce as described in the most recent edition of the Montana Coal Endowment Program
2 Project Administration Manual adopted by the department through the administrative rulemaking process.

3
4 **NEW SECTION. Section 4. Other powers and duties of department.** (1) The department of
5 commerce shall disburse grant funds on a reimbursement basis as grant recipients incur eligible project
6 expenses.

7 (2) If actual project expenses are lower than the projected expense of the project, the department
8 may, at its discretion:

9 (a) reduce the amount of grant funds to be provided to grant recipients in proportion to all other
10 project funding sources; or

11 (b) reduce the amount of grant funds to be provided so that the grant recipient's projected average
12 residential user rates do not become lower than their target rate as determined by the department.

13 (3) If the grant recipient obtains a greater amount of grant funds than was contained in the
14 Montana coal endowment program application, the department may reduce the amount of the Montana coal
15 endowment program grant funds to be provided to ensure that the grant recipient continues to meet the
16 threshold requirements contained in the program guidelines for receiving the larger Montana coal endowment
17 program grant.

18
19 **NEW SECTION. Section 5. Appropriation from Montana coal endowment special revenue**
20 **account for emergency grants.** There is appropriated \$100,000 from the Montana coal endowment special
21 revenue account to the department of commerce for the biennium beginning July 1, 2023, for the purpose of
22 providing local governments, as defined in 90-6-701, with emergency grants for infrastructure projects, as
23 defined in 90-6-701.

24
25 **NEW SECTION. Section 6. Appropriation from Montana coal endowment special revenue**
26 **account for infrastructure planning grants.** There is appropriated \$900,000 from the Montana coal
27 endowment special revenue account to the department of commerce for the biennium beginning July 1, 2023,
28 for the purpose of providing local governments, as defined in 90-6-701, with the infrastructure planning grants

1 for infrastructure projects, as defined in 90-6-701.

2

3 **NEW SECTION. Section 7. Appropriation from Montana coal endowment regional water system**
4 **special revenue account.** (1) There is appropriated ~~\$7 million~~ \$10 million from the Montana coal endowment
5 regional water system special revenue account to the department of natural resources and conservation for the
6 biennium beginning July 1, 2023, to finance the state's share of regional water system projects authorized in
7 subsection (2) and as set forth in 90-6-715.

8 (2) The state's four regional water authorities are authorized to receive the funds appropriated in
9 subsection (1) as long as there are sufficient funds available from the amount that was deposited in the
10 Montana coal endowment regional water system special revenue account during the biennium beginning July 1,
11 2023.

12 (3) A regional water authority's receipt of funds is dependent on the authority's compliance with the
13 conditions described in [section 9(1)].

14 (4) This section constitutes a valid obligation of funds to the regional water authorities identified in
15 subsection (2) for the purposes of encumbering the funds in the Montana coal endowment regional water
16 system special revenue account received during the biennium beginning July 1, 2023, under 17-7-302.

17
18 **NEW SECTION. Section 8. Approval of funds -- completion of appropriation.** (1) The legislature,
19 pursuant to 90-6-715, authorizes funds for the regional water authorities identified in [section 7(2)].

20 (2) The authorization of these funds completes an appropriation from the Montana coal
21 endowment regional water system special revenue account provided for in 17-5-703(3)(b).

22
23 **NEW SECTION. Section 9. Conditions -- manner of disbursement of funds.** (1) The disbursement
24 of funds under [sections 7 and 8] is subject to completion of the following conditions:

25 (a) The regional water authority shall execute an agreement with the department of natural
26 resources and conservation.

27 (b) The regional water authority must have a project management plan that is approved by the
28 department.

1 (c) The regional water authority shall establish a financial accounting system that the department
2 can reasonably ensure conforms to generally accepted accounting principles.

3 (d) The regional water authority shall provide the department with a detailed preliminary
4 engineering report.

5 (2) The department shall disburse funds on a reimbursement basis as the regional water authority
6 incurs eligible project expenses.

7
8 **NEW SECTION. Section 10. Notification to tribal governments.** The secretary of state shall send a
9 copy of [this act] to each federally recognized tribal government in Montana.

10
11 **NEW SECTION. Section 11. Effective date.** [This act] is effective July 1, 2023.
