5 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING LAWS RELATED TO CHILD ABUSE AND
6 NEGLECT INVESTIGATIONS BY THE DEPARTMENT OF PUBLIC HEALTH AND HUMAN SERVICES;
7 REMOVING TEMPORARY INVESTIGATIVE AUTHORITY; AMENDING SECTIONS 3-5-901, 41-3-422, 41-3-
8 427, AND 41-3-432, MCA; AND REPEALING SECTION 41-3-433, MCA."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

12 **Section 1.** Section 3-5-901, MCA, is amended to read:

13 **"3-5-901. State assumption of district court expenses.** (1) There is a state-funded district court
14 program under the judicial branch. Under this program, the office of court administrator shall fund all district
15 court costs, except as provided in subsection (3). These costs include but are not limited to the following:

- 16 (a) salaries and benefits for:
- 17 (i) district court judges;
- 18 (ii) law clerks;
- 19 (iii) court reporters, as provided in 3-5-601;
- 20 (iv) juvenile probation officers, youth division offices staff, and assessment officers of the youth
21 court;
- 22 (v) standing masters; and
- 23 (vi) other employees of the district court;
- 24 (b) in criminal cases:
- 25 (i) fees for transcripts of proceedings, as provided in 3-5-604;
- 26 (ii) witness fees and necessary expenses, as provided in 46-15-116;
- 27 (iii) juror fees and necessary expenses;
- 28 (iv) for a psychiatric examination under 46-14-202, the cost of the examination and other

1 associated expenses, as provided in 46-14-202(4); and

2 (v) for commitment under 46-14-221, the cost of transporting the defendant to the custody of the
3 director of the department of public health and human services to be placed in an appropriate facility of the
4 department of public health and human services and of transporting the defendant back for any proceedings, as
5 provided in 46-14-221(5);

6 (c) except as provided in 47-1-119, the district court expenses in all postconviction proceedings
7 held pursuant to Title 46, chapter 21, and in all habeas corpus proceedings held pursuant to Title 46, chapter
8 22, and appeals from those proceedings;

9 (d) except as provided in 47-1-119, the following expenses incurred by the state in federal habeas
10 corpus cases that challenge the validity of a conviction or of a sentence:

11 (i) transcript fees;

12 (ii) witness fees; and

13 (iii) expenses for psychiatric examinations;

14 (e) except as provided in 47-1-119, the following expenses incurred by the state in a proceeding
15 held pursuant to Title 41, chapter 3, part 4 or 6, that seeks ~~temporary investigative authority of a youth,~~
16 temporary legal custody of a youth, or termination of the parent-child legal relationship and permanent custody:

17 (i) transcript fees;

18 (ii) witness fees;

19 (iii) expenses for medical and psychological evaluation of a youth or the youth's parent, guardian,
20 or other person having physical or legal custody of the youth except for expenses for services that a person is
21 eligible to receive under a public program that provides medical or psychological evaluation;

22 (iv) expenses associated with appointment of a guardian ad litem or child advocate for the youth;

23 and

24 (v) expenses associated with court-ordered alternative dispute resolution;

25 (f) except as provided in 47-1-119, costs of juror and witness fees and witness expenses before a
26 grand jury;

27 (g) costs of the court-sanctioned educational program concerning the effects of dissolution of
28 marriage on children, as required in 40-4-226, and expenses of education when ordered for the investigation

1 and preparation of a report concerning parenting arrangements, as provided in 40-4-215(2)(a);

2 (h) except as provided in 47-1-119, all district court expenses associated with civil jury trials if
3 similar expenses were paid out of the district court fund or the county general fund in any previous year;

4 (i) all other costs associated with the operation and maintenance of the district court, including
5 contract costs for court reporters who are independent contractors; and

6 (j) costs associated with the operation and maintenance of the youth court and youth court
7 division operations pursuant to 41-5-111 and subsection (1)(a) of this section, except for those costs paid by
8 other entities identified in Title 41, chapter 5.

9 (2) If a cost is not paid directly by the office of court administrator, the county shall pay the cost
10 and the office of court administrator shall reimburse the county within 30 days of receipt of a claim.

11 (3) For the purposes of subsection (1), district court costs paid by the office of court administrator
12 do not include:

13 (a) costs for clerks of district court and employees and expenses of the offices of the clerks of
14 district court;

15 (b) costs of providing and maintaining district court office space; or

16 (c) charges incurred against a county by virtue of any provision of Title 7 or 46."

18 **Section 2.** Section 41-3-422, MCA, is amended to read:

19 **" 41-3-422. ~~(Temporary) Abuse and neglect petitions -- burden of proof.~~** (1)(a) Proceedings
20 under this chapter must be initiated by the filing of a petition. A petition may request the following relief:

21 (i) ~~immediate protection and emergency protective services, as provided in 41-3-427 ;~~

22 (ii) ~~temporary investigative authority, as provided in 41-3-433 ;~~

23 (iii) ~~temporary legal custody, as provided in 41-3-442 ;~~

24 (iv) ~~long-term custody, as provided in 41-3-445 ;~~

25 (v) ~~termination of the parent-child legal relationship, as provided in 41-3-607 ;~~

26 (vi) ~~appointment of a guardian pursuant to 41-3-444 ;~~

3 (c) — A petition for temporary legal custody may be the initial petition filed in a case.

4 (d) — A petition for the termination of the parent-child legal relationship may be the initial petition filed
5 in a case if a request for a determination that preservation or reunification services need not be provided is
6 made in the petition.

7 (2) — The county attorney, attorney general, or an attorney hired by the county shall file all petitions
8 under this chapter. A petition filed by the county attorney, attorney general, or an attorney hired by the county
9 must be accompanied by:

10 (a) — an affidavit by the department alleging that the child appears to have been abused or neglected
11 and stating the basis for the petition; and

12 (b) — a separate notice to the court stating any statutory time deadline for a hearing.

13 (3) — Abuse and neglect petitions must be given highest preference by the court in setting hearing
14 dates.

15 (4) — An abuse and neglect petition is a civil action brought in the name of the state of Montana. The
16 Montana Rules of Civil Procedure and the Montana Rules of Evidence apply except as modified in this chapter.
17 Proceedings under a petition are not a bar to criminal prosecution.

18 (5) — (a) Except as provided in subsection (5)(b), the person filing the abuse and neglect petition has
19 the burden of presenting evidence required to justify the relief requested and establishing:

20 (i) — probable cause for the issuance of an order for immediate protection and emergency protective
21 services or an order for temporary investigative authority ;

22 (ii) — a preponderance of the evidence for an order of adjudication or temporary legal custody;

23 (iii) — a preponderance of the evidence for an order of long-term custody; or

24 (iv) — clear and convincing evidence for an order terminating the parent-child legal relationship.

25 (b) — If a proceeding under this chapter involves an Indian child, as defined in the federal Indian

Section 3. Section 41-3-427, MCA, is amended to read:

" 41-3-427. ~~(Temporary) Petition for immediate protection and emergency protective services -- evidence and consideration of harm of removal -- order -- service.~~ (1) (a) In a case in which it appears that a child is abused or neglected or is in danger of being abused or neglected, the county attorney, the attorney general, or an attorney hired by the county may file a petition for immediate protection and emergency protective services. In implementing the policy of this section, the child's health and safety are of paramount concern.

(b) ~~_____ A petition for immediate protection and emergency protective services must state the specific authority requested and must be supported by an affidavit signed by a representative of the department stating in detail the alleged facts upon which the request is based and the facts establishing probable cause or, if the case is subject to the federal Indian Child Welfare Act or the Montana Indian Child Welfare Act provided for in Title 41, chapter 3, part 13, clear and convincing evidence that a child is abused or neglected or is in danger of being abused or neglected.~~

(c) ~~_____ The affidavit of the department representative must contain:~~

(i) ~~_____ information, if any, regarding statements made by the parents about the facts of the case; and~~

(ii) ~~_____ specific, written documentation as to why the risk of allowing the child to remain at home substantially outweighs the harm of removing the child, including consideration of:~~

(A) ~~_____ the emotional trauma the child is likely to experience if separated from the family;~~

(B) ~~_____ the child's relationships with other members of the household, including siblings;~~

1 (C) — the child's schooling and social relationships that could be disrupted with a placement out of
2 the neighborhood;

3 (D) — the impact the removal would have on services the child is receiving and on extracurricular
4 activities that benefit the child; and

5 (E) — documentation of reasonable efforts made to keep the family intact.

6 (d) — If from the alleged facts presented in the affidavit it appears to the court that there is probable
7 cause or, if the case is subject to the federal Indian Child Welfare Act or the Montana Indian Child Welfare Act,
8 clear and convincing evidence to believe that the child has been abused or neglected or is in danger of being
9 abused and neglected, the judge shall grant emergency protective services and the relief authorized by
10 subsection (2) until the adjudication hearing or the temporary investigative hearing. If it appears from the
11 alleged facts contained in the affidavit that there is insufficient probable cause or, if the case is subject to the
12 federal Indian Child Welfare Act or the Montana Indian Child Welfare Act, clear and convincing evidence to
13 believe that the child has been abused or neglected or is in danger of being abused or neglected, the court
14 shall dismiss the petition.

15 (e) — If the parents, parent, guardian, person having physical or legal custody of the child, or attorney
16 for the child disputes the material issues of fact contained in the affidavit or the veracity of the affidavit, the
17 person may request a contested show cause hearing pursuant to 41-3-432 within 10 days following service of
18 the petition and affidavit.

19 (f) — The petition for immediate protection and emergency protective services must include a notice
20 advising the parents, parent, guardian, or other person having physical or legal custody of the child that the
21 parents, parent, guardian, or other person having physical or legal custody of the child may have a support
22 person present during any meeting with a child protection specialist concerning emergency protective services.
23 Reasonable accommodation must be made in scheduling an in-person meeting with the child protection
24 specialist.

25 (2) — Pursuant to subsection (1), if the court finds probable cause or, if the case is subject to the
26 federal Indian Child Welfare Act or the Montana Indian Child Welfare Act, clear and convincing evidence based
27 on the petition and affidavit, the court may issue an order for immediate protection of the child. The court shall
28 consider the parents' statements, if any, included with the petition and any accompanying affidavit or report to

1 the court. If the court finds probable cause or, if the case is subject to the federal Indian Child Welfare Act or the
2 Montana Indian Child Welfare Act, clear and convincing evidence, the court may issue an order granting the
