4 supervise the examination of applicants;

5 (c) conduct hearings and keep records and minutes as the board considers necessary to an

15 landscape architect from performing services for a corporation, firm, partnership, or association.

16 (2) Each partner in a partnership of landscape architects must be licensed to practice landscape
17 architecture. Subject to this requirement, a partnership of landscape architects may use a partnership name if
18 the name consists of:
