- 10 (ii) sand and gravel, if an investigation is completed, in accordance with 82-2-701;
- 11 (iii) assistance to local governments on federal land management proposals from the department
12 of commerce in accordance with 90-1-182; and
- 13 (iv) emergency financial assistance to local government reports from the department of commerce,
14 if requests are made, in accordance with 90-6-703(2);
- 15 (l) reports to the state-tribal relations committee, including:
- 16 (i) reports from the missing indigenous persons review commission in accordance with 2-15-2018;
- 17 (ii) the Montana Indian language preservation program report from the office of public instruction in
18 accordance with 20-9-537;
- 19 (iii) reports from the missing and murdered indigenous persons ~~task force~~ advisory council in
20 accordance with 44-2-411;
- 21 (iv) a report from the department of justice on missing persons response team training grants
22 awarded in accordance with 44-2-416;
- 23 (v) state-tribal economic development commission activities reports from the state-tribal economic
24 development commission in accordance with 90-1-132; and
- 25 (vi) state-tribal economic development commission reports provided regularly by the state director
26 of Indian affairs in accordance with 90-11-102.
- 27 (4) Reports to the legislature include multistate compact and agreement reports, including:
- 28 (a) multistate tax compact reports in accordance with 15-1-601;

- 1 (b) interstate compact on educational opportunity for military children reports in accordance with
 2 20-1-230 and 20-1-231;
- 3 (c) compact for education reports in accordance with 20-2-501;
- 4 (d) Western regional higher education compact reports in accordance with 20-25-801;
- 5 (e) interstate insurance product regulation compact reports in accordance with 33-39-101;
- 6 (f) interstate medical licensure compact reports in accordance with 37-3-356;
- 7 (g) interstate compact on juveniles reports in accordance with 41-6-101;
- 8 (h) interstate compact for adult offender supervision reports in accordance with 46-23-1115;
- 9 (i) vehicle equipment safety compact reports in accordance with 61-2-201;
- 10 (j) multistate highway transportation agreement reports in accordance with 61-10-1101; and
- 11 (k) western interstate nuclear compact reports in accordance with 90-5-201.
- 12 (5) Reports, transfers, statements, assessments, recommendations and changes required under
 13 17-7-138, 17-7-139, 17-7-140, 19-2-405, 19-2-407, 19-3-117, 19-20-201, 19-20-216, 23-7-202, 33-1-115, and
 14 39-71-2375 must be provided as soon as the report is published and publicly available. Reports required in
 15 subsections (2)(a), (2)(gg), (2)(ii), and (3)(b)(xi) must be provided following issuance of reports issued under
 16 Title 5, chapter 13."

18 **Section 2.** Section 44-2-411, MCA, is amended to read:

19 **"44-2-411. (Temporary) Missing and murdered indigenous persons ~~task force~~ advisory council**

20 **-- membership -- duties -- reporting.** (1) There is a missing and murdered indigenous persons ~~task force~~
 21 advisory council. The ~~task force~~ advisory council is allocated to the department of justice for staffing services
 22 and administrative purposes only.

23 (2) ~~Task force~~ Advisory council members, including the presiding officer, must be appointed by the
 24 attorney general or a designee of the attorney general. The ~~task force~~ advisory council membership must
 25 include but is not limited to:

- 26 (a) an employee of the department of justice who has expertise in the subject of missing persons;
- 27 (b) a representative from each federally recognized Indian tribe in Montana;
- 28 (c) ~~a member from the Montana highway patrol~~ homicide investigator;

1 (d) a representative from the attorney general's office; and

2 (e) a representative from the office of public instruction.

3 (3) While respecting the government-to-government relationship between the state and each tribe,
4 the primary duties of the ~~task force~~ advisory council are to:

5 (a) identify jurisdictional barriers between federal, state, local, and tribal law enforcement and
6 community agencies;

7 (b) work to identify causes that contribute to missing and murdered indigenous persons and make
8 recommendations to federally recognized tribes in the state and applicable federal agencies to reduce cases of
9 missing and murdered indigenous persons;

10 (c) work to identify strategies to improve interagency communication, cooperation, and
11 collaboration to remove jurisdictional barriers and increase reporting and investigation of missing and murdered
12 indigenous persons; and

13 (d) administer the looping in native communities network grant program provided for in 44-2-412.

14 (4) A vacancy on the ~~task force~~ advisory council must be filled in the manner of the original
15 appointment.

16 (5) By July 1 prior to each regular legislative session, the ~~task force~~ advisory council shall, in
17 accordance with 5-11-210, prepare a written report of findings and recommendations for submission to the
18 state-tribal relations committee provided for in 5-5-229. The report must include the following information:

19 (a) the number of unique individuals reported to the missing and murdered indigenous persons
20 database;

21 (b) the number of unique individuals recovered as a result of the missing and murdered indigenous
22 persons database;

23 (c) the number of unique individuals recovered as a result of the looping in native communities
24 network grant program;

25 (d) the number of unique individuals searched for and recovered as a result of missing persons
26 response teams;

27 (e) the number of missing persons entries into the missing and murdered indigenous persons
28 database by year;

1 (f) an analysis by year of the characteristics of missing indigenous persons, including but not
2 limited to age, gender, child protective services involvement status, foster case status, duration of time missing,
3 and estimated related cause;

4 (g) the number of actively missing indigenous persons by year;

5 (h) a description and the results of any noncompetitive grant awardee activities;

6 (i) a description of the activities and progress related to improving interagency communication,
7 cooperation, and collaboration and removing interjurisdictional barriers; and

8 (j) any other information the ~~task force~~ advisory council members find relevant to the ~~task force's~~
9 advisory council's mission.

10 (6) In addition to the recommendations to federally recognized tribes in the state required under
11 subsection (3)(b), the ~~task force~~ advisory council may make recommendations to federal, state, and local
12 agencies in carrying out the ~~task force's~~ advisory council's duties. (Terminates June 30, 2033--sec. 2, Ch. 624,

15 **Section 3.** Section 44-2-412, MCA, is amended to read:

16 **"44-2-412. (Temporary) Looping in native communities network grant program.** (1) There is a
17 looping in native communities network grant program. The program is established to create a network in
18 support of efforts by Montana tribes to identify, report, and find Native American persons who are missing. The
19 grant program is administered by the missing and murdered indigenous persons ~~task force~~ advisory council
20 established in 44-2-411.

21 (2) The grant program includes a competitive grant to be awarded to a tribal entity to create and
22 administer a central administration point for the looping in native communities network. The missing and
23 murdered indigenous persons ~~task force~~ advisory council shall develop the application and the criteria to award
24 the grant to a tribal entity. The criteria must include:

25 (a) policies and standards for technology and equipment, including data storage and security of
26 information entered into the network;

27 (b) standards for data verification;

28 (c) job qualifications and requirements for a data specialist to administer the network;

1 (d) development of a system to provide automatic initial alerts to law enforcement agencies and
2 tribal and community organizations when a missing indigenous person report is made, including determining
3 which law enforcement agencies will receive the automatic initial alert;

4 (e) development of a standard reporting form that includes space to provide the information
5 specified in subsection (4) to be used by the data specialist; and

6 (f) administrative rights for a designee at each participating tribal agency.

7 (3) The grant program may include additional smaller, noncompetitive grants to be awarded to a
8 qualifying tribal agency at each reservation that submits a complete application. The purpose of the grants
9 awarded under this subsection is to provide matching funds for some or all of the costs required for the tribal
10 agency to set up and maintain access to the looping in native communities network.

11 (4) The standard reporting form required under subsection (2)(e) must allow a data specialist to
12 enter information about the missing indigenous person, including but not limited to the missing person's:

13 (a) name and any aliases or nicknames;

14 (b) gender, age, height, weight, and other physical descriptive characteristics;

15 (c) last known location and related information, including the date of last contact with the missing
16 indigenous person and the person with whom the missing indigenous person last made contact; and

17 (d) photographs, including photographs obtained from an online or social media profile.

20 NEW SECTION. Section 4. Notification to tribal governments. The secretary of state shall send a
21 copy of [this act] to each federally recognized tribal government in Montana.
