11 **Section 1.** Section 61-1-101, MCA, is amended to read:

12 **"61-1-101. Definitions.** As used in this title, unless the context indicates otherwise, the following
13 definitions apply:

14 (1) (a) "Authorized agent" means a person who has executed a written agreement with the
15 department and is specifically authorized by the department to electronically access and update the
16 department's motor vehicle titling, registration, or driver records, using an approved automated interface, for
17 specific functions or purposes on behalf of a third party.

18 (b) For purposes of this subsection (1), "person" means an individual, corporation, partnership,
19 limited partnership, limited liability company, association, joint venture, state agency, local government unit,
20 another state government, the United States, a political subdivision of this or another state, or any other legal or
21 commercial entity.

22 (2) "Authorized agent agreement" means the written agreement executed between an authorized
23 agent and the department that sets the technical and operational program standards, compliance criteria,
24 payment options, and service expectations by which the authorized agent is required to operate in performing
25 specific motor vehicle or driver-related record functions.

26 (3) "Autocycle" means a three-wheeled motorcycle that is equipped with safety belts, roll bars or
27 roll hoops, a steering wheel, and seating that does not require the operator to straddle or sit astride it.

1 (4) "Bus" means a motor vehicle designed for carrying more than 10 passengers and used for the
2 transportation of persons and any other motor vehicle, other than a taxicab, designed and used for the
3 transportation of persons for compensation.

4 (5) (a) "Business entity" means a corporation, association, partnership, limited liability partnership,
5 limited liability company, or other legal entity recognized under state law.

6 (b) The term does not include an individual.

7 (6) (a) "Camper" means a structure designed to be mounted in the cargo area of a truck or
8 attached to an incomplete vehicle for the purpose of providing shelter for persons. The term includes but is not
9 limited to a cab-over, half cab-over, noncab-over, telescopic, and telescopic cab-over.

10 (b) The term does not include a truck canopy cover or topper.

11 (7) "CDLIS driver record" means the electronic record of a person's commercial driver's license
12 status and history stored as part of the commercial driver's license system established under 49 U.S.C. 31309.

13 (8) "Certificate of title" means the paper record issued by the department or by the appropriate
14 agency of another jurisdiction that establishes a verifiable record of ownership between an identified person or
15 persons and the motor vehicle specifically described in the record and that provides notice of a perfected
16 security interest in the motor vehicle.

17 (9) "Commercial driver's license" means:

18 (a) a driver's license issued under or granted by the laws of this state that authorizes a person to
19 operate a class of commercial motor vehicle; or

20 (b) the privilege of a person to drive a commercial motor vehicle, whether or not the person holds a
21 valid commercial driver's license.

22 (10) (a) "Commercial motor vehicle" means a motor vehicle or combination of motor vehicles used
23 in commerce to transport passengers or property if the vehicle:

24 (i) has a gross combination weight rating or a gross combination weight of 26,001 pounds or
25 more, whichever is greater, inclusive of a towed unit with a gross vehicle weight rating of more than 10,000
26 pounds;

27 (ii) has a gross vehicle weight rating or a gross vehicle weight of 26,001 pounds or more,

- 5 (b) The following vehicles are not commercial motor vehicles:
- 6 (i) an authorized emergency vehicle:
- 7 (A) equipped with audible and visual signals as required under 61-9-401 and 61-9-402; and
- 8 (B) operated when responding to or returning from an emergency call or operated in another

- 18 military reserves, a member of the national guard on active duty, including personnel on full-time national guard
- 19 duty, personnel in part-time national guard training, and national guard military technicians, or active duty
- 20 United States coast guard personnel.
- 21 (c) For purposes of this subsection (10):
- 22 (i) "farmer" means a person who operates a farm or who is directly involved in the cultivation of
- 23 land or crops or the raising of livestock owned by or under the direct control of that person;
- 24 (ii) "gross combination weight rating" means the value specified by the manufacturer as the loaded
- 25 weight of a combination or articulated vehicle;
- 26 (iii) "gross vehicle weight rating" means the value specified by the manufacturer as the loaded
- 27 weight of a single vehicle; and

- 2 (11) "Commission" means the state transportation commission.
- 3 (12) "Custom-built motorcycle" means a motorcycle that is equipped with:
- 4 (a) an engine that was manufactured 20 years prior to the current calendar year and that has been
- 5 altered from the manufacturer's original design; or
- 6 (b) an engine that was manufactured to resemble an engine 20 or more years old and that has

- 15 (14) "Customer identification number" means:
- 16 (a) a driver's license or identification card number when the customer is an individual who has
- 17 been issued a driver's license or identification card by a state driver licensing authority;
- 18 (b) a federal employer or tax identification number when the customer is a business entity that has
- 19 been issued a federal employer or tax identification number;
- 20 (c) the identification number assigned by the secretary of state to a business entity authorized to
- 21 do business in this state under Title 35 if the customer is a business entity that does not have a federal
- 22 employer or tax identification number other than a social security number; or
- 23 (d) if the customer has not been issued one of the numbers described in subsections (14)(a)
- 24 through (14)(c), a number assigned to the customer by the department when a transaction is initiated under this
- 25 title.
- 26 (15) (a) "Dealer" means a person that, for commission or profit, engages in whole or in part in the
- 27 business of buying, selling, exchanging, or accepting on consignment new or used motor vehicles, trailers,

2 mobile equipment that is not registered in the name of the person.

3 (b) The term does not include the following:

4 (i) receivers, trustees, administrators, executors, guardians, or other persons appointed by or
5 acting under a judgment or order of any court of competent jurisdiction;

6 (ii) employees of the persons included in subsection (15)(b)(i) when engaged in the specific
7 performance of their duties as employees; or

8 (iii) public officers while performing or in the operation of their duties.

9 (16) "Declared weight" means the total unladen weight of a vehicle plus the weight of the maximum
10 load to be carried on the vehicle as stated by the registrant in the application for registration.

11 (17) "Department" means the department of justice acting directly or through its duly authorized
12 officers or agents.

13 (18) "Dolly or converter gear" means a device consisting of one or two axles with a fifth wheel and
14 trailer tongue used to support the forward end of a semitrailer, converting a semitrailer into a trailer.

15 (19) "Domiciled" means a place where:

16 (a) an individual establishes residence;

17 (b) a business entity maintains its principal place of business;

18 (c) the business entity's registered agent maintains an address; or

19 (d) a business entity most frequently uses, dispatches, or controls a motor vehicle, trailer,
20 semitrailer, or pole trailer that it owns or leases.

21 (20) "Downgrade" means the removal of a person's privilege to operate a commercial motor vehicle,
22 as maintained by the department on the individual Montana driving record and the CDLIS driver record for that
23 person.

24 (21) "Driver" means a person who drives or is in actual physical control of a vehicle.

25 (22) "Driver's license" means a license or permit to operate a motor vehicle issued under or granted
26 by the laws of this state, including:

27 (a) any temporary license or learner license;

6 (23) "Electric personal assistive mobility device" means a device that has two nontandem wheels, is
7 self-balancing, and is designed to transport only one person with an electric propulsion system that limits the
8 maximum speed of the device to 12 1/2 miles an hour.

9 (24) "For hire" means an action performed for remuneration of any kind, whether paid or promised,
10 either directly or indirectly, or received or obtained through leasing, brokering, or buy-and-sell arrangements
11 from which a remuneration is obtained or derived for transportation service.

12 (25) (a) "Golf cart" means a motor vehicle that is designed for use on a golf course to carry a person
13 or persons and golf equipment and that has an average speed of less than 15 miles per hour.

14 (b) Except as provided in 61-3-201, a golf cart is exempt from titling, registration, and mandatory
15 liability insurance requirements under this title.

16 (26) "Gross vehicle weight" means the weight of a vehicle without load plus the weight of any load
17 on the vehicle.

18 (27) "Hazardous material" means:

19 (a) any material that has been designated as hazardous under 49 U.S.C. 5103 and is required to
20 be placarded under 49 CFR, part 172; or

21 (b) any quantity of a material listed as a select agent or toxin in 42 CFR, part 73.

22 (28) "Highway" or "public highway" means the entire width between the boundary lines of every
23 publicly maintained way when any part of the publicly maintained way is open to the use of the public for
24 purposes of vehicular travel.

25 (29) "Highway patrol officer" means a state officer authorized to direct or regulate traffic or to make
26 arrests for violations of traffic regulations.

27 (30) "Implement of husbandry" means a vehicle that is designed for agricultural purposes and

2 (31) "Kit vehicle" is a motor vehicle assembled from a manufactured kit either as:

3 (a) a complete kit, consisting of a prefabricated body and chassis, to construct a new motor
4 vehicle; or

5 (b) a kit with a prefabricated body to be mounted to an existing motor vehicle chassis and
6 drivetrain, commonly referred to as a donor vehicle.

7 (32) "Light vehicle" means a motor vehicle commonly referred to as an automobile, van, sport utility
8 vehicle, or truck having a manufacturer's rated capacity of 1 ton or less.

9 (33) "Low-speed electric vehicle" means a motor vehicle, on or by which a person may be
10 transported, that:

11 (a) has four wheels;

12 (b) has a maximum speed of at least 20 miles an hour and no greater than 40 miles an hour as
13 certified by the manufacturer;

14 (c) is propelled by its own power, using an electric motor or other device that transforms stored
15 electrical energy into the motion of the vehicle;

16 (d) stores electricity in batteries, ultracapacitors, or similar devices, which are charged from the
17 power grid or from renewable electrical energy sources;

18 (e) has a wheelbase of 40 inches or greater and a wheel diameter of 10 inches or greater;

19 (f) exhibits a manufacturer's compliance with 49 CFR, part 565, or displays a 17-character vehicle
20 identification number as provided in 49 CFR, part 565; and

21 (g) is equipped as provided in 61-9-432.

22 (34) "Low-speed restricted driver's license" means a license limited to the operation of a low-speed
23 electric vehicle or a golf cart issued under or granted by the laws of this state, including:

24 (a) a temporary license or learner license;

25 (b) the privilege of a person to drive a low-speed electric vehicle or golf cart under the authority of
26 61-5-122, whether or not the person holds a valid driver's license; and

27 (c) a nonresident's similarly restricted driving privilege.

1 (35) "Manufactured home" has the meaning provided in 15-24-201.

2 (36) "Manufacturer" includes any person engaged in the manufacture of motor vehicles, trailers,
3 semitrailers, pole trailers, travel trailers, motorboats, sailboats, snowmobiles, or off-highway vehicles as a
4 regular business.

5 (37) "Manufacturer's certificate of origin" means the original paper record produced and issued by
6 the manufacturer of a vehicle or, if in a medium authorized by the department, an electronic record created and
7 transmitted by the manufacturer of a vehicle to the manufacturer's agent or a licensed dealer. The record must
8 establish the origin of the vehicle specifically described in the record and, upon assignment, transfers of
9 ownership of the vehicle to the person or persons named in the certificate.

10 (38) (a) "Medium-speed electric vehicle" is a motor vehicle, on or by which a person may be
11 transported, that:

12 (i) has a maximum speed of 45 miles an hour as certified by the manufacturer;

13 (ii) is propelled by its own power, using an electric motor or other device that transforms stored
14 electrical energy into the motion of the vehicle;

15 (iii) stores electricity in batteries, ultracapacitors, or similar devices, which are charged from the
16 power grid or from renewable electrical energy sources;

17 (iv) is fully enclosed and includes at least one door for entry;

18 (v) has a wheelbase of 40 inches or greater and a wheel diameter of 10 inches or greater;

19 (vi) exhibits a manufacturer's compliance with 49 CFR, part 565, or displays a 17-character vehicle
20 identification number as provided in 49 CFR, part 565;

21 (vii) bears a sticker, affixed by the manufacturer or dealer, on the left side of the rear window that
22 indicates the vehicle's maximum speed rating; and

23 (viii) as certified by the manufacturer, is equipped as provided in 61-9-432.

24 (b) A medium-speed electric vehicle must be treated as a light vehicle for purposes of titling and
25 registration under Title 61, chapter 3.

26 (c) A medium-speed electric vehicle may not have a gross vehicle weight in excess of 5,000
27 pounds.
