4 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING JUDICIAL ELECTION LAWS;
5 PROVIDING FOR THE PARTISAN NOMINATION AND ELECTION OF SUPREME COURT JUSTICES,
6 DISTRICT COURT JUDGES, JUSTICES OF THE PEACE, AND MUNICIPAL COURT JUDGES; PROVIDING
7 THAT EACH VACANCY FOR A SUPREME COURT JUSTICE AND A DISTRICT COURT JUDGE IS A
8 SEPARATE AND INDEPENDENT OFFICE; ALLOWING JUDICIAL CANDIDATES TO ACCEPT
9 ENDORSEMENTS FROM POLITICAL PARTIES; ALLOWING POLITICAL PARTIES TO CONTRIBUTE TO
10 JUDICIAL CANDIDATES; PROVIDING THAT THE PROPOSED ACT BE SUBMITTED TO THE QUALIFIED
11 ELECTORS OF MONTANA; AMENDING SECTIONS 3-2-101, 3-5-201, 3-10-201, 3-10-206, 13-14-111, 13-14-
12 118, AND 13-37-211, MCA; REPEALING SECTIONS 13-14-211, 13-14-212, 13-14-213, AND 13-35-231, MCA;
13 AND PROVIDING AN APPLICABILITY DATE AND AN EFFECTIVE DATE."

15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

16

17 NEW SECTION. **Section 1. Statement of purpose.** It is the policy of the state of Montana that
18 candidates for district judges and supreme court justices must be nominated and elected on a partisan ballot in
19 the same manner as provided for other partisan offices. The chief justice of the supreme court shall assign an
20 individual number to each justice position and certify these numbers to the secretary of state. The clerk of
21 district court in a multijudge district shall certify department numbers assigned pursuant to state law to the
22 secretary of state. Joint fundraising committee expenditures supporting a judicial candidate are allowed even if
23 a participant is a political party committee.

25 **Section 2.** Section 3-2-101, MCA, is amended to read:

26 **"3-2-101. Number, nomination, election, and term of office.** (1) The supreme court consists of a
27 chief justice and six associate justices who are elected by the qualified electors of the state at large at the
28 general state elections next preceding the expiration of the terms of office of their predecessors, respectively,

1 and hold their offices for the term of 8 years from and after the first Monday of January next succeeding their
2 election.

3 (2) A supreme court justice, including the chief justice, must be nominated and elected on a
4 partisan ballot in the same manner as provided for partisan candidates in Title 13, except that an incumbent
5 justice who is the only candidate for the office must be placed on the general ballot as provided in Article VII,
6 section 8, of the Montana constitution and [section 5].

7 (3) Each vacancy for justice of the supreme court is a separate and independent office for election
8 purposes. The chief justice of the supreme court shall assign an individual number to each justice position and
9 certify these numbers to the secretary of state."

10
11 **Section 3.** Section 3-5-201, MCA, is amended to read:

12 **"3-5-201. Election Nomination, election, and oath of office.** (1) The judges of the district court,
13 except judges pro tempore, must be elected by the qualified voters of the district.

14 (2) (a) A district court judge must be nominated and elected on a partisan ballot in the same
15 manner as provided for partisan candidates in Title 13, except that an incumbent judge who is the only
16 candidate for the office must be placed on the general ballot as provided in Article VII, section 8, of the Montana
17 constitution and [section 5].

18 (b) Each vacancy for district court office is a separate and independent office for election
19 purposes.

20 (c) The clerk of district court in a multijudge district shall certify the department numbers assigned
21 pursuant to 3-5-403 to the office of the secretary of state for election purposes.

22 (2)(3) Except as provided in subsection (1), each judge of a the district court shall, as soon as the
23 judge has taken and subscribed the official oath, file the official oath in the office of the secretary of state."

24
25 **Section 4.** Section 3-10-201, MCA, is amended to read:

26 **"3-10-201. Election Nomination and election.** (1) Except as provided in 3-10-206, each justice of
27 the peace must be elected by the qualified electors of the county at the general state election immediately
28 preceding the expiration of the term of office of the justice of the peace's predecessor.

(2) A justice of the peace must be nominated and elected on the nonpartisan judicial ballot in the same manner as judges of the district court.

(3) Each judicial office must be a separate and independent office for election purposes, each office must be numbered by the county commissioners, and each candidate for justice of the peace shall specify the number of the office for which the candidate seeks to be elected. A candidate may not file for more than one office.

~~(4) — Section 13-35-231, prohibiting political party contributions to judicial officers, applies to justices of the peace."~~

NEW SECTION. Section 5. Form of ballot on retention for judicial officers. (1) If an incumbent judge is the only candidate for a judicial office, the name of the incumbent judge must be placed on the official ballot for the general election as follows:

Shall (insert title of officer) (insert name of the incumbent officer) of the (insert title of the court) of the state of Montana be retained for another term?

(2) Following the question, provision must be made, subject to rules adopted pursuant to 13-12-202, for a voter to indicate a "yes" or a "no" vote. The form must include the incumbent's political party designation and may not include a write-in space for the office.

Section 6. Section 3-10-206, MCA, is amended to read:

"3-10-206. Vacancies. Subject to the residency requirements provided in 3-10-204 and the election requirements provided in 3-10-201(2) ~~through (4)~~ and (3), a vacancy in the office of a justice of the peace must be filled pursuant to 7-4-2206 until a successor is elected and qualified."

Section 7. Section 13-14-111, MCA, is amended to read:

"13-14-111. Application of general laws. Except as otherwise provided in this chapter, candidates for nonpartisan offices, ~~including judicial offices,~~ must be nominated and elected according to the provisions of this title."

1 **Section 8.** Section 13-14-118, MCA, is amended to read:

2 **"13-14-118. Vacancies among nominees after nomination and before general election.** (1) If
3 after the primary election and before the 85th day before the general election a candidate is not able to run for
4 the office for any reason, the vacancy must be filled by the candidate next in rank in number of votes received
5 in the primary election.

6 (2) If a vacancy for a nonpartisan nomination cannot be filled as provided in subsection (1) and the
7 vacancy occurs no later than 85 days before the general election, a 10-day period for accepting declarations for
8 nomination or statements of candidacy and nominating petitions for the office must be declared by:

9 (a) the governor for national, state, ~~judicial district~~, legislative, or any multicounty district office;

10 (b) the governing body of the appropriate political subdivision for all other offices.

11 (3) The names of the candidates who filed as provided in subsection (2) must be certified and must
12 appear on the general election ballot in the same manner as candidates nominated in the primary.

13 (4) If the vacancy occurs later than 85 days before the general election and a qualified individual is
14 not elected to the office at the general election, the office is vacant and must be filled as provided by law."

15
16 **Section 9.** Section 13-37-211, MCA, is amended to read:

17 **"13-37-211. Joint fundraising committee.** (1) (a) One or more candidates for a statewide office and
18 political committees may join together to establish a joint fundraising committee to act as a fundraising
19 representative for all participants. A joint fundraising committee may not be construed to be a political
20 committee.

21 (b) The participants in a joint fundraising committee may include only a candidate for statewide
22 office, an independent committee, or a political party committee. Any combination of these entities may form a
23 joint fundraising committee.

24 (c) The participants in a joint fundraising committee may not include an incidental committee, a
25 ballot issue committee, a judicial candidate, or a political committee that is a corporation or a union.

26 (d) The joint fundraising committee may not be a participant in any other joint fundraising effort.

27 (e) A participant may participate in an unlimited amount of concurrent joint fundraising committees.

28 (f) A joint fundraising committee may not amend its list of participants after filing its certification

1 and organizational statement as provided by 13-37-201.

2 (2) A joint fundraising committee shall:

3 (a) appoint a campaign treasurer and certify an organization statement pursuant to 13-37-201;

4 (b) designate one separate campaign depository as provided in 13-37-205 to be used solely for
5 the receipt of all contributions received and the disbursement of all expenditures made by the joint fundraising
6 committee; and

7 (c) keep records as provided by 13-37-207 and 13-37-208.

8 (3) The participants in a joint fundraising committee shall enter into a written agreement that states
9 a formula for the allocation of fundraising proceeds. The formula must be stated as the amount or percentage of
10 each contribution received to be allocated to each participant. The joint fundraising committee shall retain the
11 written agreement for the same amount of time the campaign treasurer is required to retain accounts under 13-
12 37-208(3) and shall make it available to the commissioner on request.

13 (4) Each solicitation for contributions to the joint fundraising committee must include a notice that
14 includes the following information:

15 (a) the name of each participant in the joint fundraising committee;

16 (b) the allocation formula to be used for distributing joint fundraising proceeds;

17 (c) a statement informing contributors that, despite the state allocation formula, they may
18 designate their contributions for particular participants;

19 (d) a statement informing contributors that the allocation formula may change if a contributor
20 makes a contribution that would exceed the amount that a contributor may give to a participant or if a
21 participant is otherwise prohibited from receiving the contribution; and

22 (e) if one or more participants engage in the joint fundraising activity solely to satisfy outstanding
23 debts, a statement informing contributors that the allocation formula may change if a participant receives
24 sufficient funds to pay its outstanding debts.

25 (5) (a) A joint fundraising committee may accept contributions on behalf of its participants under
26 the provisions of the fundraising formula and may make expenditures on behalf of and to its participants under
27 the limitations provided in this section.

28 (b) Except as provided by subsection (8), a joint fundraising committee may not accept a

1 contribution that, when allocated pursuant to the joint fundraising committee's allocation formula in subsection
2 (3), in addition to any other contributions received by the participant from that contributor, would be in excess of
3 the contribution limits of that contributor calculated pursuant to this section. A participant may not accept
4 contributions allocated from the joint fundraising committee that, but for the joint fundraising committee acting
5 as an intermediary, the participant could not otherwise accept.

6 (c) Contributions to the joint fundraising committee may only be deposited in the joint fundraising
7 committee depository.

8 (d) The joint fundraising committee shall report and maintain records concerning contributions as
9 provided by Title 13, chapter 37. The joint fundraising committee shall make its records available to each
10 participant.

11 (e) A participant shall make the participant's contributor records available to the joint fundraising
12 committee to enable the joint fundraising committee to carry out its duty to screen contributions pursuant to
13 subsection (6)(a).

14 (6) (a) The joint fundraising committee shall screen all contributions received to ensure the
15 prohibitions provided in Title 13, chapters 35 and 37, are followed.

16 (b) A corporation or a union prohibited from making a contribution to a candidate under 13-35-
17 227(1) may make a contribution to a joint fundraising committee if one or more participants are not otherwise
18 prohibited from receiving the contribution. A joint fundraising committee may not make an expenditure in
19 contravention of 13-35-227(1), and a participant in a joint fundraising committee prohibited from accepting or
20 receiving a contribution under 13-35-227(1) may not accept or receive such a contribution from a joint
21 fundraising committee.

22 ~~(c) A joint fundraising committee may not make an expenditure in contravention of 13-35-231 if a~~
23 ~~participant is a political party committee.~~

24 ~~(d)~~(c) A joint fundraising committee may not act as an intermediary for contributions or expenditures
25 by any entity, including participants, that is otherwise prohibited under Title 13, chapters 35 and 37.

26 (7) For reporting and limitation purposes:

27 (a) the joint fundraising committee shall report contributions in the reporting period in which they
28 are received and expenditures in the reporting period in which they are made; and

1 (b) the date of receipt of a contribution by a participant is the date that the contribution is disbursed
2 by the joint fundraising committee to the participant. However, the funds must be allocated to the general
3 election or primary election cycle during which the joint fundraising committee received them.

4 (8) (a) Expenditures by the joint fundraising committee must be allocated to each participant in
5 proportion to the formula in the written agreement provided for in subsection (3).

6 (b) If expenditures are made for fundraising costs, a participant may pay more than its
7 proportionate share. However, the amount that is in excess of the participant's proportionate share may not
8 exceed the amount that the participant could legally contribute to the remaining participants. A participant may
9 only pay expenditures on behalf of another participant subject to the limits provided in 13-37-216.

10 (c) If distribution according to the fundraising formula extinguishes the debts of one or more
11 participants and results in a surplus for those participants, or if distribution under the formula results in a
12 violation of the contribution limits under 13-37-216, the joint fundraising committee may reallocate the excess
13 funds. Reallocation must be based on the remaining participants' proportionate shares under the allocation
14 formula. If reallocation results in a violation of a contributor's limit under 13-37-216, the joint fundraising
15 committee shall return the amount of the contribution that exceeds the limit to the contributor. However,
16 contributions that have been designated by a contributor may not be reallocated by the joint fundraising
17 committee without prior written permission of the contributor. If the contributor does not give the contributor's
18 permission for reallocation, the funds must be returned to the contributor.

19 (9) The joint fundraising committee shall allocate total gross contributions received by the joint
20 fundraising committee to the participants. The joint fundraising committee shall inform each participant of the
21 participant's gross contribution total, make the joint fundraising committee's contribution and expenditure
22 records available to each participant, and subject to the limitations provided in 13-37-216, and this section, pay
23 fundraising expenses and distribute each participant's allocated net contributions.

24 (10) An independent committee may not be construed to violate the requirement that it is not
25 controlled directly or indirectly by a candidate or that it may not coordinate with a candidate in connection with
26 the making of expenditures as provided in 13-1-101 solely because:

27 (a) the independent committee participates in a joint fundraising committee; and

28 (b) the joint fundraising committee makes a total gross contribution to a candidate that is in excess

1 of an individual independent committee's limits provided in 13-37-216 but that is not in excess of the remaining
2 combined limit, if any, of all the entities within the joint fundraising committee.

3 (11) The joint fundraising committee is liable for its violations of the provisions of Title 13, chapters
4 35 and 37. In addition, each participant of a joint fundraising committee is severally liable for violations of the
5 provisions of Title 13, chapters 35 and 37, pertaining to the contributions allocated or disbursed to the
6 participant by the joint fundraising committee."

7
8 **NEW SECTION. Section 10. Judicial endorsements lawful.** A judicial candidate may accept
9 endorsements from political parties.

10
11 **NEW SECTION. Section 11. Repealer.** The following sections of the Montana Code Annotated are
12 repealed:

13 13-14-211. Judicial offices separate and independent offices for election purposes.

14 13-14-212. Form of ballot on retention of certain incumbent judicial officers.

15 13-14-213. Form of ballot on retention for other judicial offices.

16 13-35-231. Unlawful for political party to contribute to judicial candidate.

18 **NEW SECTION. Section 12. Codification instruction.** (1) [Section 5] is intended to be codified as
19 an integral part of Title 13, chapter 12, part 2, and the provisions of Title 13, chapter 12, part 2, apply to [section
20 5].

21 (2) [Section 10] is intended to be codified as an integral part of Title 13, chapter 35, part 2, and the
22 provisions of Title 13, chapter 35, part 2, apply to [section 10].

23
24 **NEW SECTION. Section 13. Saving clause.** [This act] does not affect rights and duties that
25 matured, penalties that were incurred, or proceedings that were begun before [the effective date of this act].

26
27 **NEW SECTION. Section 14. Applicability.** [This act] applies to elections for judicial offices occurring
28 on or after [the effective date of this act].
