A BILL FOR AN ACT ENTITLED: "AN ACT REQUIRING PAID SIGNATURE GATHERERS TO DISCLOSE
THEIR STATUS AND TO PROVIDE THEIR STATE OF LEGAL RESIDENCE; AND PROVIDING AN
IMMEDIATE EFFECTIVE DATE."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

NEW SECTION. Section 1. Paid signature gatherers -- disclosure requirements. ~~(1)-A paid~~
~~signature gatherer, as defined in 13-27-112, shall~~ VERBALLY ~~disclose their~~ FIRST NAME, THE STATE IN WHICH THEY
LEGALLY RESIDE, AND THEIR ~~status as a paid signature gatherer verbally and by wearing a badge stating this~~
~~information to anyone the paid signature gatherer approaches about signing a petition~~ TO ANYONE THEY
APPROACH ABOUT SIGNING A PETITION. THE PAID SIGNATURE GATHERER SHALL ALSO WEAR A BADGE STATING THIS
INFORMATION, INCLUDING THEIR FULL FIRST NAME AND LAST INITIAL.

~~(2)——The disclosure provided for in subsection (1) must include the state the paid signature gatherer~~

NEW SECTION. Section 2. Codification instruction. [Section 1] is intended to be codified as an
integral part of Title 13, chapter 27, and the provisions of Title 13, chapter 27, apply to [section 1].

3 APPLICATIONS, THE PART REMAINS IN EFFECT IN ALL VALID APPLICATIONS THAT ARE SEVERABLE FROM THE INVALID
4 APPLICATIONS.
