4 A BILL FOR AN ACT ENTITLED: "AN ACT FOR THE CODIFICATION AND GENERAL REVISION OF THE  
5 LAWS RELATING TO THE DEFINITION FOR THE WORDS SEX, FEMALE, ~~AND MALE~~, MAN, WOMAN,  
6 FATHER, AND MOTHER WHEN REFERRING TO A HUMAN; PROVIDING THAT THE DEFINITION OF SEX  
7 REFERS TO BIOLOGICAL SEX AND NOT GENDER IDENTITY OR SEXUAL INTERCOURSE; PROVIDING  
8 THAT THE DEFINITION OF SEX IS LIMITED TO TWO TYPES OF SEXES WHICH ARE REFERRED TO AS  
9 MALE AND FEMALE; PROVIDING THAT THE DEFINITIONS OF MALE, ~~AND FEMALE~~, MAN, WOMAN,  
10 FATHER, AND MOTHER REFER TO BIOLOGICAL SEX AND NOT SUBJECTIVE GENDER IDENTITY;  
11 CLARIFYING THE MEANING OF THE TERM "GENDER"; AMENDING SECTIONS 2-18-208, 2-18-606, 7-15-  
12 4207, 7-34-2123, 10-2-403, 13-27-408, 13-35-301, 13-38-201, 13-38-203, 13-38-205, 19-2-802, 20-6-808, 20-  
13 7-1306, 20-7-1703, 20-9-327, 20-11-116, 20-25-501, 20-25-707, 22-2-306, 23-2-505, 33-1-201, 35-20-209, 39-

21 WHEREAS, IN HUMAN BEINGS, THERE ARE TWO -- AND ONLY TWO -- SEXES: MALE AND FEMALE, WHICH REFER  
22 TO THE TWO BODY STRUCTURES (PHENOTYPES) THAT, IN NORMAL DEVELOPMENT, CORRESPOND TO ONE OR THE OTHER  
23 GAMETE -- SPERM FOR MALES AND OVA FOR FEMALES; AND

24 WHEREAS, EVERY INDIVIDUAL IS EITHER MALE OR FEMALE; AND

25 WHEREAS, AN INDIVIDUAL'S SEX CAN BE OBSERVED OR CLINICALLY VERIFIED AT OR BEFORE BIRTH; AND

26 WHEREAS, RARE DISORDERS OF SEXUAL DEVELOPMENT ARE NOT EXCEPTIONS TO THE BINARY NATURE OF  
27 SEX; AND

28 WHEREAS, IN NO CASE IS AN INDIVIDUAL'S SEX DETERMINED BY STIPULATION OR SELF-IDENTIFICATION; AND

1           WHEREAS, THERE IS INCREASING CONFUSION ABOUT THE DEFINITION AND IMPLICATIONS OF SEX AS A  
2 BIOLOGICAL TRUTH AND ITS RELATIONSHIP TO CONCEPTS AND TERMS INCLUDING BUT NOT LIMITED TO SEX ASSIGNED AT  
3 BIRTH, GENDER, GENDER IDENTITY, GENDER ROLE, GENDER EXPRESSION, AND EXPERIENCED GENDER; AND

4           WHEREAS, CONFUSION AND AMBIGUITIES SURROUNDING THE DEFINITIONS OF SEX, MALE, FEMALE, AND  
5 RELATED TERMS CAN HINDER INDIVIDUAL EFFORTS TO ENJOY EQUAL TREATMENT UNDER THE LAW; AND

6           WHEREAS, LEGAL EQUALITY OF THE TWO SEXES -- MALE AND FEMALE -- DOES NOT IMPLY THAT THE SEXES  
7 ARE IDENTICAL TO EACH OTHER OR ARE THE SAME IN EVERY RESPECT; AND

8           WHEREAS, WITH RESPECT TO THE TWO SEXES -- MALE AND FEMALE -- SEPARATE FACILITIES OR SPORTS  
9 LEAGUES ESTABLISHED BECAUSE OF OR ORGANIZED ACCORDING TO PHYSICAL DIFFERENCES BETWEEN THE SEXES DO  
10 NOT CONSTITUTE UNEQUAL TREATMENT UNDER THE LAW; AND

11           WHEREAS, PHYSICAL DIFFERENCES BETWEEN MALES AND FEMALES ARE ENDURING, AND THE TWO SEXES ARE  
12 NOT FUNGIBLE.

13           THEREFORE, IT IS THE INTENT OF THE LEGISLATURE OF THIS STATE TO CLARIFY AND RECONCILE THE  
14 MEANING OF SEX, MALE, FEMALE, AND RELATED TERMS IN STATE LAWS, ADMINISTRATIVE RULES, AND GUIDELINES.

15  
16 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

17  
18           NEW SECTION. Section 1. Terms of wide applicability. (1) Unless the context requires otherwise,  
19 the following definitions apply in the Montana Code Annotated:

20           (a)     "FATHER" MEANS A MALE PARENT.

21           (b)     ~~"Female" means a member of the human species who, under normal development, has XX~~  
22 ~~chromosomes and produces or would produce relatively large, relatively immobile gametes, or eggs, during her~~  
23 ~~life cycle and has a reproductive and endocrine system oriented around the production of those gametes. An~~  
24 ~~individual who would otherwise fall within this definition, but for a biological or genetic condition, is female, WHEN~~  
25 USED TO REFER TO A NATURAL PERSON, AN INDIVIDUAL WHO NATURALLY HAS, HAD, WILL HAVE, OR WOULD HAVE, BUT  
26 FOR A CONGENITAL ANOMALY OR INTENTIONAL OR UNINTENTIONAL DISRUPTION, THE REPRODUCTIVE SYSTEM THAT AT  
27 SOME POINT PRODUCES, TRANSPORTS, AND UTILIZES THE LARGE GAMETE, OR OVA, FOR FERTILIZATION.

28           (b)(c)   ~~"Male" means a member of the human species who, under normal development, has XY~~

1 ~~chromosomes and produces or would produce small, mobile gametes, or sperm, during his life cycle and has a~~  
2 ~~reproductive and endocrine system oriented around the production of those gametes. An individual who would~~  
3 ~~otherwise fall within this definition, but for a biological or genetic condition, is male, WHEN USED TO REFER TO A~~  
4 ~~NATURAL PERSON, AN INDIVIDUAL WHO NATURALLY HAS, HAD, WILL HAVE, OR WOULD HAVE, BUT FOR A CONGENITAL~~  
5 ~~ANOMALY OR INTENTIONAL OR UNINTENTIONAL DISRUPTION, THE REPRODUCTIVE SYSTEM THAT AT SOME POINT~~  
6 ~~PRODUCES, TRANSPORTS, AND UTILIZES THE SMALL GAMETE, OR SPERM, FOR FERTILIZATION.~~

7 (e)(D) "MAN" MEANS AN ADULT HUMAN MALE, EXCEPT WHEN USED AS A GENERIC REFERENCE TO HUMAN  
8 BEINGS.

9 (E) "MOTHER" MEANS A FEMALE PARENT.

10 (F) "Oath" includes an affirmation or declaration.

11 (d)(G) "Person" includes a corporation or other entity as well as a natural person.

12 (e)(H) "Several" means two or more.

13 (f)(I) "Sex" means the organization of the body parts and gametes for reproduction in human beings  
14 and other organisms. In human beings, there are exactly two sexes, male and female, with two corresponding  
15 types of gametes. The sexes are determined by the biological and genetic indication of male or female,  
16 including sex chromosomes, naturally occurring sex chromosomes, gonads, and nonambiguous internal and  
17 external genitalia present at birth, without regard to an individual's psychological, behavioral, social, chosen, or  
18 subjective experience of gender WHETHER SOMEONE IS MALE OR FEMALE, WHICH IS DISTINGUISHED BASED ON THE  
19 TYPE OF GAMETE, SPERM OR EGGS, THEY ARE CAPABLE OF OR EXPECTED TO PRODUCE, AS DICTATED BY THEIR PRIMARY  
20 SEXUAL ANATOMY. BECAUSE THERE ARE ONLY TWO TYPES OF GAMETES, SPERM AND OVA, WITH TWO CORRESPONDING  
21 REPRODUCTIVE SYSTEMS, THERE ARE ONLY TWO SEXES: MALE AND FEMALE. AN INDIVIDUAL'S SEX IS ROOTED IN  
22 REPRODUCTIVE ANATOMY AND IS IN NO WAY INFLUENCED OR DEFINED BY ONE'S PSYCHOLOGICAL STATE, BEHAVIOR,  
23 EXPRESSION, OR PERSONAL IDENTITY.

24 (g)(J) "State", when applied to the different parts of the United States, includes the District of  
25 Columbia and the territories.

26 (h)(K) "United States" includes the District of Columbia and the territories.

27 (L) "WOMAN" MEANS AN ADULT HUMAN FEMALE.

28 (2) Wherever the word "man" or "men" or a word that includes the syllable "man" or "men" in

1 combination with other syllables, such as "workman", appears in this code, the word or syllable includes  
2 "woman" or "women" unless the context clearly indicates a contrary intent and unless the subject matter of the  
3 statute relates clearly and necessarily to a specific sex only.

4 (3) Whenever the term "heretofore" occurs in any statute, it must be construed to mean any time  
5 previous to the day the statute takes effect. Whenever the word "hereafter" occurs, it must be construed to  
6 mean the time after the statute containing the term takes effect.

7 (4) (A) THE TERM "GENDER", WHEN USED ALONE TO REFER TO A MALE, FEMALE, OR THE NATURAL  
8 DIFFERENCES BETWEEN A MALE AND FEMALE:

9 (I) MUST BE CONSIDERED A SYNONYM FOR SEX; AND

10 (II) MAY NOT BE CONSIDERED A SYNONYM OR SHORT-HAND EXPRESSION FOR GENDER IDENTITY,  
11 EXPERIENCED GENDER, GENDER EXPRESSION, OR GENDER ROLE.

12 (B) THE TERM "GENDER" DOES NOT APPLY WHEN IT IS USED IN CONJUNCTION WITH OTHER WORDS OR AS  
13 AN ADJECTIVE TO MODIFY OTHER WORDS, OR WHEN CONTEXT OR EXPLICIT DEFINITION IN PREEXISTING STATE LAW,  
14 ADMINISTRATIVE RULES, OR GUIDELINES INDICATES OTHERWISE.

15 (C) THE TERM "GENDER IDENTITY", IF USED IN STATE LAW, ADMINISTRATIVE RULES, OR GUIDELINES, MAY  
16 NOT BE CONSIDERED A SYNONYM OR SUBSTITUTE FOR SEX OR GENDER.

17

18 **Section 2.** Section 2-18-208, MCA, is amended to read:

19 **"2-18-208. Comparable worth.** The department of administration shall, in its continuous efforts to  
20 enhance the current classification plan and pay schedules, work toward the goal of establishing a standard of  
21 equal pay for comparable worth. This standard for the classification plan shall be reached by:

22 (1) eliminating, in the classification of positions, the use of judgments and factors that contain  
23 inherent biases based on sex, as defined in ~~4-1-201~~ [section 1]; and

24 (2) comparing, in the classification of positions, the factors for determining job worth across  
25 occupational groups whenever those groups are dominated by males or females."

26

27 **SECTION 3.** SECTION 2-18-606, MCA, IS AMENDED TO READ:

28 **"2-18-606. Parental leave for state employees.** (1) The department of administration shall develop a

1 parental leave policy for permanent state employees. The policy must permit an employee to take a reasonable  
2 leave of absence and permit the employee to use sick leave immediately following the birth or placement of a  
3 child for a period not to exceed 15 working days if:

- 4 (a) the employee is adopting a child; or
  - 5 (b) the employee is a birth father, as defined in [section 1].
- 6 (2) As used in this section, "placement" means placement for adoption as defined in 33-22-130.
- 7 (3) A state agency that is not subject to the provisions of the Family and Medical Leave Act of  
8 1993, 29 U.S.C. 2601 through 2654, may extend the provisions of that act to the employees of the agency."

9

10 **Section 4.** Section 7-15-4207, MCA, is amended to read:

11 **"7-15-4207. Prohibition against discrimination.** For all of the purposes of this part and part 43, a  
12 person may not be subjected to discrimination because of sex, as defined in ~~4-1-204~~ [section 1], race, creed,  
13 religion, age, physical or mental disability, color, or national origin."

14

15 **Section 5.** Section 7-34-2123, MCA, is amended to read:

16 **"7-34-2123. Admission to district hospital facilities.** Such a hospital district must admit persons to  
17 its facilities without regard to race, color, or sex, as defined in ~~4-1-204~~ [section 1]. Such obligation shall not  
18 prevent the board of trustees of such hospital district from establishing reasonable minimum rates for hospital  
19 quarters, services, and supplies. Indigents needing such services, for the rendition of which provision is made  
20 by the laws of Montana, must be admitted to such public hospitals on terms and rates prescribed or authorized  
21 by law."

22

23 **SECTION 6. SECTION 10-2-403, MCA, IS AMENDED TO READ:**

24 **"10-2-403. Eligibility for residence in home.** To be eligible for residence in a Montana veterans'  
25 home under rules prescribed by the department of public health and human services, a person must be a  
26 veteran or the spouse or surviving spouse of a veteran. Consideration must also be given to:

- 27 (1) the person's age;
- 28 (2) the person's physical and mental status;

- 1 (3) the person's ability or inability to locate suitable alternative accommodations;
- 2 (4) the person's term of residence in Montana;
- 3 (5) the person's gender, as provided in [section 1], as it relates to availability of appropriate living
- 4 space;
- 5 (6) the ability of the Montana veterans' home to meet the person's needs; and
- 6 (7) other admission requirements established by the department."

7

8 **Section 7.** Section 13-27-408, MCA, is amended to read:

9 **"13-27-408. Rejection of improper arguments.** The secretary of state shall reject, with the approval  
10 of the attorney general, an argument or other matter held to contain obscene, vulgar, profane, scandalous,  
11 libelous, or defamatory matter; any language that in any way incites, counsels, promotes, or advocates hatred,  
12 abuse, violence, or hostility toward, or that tends to cast ridicule or shame upon, a group of persons by reason  
13 of race, color, religion, or sex, as defined in ~~4-4-204~~ [section 1]; or any matter not allowed to be sent through  
14 the mail. Such arguments may not be filed or printed in the voter information pamphlet."

15

16 **Section 8.** Section 13-35-301, MCA, is amended to read:

17 **"13-35-301. Adoption of code of fair campaign practices.** The following code of fair campaign  
18 practices is adopted by Montana:

19 "There are basic principles of decency, honesty, and fair play that every candidate for public office in  
20 the United States has a moral obligation to observe and uphold, in order that, after vigorously contested but  
21 fairly conducted campaigns, our citizens may exercise their constitutional right to a free and untrammelled  
22 choice and the will of the people may be fully and clearly expressed on the issues before the country.

23 Therefore:

24 I will conduct my campaign in the best American tradition, discussing the issues as I see them,  
25 presenting my record and policies with sincerity and frankness, and criticizing without fear or favor the record  
26 and policies of my opponent and my opponent's party that merit such criticism.

27 I will defend and uphold the right of every qualified American voter to full and equal participation in the  
28 electoral process.

1 I will conduct my campaign without the use of personal vilification, character defamation, whispering  
2 campaigns, libel, slander, or scurrilous attacks on my opposition or my opposition's personal or family life.

3 I will not use campaign material of any sort that misrepresents, distorts, or otherwise falsifies the facts,  
4 nor will I use malicious or unfounded accusations that aim at creating or exploiting doubts, without justification,  
5 as to the loyalty and patriotism of my opposition.

6 I will not make any appeal to prejudice based on race, sex, as defined in ~~4-1-204~~ [section 1], creed, or  
7 national origin.

8 I will not undertake or condone any dishonest or unethical practice that tends to corrupt or undermine  
9 our American system of free elections or that hampers or prevents the full and free expression of the will of the  
10 voters.

11 Insofar as is possible, I will immediately and publicly repudiate support deriving from any individual or  
12 group that resorts, on behalf of my candidacy or in opposition to that of my opponent, to the methods and  
13 tactics that I have pledged not to use or condone.""

14

15 **Section 9.** Section 13-38-201, MCA, is amended to read:

16 **"13-38-201. Election or appointment of committee representatives at primary -- vacancies -- tie**  
17 **votes.** (1) Each political party shall appoint or elect at each primary election one person of each sex, as defined  
18 in ~~4-1-204~~ [section 1], to serve as committee representatives for each election precinct. The committee  
19 representatives must be residents and registered voters of the precinct.

20 (2) If a political party chooses to appoint precinct committee representatives, the political party  
21 shall make the appointments as provided in the party's rules.

22 (3) If a political party chooses to elect precinct committee representatives, the party may:

23 (a) administer the election itself as provided in the party's rules; or

24 (b) elect precinct committee representatives in a primary election, subject to 13-10-209 and  
25 subsection (4) of this section.

26 (4) In a primary election for a precinct committee representative:

27 (a) if the number of candidates nominated for a party's precinct committee representatives is less  
28 than or equal to the number of positions to be elected, the election administrator may give notice that a party's

1 precinct committee election will not be held in that precinct;

2 (b) if a party precinct committee election is not held pursuant to subsection (4)(a), the election  
3 administrator shall declare elected by acclamation the candidate who filed for the position or who filed a  
4 declaration of intent to be a write-in candidate. The election administrator shall issue a certificate of election to  
5 the designated party.

6 (c) write-in votes for a precinct committee representative may be counted as specified in 13-15-  
7 206(5) only if the individual whose name is written in has filed a declaration of intent as a write-in candidate by  
8 the deadline prescribed in 13-10-211(1);

9 (d) in the case of a tie vote for a precinct committee representative position, the county central  
10 committee shall determine a winner.

11 (5) Pursuant to 13-38-101, a vacancy in a precinct committee representative position must be filled  
12 by the party governing body as provided in its rules."

13

14 **SECTION 10.** SECTION 13-38-203, MCA, IS AMENDED TO READ:

15 **"13-38-203. Powers and duties of county and city central committees -- role of state central**  
16 **committee where no county central committee exists.** (1) The county and city central committee may:

17 (a) make rules for the government of its political party in each county not inconsistent with any of  
18 the provisions of the election laws of this state or the rules of its state political party;

19 (b) elect two county members of the state central committee, one of each gender, as provided in  
20 [section 1], elect the members of the congressional committee, and fill all vacancies and make rules in their  
21 jurisdiction.

22 (2) If there is no county central committee, the state central committee shall appoint a county  
23 central committee.

24 (3) Meetings of a central committee that is filling an election vacancy pursuant to 13-10-326 or 13-  
25 10-327 must be open to the public. Records of a central committee regarding filling a vacancy pursuant to 13-  
26 10-326 or 13-10-327 must be made available for public inspection on request.

27 (4) County and city central committees are not public agencies of the state. The documents of the  
28 county and city central committees are not public records."

**SECTION 11.** SECTION 13-38-205, MCA, IS AMENDED TO READ:

**"13-38-205. Organization and operation of county and city central committees.** (1) The county central committee shall meet prior to the state convention of its political party and organize by electing a presiding officer and one or more vice presiding officers. The gender, as provided in [section 1], of the presiding officer and the vice presiding officer may not be the same. The county central committee shall elect a secretary and other officers as necessary. It is not necessary for the officers to be precinct committee representatives.

(2) The committee may select managing or executive committees and authorize subcommittees to exercise all powers conferred upon the county, city, state, and congressional central committees by the election laws of this state.

(3) The presiding officer of the county central committee shall call the county convention and not less than 4 days before the date of the county convention shall publish the call in a newspaper published at the county seat and mail a copy of the call to each precinct committee representative. If party rules permit the use of a proxy, a proxy may not be recognized unless it is held by an elector of the precinct of the committee representative executing it.

(4) The county presiding officer of the party shall preside at the county convention. No person other than a duly elected or appointed committee representative or officer of the committee is entitled to participate in the proceedings of the committee.

(5) If a committee representative is absent, the convention may fill the vacancy by appointing some qualified elector of the party, resident in the precinct, to represent the precinct in the convention.

(6) The county convention shall elect delegates and alternate delegates to the state convention under rules of the state party. The presiding officer and secretary of the county convention shall issue and sign certificates of election of the delegates."

**SECTION 12.** SECTION 19-2-802, MCA, IS AMENDED TO READ:

**"19-2-802. Effect of no designation of beneficiary or no surviving statutory or designated beneficiary.** (1) If a member or payment recipient fails to name a designated beneficiary or if a statutory or designated beneficiary does not survive the member or payment recipient, the estate of the member or

1 payment recipient is entitled to any accrued lump-sum payment or accrued retirement benefit not received prior  
2 to the member's or payment recipient's death. If the estate, as either a designated beneficiary or as a  
3 beneficiary by default as provided in this subsection, would not be probated but for the amount due to the  
4 estate from the retirement system, all of the amount due to the estate must be paid directly, without probate, to  
5 the surviving next of kin of the deceased or the guardians of the survivor's estate, share and share alike.

6 (2) Payment must be made in the same order in which the following groups are listed:

7 (a) husband or wife;

8 (b) children;

9 (c) father and mother, as defined in [section 1];

10 (d) grandchildren;

11 (e) brothers and sisters; or

12 (f) nieces and nephews.

13 (3) A payment may not be made to a person included in any of the groups listed in subsection (2) if  
14 at the date of payment there is a living person in any of the groups preceding the group of which the person is a  
15 member, as listed. Payment must be made upon receipt from the person of an affidavit, upon a form supplied  
16 by the board, that there are no living individuals in the groups preceding the group of which the person is a  
17 member and that the estate of the deceased will not be probated.

18 (4) The payment must be in full and complete discharge and acquittance of the board and system  
19 on account of the member's or payment recipient's death."

20

21 **SECTION 13.** SECTION 20-6-808, MCA, IS AMENDED TO READ:

22 **"20-6-808. Enrollment.** (1) (a) A public charter school must be open to any student residing in the  
23 state.

24 (b) A school district may not require a student enrolled in the school district to attend a public  
25 charter school.

26 (c) A public charter school may limit admission to students within a given age group or grade level.

27 (d) A public charter school may be organized for a special emphasis, theme, or concept as stated  
28 in the school's proposal.

1 (e) A public charter school shall enroll all students who wish to attend the school unless the  
2 number of students exceeds the capacity of a program, class, grade level, or building.

3 (f) If capacity is insufficient to enroll all students who wish to attend the school, the public charter  
4 school shall select students through a lottery.

5 (2) (a) A public charter school shall give enrollment preference to students who are residents of the  
6 located school district.

7 (b) A public charter school may give enrollment preference to:

8 (i) students who were enrolled in the public charter school the previous school year and to siblings  
9 of students already enrolled in the public charter school. An enrollment preference for returning students  
10 excludes those students from entering a lottery.

11 (ii) children of members of a public charter school's governing board and full-time employees,  
12 limited to no more than 10% of the school's total student population.

13 (3) This section does not preclude the formation of a public charter school for the purpose of  
14 serving students with disabilities, students of the same gender, as provided in [section 1], students who pose a  
15 sufficiently severe disciplinary problem to warrant a specific educational program, or students who are at risk of  
16 academic failure. If capacity is insufficient to enroll all students who wish to attend such a school, the public  
17 charter school shall select students through a lottery.

18 (4) If a student who was previously enrolled in a public charter school enrolls in any other public  
19 school in this state, the student's new school shall accept credits earned by the student in courses or  
20 instructional programs at the public charter school.

21 (5) A school district shall provide or publicize to parents and the general public information about  
22 public charter schools as an enrollment option within the district to the same extent and through the same

9 (k) employment of a person performing services as a newspaper carrier or freelance  
10 correspondent if the person performing the services or a parent or guardian of the person performing the  
11 services in the case of a minor has acknowledged in writing that the person performing the services and the  
12 services are not covered. As used in this subsection (2)(k):

13 (i) "freelance correspondent" means a person who submits articles or photographs for publication  
14 and is paid by the article or by the photograph; and

15 (ii) "newspaper carrier":

16 (A) means a person who provides a newspaper with the service of delivering newspapers singly or  
17 in bundles; and

18 (B) does not include an employee of the paper who, incidentally to the employee's main duties,  
19 carries or delivers papers.

20 (l) cosmetologist's services and barber's services as referred to in 39-51-204(1)(e);

21 (m) a person who is employed by an enrolled tribal member or an association, business,  
22 corporation, or other entity that is at least 51% owned by an enrolled tribal member or members, whose  
23 business is conducted solely within the exterior boundaries of an Indian reservation;

24 (n) employment of a jockey who is performing under a license issued by the board of horseracing  
25 from the time that the jockey reports to the scale room prior to a race through the time that the jockey is  
26 weighed out after a race if the jockey has acknowledged in writing, as a condition of licensing by the board of  
27 horseracing, that the jockey is not covered under the Workers' Compensation Act while performing services as  
28 a jockey;

1 (o) employment of a trainer, assistant trainer, exercise person, or pony person who is performing  
2 services under a license issued by the board of horseracing while on the grounds of a licensed race meet;

3 (p) employment of an employer's spouse for whom an exemption based on marital status may be  
4 claimed by the employer under 26 U.S.C. 7703;

5 (q) a person who performs services as a petroleum land professional. As used in this subsection, a  
6 "petroleum land professional" is a person who:

7 (i) is engaged primarily in negotiating for the acquisition or divestiture of mineral rights or in  
8 negotiating a business agreement for the exploration or development of minerals;

9 (ii) is paid for services that are directly related to the completion of a contracted specific task rather  
10 than on an hourly wage basis; and

11 (iii) performs all services as an independent contractor pursuant to a written contract.

12 (r) an officer of a quasi-public or a private corporation or, except as provided in subsection (3), a  
13 manager of a manager-managed limited liability company who qualifies under one or more of the following  
14 provisions:

15 (i) the officer or manager is not engaged in the ordinary duties of a worker for the corporation or  
16 the limited liability company and does not receive any pay from the corporation or the limited liability company  
17 for performance of the duties;

18 (ii) the officer or manager is engaged primarily in household employment for the corporation or the  
19 limited liability company;

20 (iii) the officer or manager either:

21 (A) owns 10% or more of the number of shares of stock in the corporation or owns 10% or more of  
22 the limited liability company; or

23 (B) owns less than 10% of the number of shares of stock in the corporation or limited liability  
24 company if the officer's or manager's shares when aggregated with the shares owned by a person or persons  
25 listed in subsection (2)(r)(iv) total 10% or more of the number of shares in the corporation or limited liability  
26 company; or

27 (iv) the officer or manager is the spouse, child, adopted child, stepchild, mother as defined in  
28 [section 1], father as defined in [section 1], son-in-law, daughter-in-law, nephew, niece, brother, or sister of a

1 corporate officer who meets the requirements of subsection (2)(r)(iii)(A) or (2)(r)(iii)(B);

2 (s) a person who is an officer or a manager of a ditch company as defined in 27-1-731;

3 (t) service performed by an ordained, commissioned, or licensed minister of a church in the  
4 exercise of the church's ministry or by a member of a religious order in the exercise of duties required by the  
5 order;

6 (u) service performed to provide companionship services, as defined in 29 CFR 552.6, or respite  
7 care for individuals who, because of age or infirmity, are unable to care for themselves when the person  
8 providing the service is employed directly by a family member or an individual who is a legal guardian;

9 (v) employment of a person performing the services of an intrastate or interstate common or  
10 contract motor carrier when hired by an individual or entity who meets the definition of a broker or freight  
11 forwarder, as provided in 49 U.S.C. 13102;

12 (w) employment of a person who is not an employee or worker in this state as defined in 39-71-  
13 118(8);

14 (x) employment of a person who is working under an independent contractor exemption certificate;

15 (y) employment of an athlete by or on a team or sports club engaged in a contact sport. As used in  
16 this subsection, "contact sport" means a sport that includes significant physical contact between the athletes  
17 involved. Contact sports include but are not limited to football, hockey, roller derby, rugby, lacrosse, wrestling,  
18 and boxing.

19 (z) a musician performing under a written contract.

20 (3) (a) (i) A person who regularly and customarily performs services at locations other than the  
21 person's own fixed business location shall elect to be bound personally and individually by the provisions of  
22 compensation plan No. 1, 2, or 3 unless the person has waived the rights and benefits of the Workers'  
23 Compensation Act by obtaining an independent contractor exemption certificate from the department pursuant  
24 to 39-71-417.

25 (ii) Application fees or renewal fees for independent contractor exemption certificates must be  
26 deposited in the state special revenue account established in 39-9-206 and must be used to offset the  
27 certification administration costs.

28 (b) A person who holds an independent contractor exemption certificate may purchase a workers'

1 compensation insurance policy and with the insurer's permission elect coverage for the certificate holder.

2 (c) For the purposes of this subsection (3), "person" means:

3 (i) a sole proprietor;

4 (ii) a working member of a partnership;

5 (iii) a working member of a limited liability partnership;

6 (iv) a working member of a member-managed limited liability company; or

7 (v) a manager of a manager-managed limited liability company that is engaged in the work of the  
8 construction industry as defined in 39-71-116.

9 (4) (a) A corporation or a manager-managed limited liability company shall provide coverage for its  
10 employees under the provisions of compensation plan No. 1, 2, or 3. A quasi-public corporation, a private  
11 corporation, or a manager-managed limited liability company may elect coverage for its corporate officers or  
12 managers, who are otherwise exempt under subsection (2), by giving a written notice in the following manner:

13 (i) if the employer has elected to be bound by the provisions of compensation plan No. 1, by  
14 delivering the notice to the board of directors of the corporation or to the management organization of the  
15 manager-managed limited liability company; or

16 (ii) if the employer has elected to be bound by the provisions of compensation plan No. 2 or 3, by  
17 delivering the notice to the board of directors of the corporation or to the management organization of the  
18 manager-managed limited liability company and to the insurer.

19 (b) If the employer changes plans or insurers, the employer's previous election is not effective and  
20 the employer shall again serve notice to its insurer and to its board of directors or the management organization  
21 of the manager-managed limited liability company if the employer elects to be bound.

22 (5) The appointment or election of an employee as an officer of a corporation, a partner in a  
23 partnership, a partner in a limited liability partnership, or a member in or a manager of a limited liability  
24 company for the purpose of exempting the employee from coverage under this chapter does not entitle the  
25 officer, partner, member, or manager to exemption from coverage.

26 (6) Each employer shall post a sign in the workplace at the locations where notices to employees  
27 are normally posted, informing employees about the employer's current provision of workers' compensation  
28 insurance. A workplace is any location where an employee performs any work-related act in the course of

2 or property of a third person while the employer has access to or control over the place of business or property  
3 for the purpose of carrying on the employer's usual trade, business, or occupation. The sign must be provided  
4 by the department, distributed through insurers or directly by the department, and posted by employers in  
5 accordance with rules adopted by the department. An employer who purposely or knowingly fails to post a sign  
6 as provided in this subsection is subject to a \$50 fine for each citation."

9 **"40-1-107. Form of application, license, marriage certificate, and consent.** (1) The director of the  
10 department of public health and human services shall prescribe the form for an application for a marriage  
11 license, which must include the following information:

12 (a) name, sex, as defined in ~~4-1-201~~ section 1, address, [social security number,] and date and  
13 place of birth of each party to the proposed marriage;

14 (b) if either party was previously married, the party's name and the date, place, and court in which

17 (d) whether the parties are related to each other and, if so, their relationship.

21 department shall keep the number from this source confidential, except that the department may use the

23 (4) The information contained in the marriage license application is subject to the disclosure  
24 restrictions provided in 50-15-122(5). (Bracketed language terminates on occurrence of contingency--sec. 1,  
25 Ch. 27, L. 1999.)"

27 **SECTION 28.** SECTION 40-1-311, MCA, IS AMENDED TO READ:

28 **"40-1-311. Declaration of marriage without solemnization.** (1) Persons may consummate a

1 marriage by written declaration in this state without the solemnization provided for in 40-1-301. The declaration  
2 must be filed by the clerk of the district court in the county where the contract was executed.

3 (2) A declaration of marriage must contain substantially the following:

4 (a) the names, ages, and residences of the parties;

5 (b) the fact of marriage;

6 (c) the name of father and maiden name of mother, as defined in [section 1], of both parties and  
7 address of each;

8 (d) a statement that both parties are legally competent to enter into the marriage contract.

9 (3) The declaration must be subscribed by the parties and attested by at least two witnesses and  
10 formally acknowledged before the clerk of the district court of the county.

11 (4) The fee for filing a declaration is \$53 and must be paid to the clerk at time of filing."

13 **Section 29.** Section 40-1-401, MCA, is amended to read:

14 **"40-1-401. Prohibited marriages -- contracts.** (1) The following marriages are prohibited:

15 (a) a marriage entered into prior to the dissolution of an earlier marriage of one of the parties;

16 (b) a marriage between an ancestor and a descendant or between a brother and a sister, whether  
17 the relationship is by the half or the whole blood, or between first cousins;

18 (c) a marriage between an uncle and a niece or between an aunt and a nephew, whether the  
19 relationship is by the half or the whole blood;

20 (d) a marriage between persons of the same sex, as defined in 4-1-204 [section 1].

21 (2) Parties to a marriage prohibited under this section who cohabit after removal of the impediment  
22 are lawfully married as of the date of the removal of the impediment.

23 (3) Children born of a prohibited marriage are legitimate.

24 (4) A contractual relationship entered into for the purpose of achieving a civil relationship that is  
25 prohibited under subsection (1) is void as against public policy."

27 **SECTION 30.** SECTION 40-5-804, MCA, IS AMENDED TO READ:

28 **"40-5-804. Definitions.** For purposes of this part, the following definitions apply:

1 (1) "Child" means an individual, whether over or under 18 years of age, to whom or on whose  
2 behalf a legal duty of support is owed by a parent. The term includes but is not limited to a child enrolled or  
3 eligible for enrollment under a health benefit plan or individual insurance policy.

4 (2) "Child support guidelines" means guidelines adopted under the provisions of 40-5-209.

5 (3) "COBRA" means the federal Consolidated Omnibus Budget Reconciliation Act of 1985, under  
6 which dependent children of employees may continue to receive, for a limited time under specific  
7 circumstances, health plan coverage after termination of employment.

8 (4) "Department" means the department of public health and human services as provided for in 2-  
9 15-2201.

10 (5) (a) "Health benefit plan" or "plan" means a group health benefit plan or combination of plans  
11 that provides medical care or benefits for a child. The term includes but is not limited to a health maintenance  
12 organization, self-funded group, state or local government group health plan, church group plan, medical or  
13 health service corporation, or similar plan.

14 (b) The term does not include public health coverage if other medical insurance is available to one  
15 or both of the parents at a reasonable cost and is accessible for the child.

16 (6) "Individual insurance" means health or medical insurance coverage other than a group health  
17 benefit plan or public assistance that is or may be provided individually for a child.

18 (7) "Medical care" means diagnosis, cure, mitigation, treatment, or prevention of disease, illness,  
19 or injury, including well baby checkups, periodic examinations, and any other undertaking for the purpose of  
20 affecting any structure or function of the body.

21 (8) "Medical support order" means a judgment, decree, or order, including approval of a settlement  
22 agreement issued by a tribunal of competent jurisdiction, that provides for the medical care of a child and that  
23 complies with the requirements of this part.

24 (9) "Obligated parent" means the parent who is required by a medical support order to provide for  
25 the medical care of a child. The obligated parent is not necessarily the same as an obligor for child support.

26 (10) "Parent" means a father or mother, as defined in [section 1], and includes a child's guardian or  
27 other adult caretaker having lawful charge of the child.

28 (11) "Payor" or "payor of income" means a person, firm, corporation, association, union, employer,

1 trustee, political subdivision, state agency, or any agent thereof who pays income to a parent on a periodic  
2 basis, who has or provides individual insurance or a health benefit plan, and who is subject to the jurisdiction of  
3 this state under Rule 4(b) of the Montana Rules of Civil Procedure or any employer under the Uniform Interstate  
4 Family Support Act.

5 (12) "Plan administrator" means the person or entity, including but not limited to a state or local  
6 government or church, that assesses and collects premiums, accepts and processes claims, and pays benefits.

7 (13) "Primary parent" means the parent with whom the child resides for the most 24-hour periods in  
8 a plan year.

9 (14) "Qualified medical child support order" means an order that meets the requirements of 29  
10 U.S.C. 1169.

11 (15) "Third-party custodian" means an agency or person other than a parent who:

12 (a) is authorized by legal process to have physical custody of a child;

13 (b) has actual physical custody of a child with the written consent of the parent or parents having  
14 legal custody of the child; or

15 (c) has actual physical custody of a child because of the parents' neglect, failure, or inability to  
16 provide for the child's support, medical care, and other needs.

17 (16) "Tribunal" means a court of competent jurisdiction or the department."  
18

19 **Section 31.** Section 40-5-907, MCA, is amended to read:

20 **"40-5-907. Case registry -- abstracts -- information required -- mandatory updating.** (1) There  
21 must be registered in the case registry an abstract of:

22 (a) each case, including interstate cases, receiving IV-D services provided by the department;

23 (b) each support order entered and each modification of an existing support order made in this  
24 state after October 1, 1998; and

25 (c) each subsequent order or action establishing, modifying, adjusting, granting relief from,  
26 terminating, or otherwise affecting a support order in a registered case.

27 (2) Each abstract must include:

28 (a) the name, sex, as defined in 4-4-204 [section 1], [social security number, other] identification

1 numbers, if any, date of birth, driver's license number, telephone number, and residential and mailing  
2 addresses of the parents;

3 (b) the child's name, date of birth, sex, as defined in ~~4-4-204~~ [section 1], [social security number, if  
4 any,] and residential address if different from that of the child's custodian;

5 (c) the name and location of the obligee if the obligee is a person or agency other than the child's  
6 parent;

7 (d) the name, address, and telephone number of the obligor's employer or of another payor of  
8 income to the obligor; and

9 (e) (i) if the child is covered by a health or medical insurance plan and the information is available  
10 in an electronic format, the name of the insurance carrier or health benefit plan, the policy identification number,  
11 the name of the persons covered, and any other pertinent information regarding coverage; or

12 (ii) if the child is not covered, information as to the availability of coverage for the child through the  
13 obligor's and obligee's employers.

14 (3) The abstract of a support order must include:

15 (a) the amount of the support payment and supplemental support payments, if any, for each child  
16 and the amount of spousal maintenance if ordered in the same case;

17 (b) the specific day or dates the payment is due;

18 (c) the inclusive dates of the support obligation;

19 (d) the terms of any condition that may affect the amount of the payment, the due date, or the  
20 obligation to pay support;

21 (e) each subsequent judgment for support arrears and the amounts of any interest, late payment  
22 penalties, and fees included in the judgment;

23 (f) any specific child support lien imposed against real or personal property of the obligor;

24 (g) the terms of any medical and health coverage provision for the child; and

25 (h) the name and county of the judicial district or the name and address of the agency where the  
26 record of the case is located and the cause number or case identification number for the case.

27 (4) (a) For each IV-D case with a support order registered in the case registry, there must be a  
28 record of the date and the amount of support payments made by the obligor, dates and amounts of support

1 collected from other sources, dates of distribution of support payments, names and locations of persons or  
2 agencies to whom support payments and collections were distributed, and the balance of support owed by the  
3 obligor.

4 (b) Except as provided in subsection (5), the department need not maintain payment records in a  
5 non IV-D case.

6 (5) A copy of each non IV-D income-withholding order must be included in the case registry. For  
7 each registered income-withholding order, there must be a record of payments received by the department from  
8 the payor under the income-withholding order, the date and amount of each payment, the date the department  
9 distributed the payment, and the person or agency to whom the payment was distributed.

10 (6) The statistical report required by the department under 50-15-302 may be combined with and  
11 made a part of the abstract of support order form.

12 (7) (a) Each support order entered or modified in this state after October 1, 1998, must include a  
13 requirement that the obligor and obligee update, as necessary, the information included in the abstract under  
14 subsection (2).

15 (b) The order must also provide that in a subsequent child support enforcement action, upon  
16 sufficient showing that diligent effort has been made to ascertain the location of the obligor or obligee, the court  
17 or agency taking the enforcement action may consider the due process requirements for notice and service of  
18 process to be met with respect to the party upon delivery of written notice by regular mail to the most recent  
19 address or employer address reported to the case registry.

20 (c) If the support order does not include the provisions required by subsections (7)(a) and (7)(b) or  
21 if the support order was entered or last modified in this state before October 1, 1998, the department may give  
22 written notice of the provisions to the obligor and obligee. Upon receipt of the notice, the provisions have the  
23 same force and effect on the obligor and obligee as if included in the support order. (Bracketed language  
24 terminates on occurrence of contingency--sec. 1, Ch. 27, L. 1999.)"

26 **Section 32.** Section 40-5-1031, MCA, is amended to read:

27 **"40-5-1031. Pleadings and accompanying documents.** (1) In a proceeding under this part, a  
28 petitioner seeking to establish a support order, to determine parentage of a child, or to register and modify a

1 support order of a tribunal of another state or a foreign country must file a petition. Unless otherwise ordered  
2 under 40-5-1032, the petition or accompanying documents must provide, so far as known, the name, residential  
3 address, and social security numbers of the obligor and the obligee or the parent and alleged parent and the  
4 name, sex, as defined in ~~4-1-204~~ [section 1], residential address, social security number, and date of birth of  
5 each child for whose benefit support is sought or whose parentage is to be determined. Unless filed at the time  
6 of registration, the petition must be accompanied by a copy of any support order known to have been issued by  
7 another tribunal. The petition may include any other information that may assist in locating or identifying the  
8 respondent.

9 (2) The petition must specify the relief sought. The petition and accompanying documents must  
10 conform substantially with the requirements imposed by the forms mandated by federal law for use in cases  
11 filed by a support enforcement agency."

13 **Section 33.** Section 40-6-701, MCA, is amended to read:

14 **"40-6-701. Interference with fundamental parental rights restricted -- cause of action.** (1) A  
15 government entity may not interfere with the fundamental right of parents to direct the upbringing, education,  
16 health care, and mental health of their children unless the government entity demonstrates that the  
17 interference:

- 18 (a) furthers a compelling governmental interest; and  
19 (b) is narrowly tailored and is the least restrictive means available for the furthering of the  
20 compelling governmental interest.

21 (2) All fundamental parental rights are exclusively reserved to the parent of a child without  
22 obstruction or interference by a government entity, including but not limited to the rights and responsibilities to  
23 do the following:

- 24 (a) direct the education of the child, including the right to choose public, private, religious, or home  
25 schools and the right to make reasonable choices with public schools for the education of the child;  
26 (b) access and review all written and electronic education records relating to the child that are  
27 controlled by or in the possession of a school;  
28 (c) direct the upbringing of the child;

- 1 (d) direct the moral or religious training of the child;
- 2 (e) make and consent to all physical and mental health care decisions for the child;
- 3 (f) access and review all health and medical records of the child;
- 4 (g) consent before a biometric scan of the child is made, shared, or stored;
- 5 (h) consent before a record of the child's blood or DNA is created, stored, or shared, unless
- 6 authorized pursuant to a court order;
- 7 (i) consent before a government entity makes an audio or video recording of the child, unless the
- 8 audio or video recording is made during or as part of:
- 9 (i) a court proceeding;
- 10 (ii) a law enforcement investigation;
- 11 (iii) a forensic interview in a criminal or child abuse and neglect investigation;
- 12 (iv) the security or surveillance of buildings grounds, or transportation of students; or
- 13 (v) a photo identification card;
- 14 (j) be notified promptly if an employee of a government entity suspects that abuse, neglect, or a
- 15 criminal offense has been committed against the child unless the parent is suspected to have caused the
- 16 abuse;
- 17 (k) opt the child out of any personal analysis, evaluation, survey, or data collection by a school
- 18 district that would capture data for inclusion in the statewide data system except data that is necessary and
- 19 essential for establishing a student's education record;
- 20 (l) have the child excused from school attendance for religious purposes;
- 21 (m) participate in parent-teacher associations and school organizations that are sanctioned by the
- 22 board of trustees of a school district; and
- 23 (n) be notified promptly if, and provide consent before, the child would share a room or sleeping
- 24 quarters with an individual of the opposite sex on a school-sponsored trip. A child whose parent does not
- 25 provide consent must be permitted to attend the trip and must be provided with reasonable accommodations
- 26 that do not require the child to share a room or sleeping quarters with an individual of the opposite sex. The
- 27 definition of sex as provided in [section 1] must be used to determine the meaning of opposite sex under this
- 28 subsection (2)(n).

1           (3)     Except for law enforcement, an employee of a government entity may not encourage or coerce  
2 a child to withhold information from the child's parent and may not withhold from a child's parent information  
3 that is relevant to the physical, emotional, or mental health of a child.

4           (4)     This section may not be construed as invalidating the provisions of Title 41, chapter 3, or  
5 modifying the burden of proof at any stage of the proceedings under Title 41, chapter 3.

6           (5)     When a parent's fundamental rights protected by 40-6-702, 40-6-707, 41-1-402, 41-1-403, 41-  
7 1-405, and this section are violated, a parent may assert that violation as a claim or defense in an  
8 administrative or judicial proceeding and may obtain appropriate relief without regard to whether the proceeding  
9 is brought by or in the name of a government entity, a private person, or any other party. The prevailing party in  
10 an action filed pursuant to 40-6-702, 40-6-707, 41-1-402, 41-1-403, 41-1-405, and this section is entitled to  
11 reasonable attorney fees and costs.

12           (6)     As used in this section, the following definitions apply:

13           (a)     "Child" means an individual under 18 years of age.

14           (b)     "Education record" means attendance records, test scores of school-administered tests and  
15 statewide assessments, grades, school-sponsored or extracurricular activity or club participation, email  
16 accounts, online or virtual accounts or data, disciplinary records, counseling records, psychological records,  
17 applications for admission, health and immunization information including any medical records maintained by a  
18 health clinic or medical facility operated or controlled by the school district or located on the district property,  
19 teacher and counselor evaluations, and reports of behavioral patterns.

20           (c)     "Government entity" means the state, its political subdivisions, or any department, agency,  
21 commission, board, authority, institution, or office of the state, including a municipality, county, consolidated  
22 municipal-county government, school district, or other special district.

23           (d)     "Parent" means a biological parent of a child, an adoptive parent of a child, or an individual who  
24 has been granted the exclusive right and authority over the welfare of a child under state law.

25           (e)     "Substantial burden" means an action that directly or indirectly constrains, inhibits, curtails, or  
26 denies the right of a parent to direct the upbringing, education, health care, and mental health of the parent's  
27 child. The term includes but is not limited to:

28           (i)     withholding benefits;

- 1 (ii) assessing criminal, civil, or administrative penalties; or
- 2 (iii) exclusion from a government program."

4 **Section 34.** Section 40-6-703, MCA, is amended to read:

5 **"40-6-703. Parental involvement in education.** (1) The board of trustees of a school district, in  
6 consultation with parents, teachers, and administrators, shall develop and adopt a policy to promote the  
7 involvement of parents of children enrolled in the school district, including:

8 (a) a plan for parent participation in the school district, which must be designed to improve parent  
9 and teacher cooperation in homework, attendance, and discipline;

10 (b) a plan to provide parents with information about how to participate in the governance of the

**SECTION 35.** SECTION 41-3-210, MCA, IS AMENDED TO READ:

**"41-3-210. County attorney duties -- certification -- retention of records -- reports to attorney general and legislature -- attorney general report.** (1) (a) The county attorney shall gather all case notes, correspondence, evaluations, interviews, and other investigative materials pertaining to each report from the department or investigation by law enforcement of sexual abuse or sexual exploitation of a child made within the county when the alleged perpetrator of the sexual abuse or sexual exploitation is 12 years of age or older. After a report is made or an investigation is commenced, the following individuals or entities shall provide to the county attorney all case notes, correspondence, evaluations, interviews, and other investigative materials related to the report or investigation:

- (i) the department;
- (ii) state and local law enforcement; and
- (iii) all members of a county or regional interdisciplinary child information and school safety team established under 52-2-211.

(b) The duty to provide records to the county attorney under subsection (1)(a) remains throughout the course of an investigation, an abuse and neglect proceeding conducted pursuant to this part, or the prosecution of a case involving the sexual abuse of a child or sexual exploitation of a child.

(c) Upon receipt of a report from the department, as required in 41-3-202, that includes an allegation of sexual abuse of a child or sexual exploitation of a child, the county attorney shall certify in writing to the person who initially reported the information that the county attorney received the report. The certification must include the date the report was received and the age and gender, as provided in [section 1], of the alleged victim. If the report was anonymous, the county attorney shall provide the certification to the department. If the report was made to the county attorney by a law enforcement officer, the county attorney is not required to provide the certification.

(2) The county attorney shall retain records relating to the report or investigation, including the certification, case notes, correspondence, evaluations, videotapes, and interviews, for 25 years.

(3) On or before January 1 and June 1 of each year, each county attorney shall report to the attorney general. The report to the attorney general must include, for each report from the department or

1 investigation by law enforcement:

2 (a) a unique case identifier;

3 (b) the date that the initial report or allegation was received by the county attorney;

4 (c) the date any charges were filed;

5 (d) the date of any decision to decline to prosecute;

6 (e) if charges are filed against a defendant, whether a conviction was obtained and, if a conviction  
7 was obtained, the sentence imposed by the court; and

8 (f) the number of certifications made as required by subsection (1)(c), including the number of  
9 certifications made to the department.

10 (4) (a) The attorney general shall create a form for county attorneys to use when submitting reports  
11 required by subsection (3). The form must allow collection of the information required by subsection (3) on an  
12 aggregated, cumulative basis for a 5-year period until charges are filed or a decision is made to decline to  
13 prosecute.

14 (b) The information provided by a county attorney on the forms is confidential criminal justice  
15 information as defined in 44-5-103.

16 (5) The attorney general shall report to the law and justice interim committee each year by August  
17 15 and as provided in 5-11-210. The reports must provide:

19 county attorneys, except for those cases pending review of the county attorney or uncharged cases still under  
20 investigation, including data on the total number of cases reported;

23 (d) any action in the past fiscal year that the attorney general took under the authority of 2-15-501  
24 based on the reports submitted as required in subsection (3). A report made pursuant to this subsection (5)(d)

26 (e) after consideration of the information provided by the department pursuant to 41-3-211, any  
27 county attorney who failed to provide a complete report required by subsection (3)."

17           (iii)   a combination of the populations described in subsections (6)(a)(i) and (6)(a)(ii) under

20          (7)     "Cost containment pool" means an account from which funds are allocated by the office of  
21 court administrator under 41-5-132 to a judicial district that exceeds its annual allocation for juvenile out-of-  
22 home placements, programs, and services or to the department for costs incurred under 41-5-1504.

23          (8)     "Cost containment review panel" means the panel established in 41-5-131.

24          (9)     "Court", when used without further qualification, means the youth court of the district court.

25          (10)    "Criminally convicted youth" means a youth who has been convicted in a district court pursuant  
26 to 41-5-206.

27          (11)   (a) "Custodian" means a person, other than a parent or guardian, to whom legal custody of the  
28 youth has been given.

1 (b) The term does not include a person who has only physical custody.

2 (12) "Delinquent youth" means a youth who is adjudicated under formal proceedings under the  
3 Montana Youth Court Act as a youth:

4 (a) who has committed an offense that, if committed by an adult, would constitute a criminal  
5 offense;

6 (b) who has been placed on probation as a delinquent youth and who has violated any condition of  
7 probation; or

8 (c) who has violated the terms and conditions of the youth's conditional release agreement.

9 (13) "Department" means the department of corrections provided for in 2-15-2301.

10 (14) (a) "Department records" means information or data, either in written or electronic form,  
11 maintained by the department pertaining to youth who are committed under 41-5-1513(1)(b).

12 (b) The term does not include information provided by the department to the department of public  
13 health and human services' management information system or information maintained by the youth court  
14 through the office of court administrator.

15 (15) "Detention" means the holding or temporary placement of a youth in the youth's home under  
16 home arrest or in a facility other than the youth's own home for:

17 (a) the purpose of ensuring the continued custody of the youth at any time after the youth is taken  
18 into custody and before final disposition of the youth's case;

19 (b) contempt of court or violation of a valid court order; or

20 (c) violation of the terms and conditions of the youth's conditional release agreement.

21 (16) "Detention facility" means a physically restricting facility designed to prevent a youth from  
22 departing at will. The term includes a youth detention facility, short-term detention center, and regional  
23 detention facility.

24 (17) "Emergency placement" means placement of a youth in a youth care facility for less than 45  
25 days to protect the youth when there is no alternative placement available.

26 (18) "Family" means the parents, guardians, legal custodians, and siblings or other youth with whom  
27 a youth ordinarily lives.

28 (19) "Final disposition" means the implementation of a court order for the disposition or placement

1 of a youth as provided in 41-5-1422, 41-5-1503, 41-5-1504, 41-5-1512, 41-5-1513, and 41-5-1522 through 41-  
2 5-1524.

3 (20) (a) "Formal youth court records" means information or data, either in written or electronic form,  
4 on file with the clerk of district court pertaining to a youth under the jurisdiction of the youth court and includes  
5 petitions, motions, other filed pleadings, court findings, verdicts, orders and decrees, and predispositional  
6 studies.

7 (b) The term does not include information provided by the youth court to the department of public  
8 health and human services' management information system.

9 (21) "Foster home" means a private residence licensed by the department of public health and  
10 human services for placement of a youth.

11 (22) "Guardian" means an adult:

12 (a) who is responsible for a youth and has the reciprocal rights, duties, and responsibilities with the  
13 youth; and

14 (b) whose status is created and defined by law.

15 (23) "Habitual truancy" means recorded unexcused absences of 9 or more days or 54 or more parts  
16 of a day, whichever is less, in 1 school year.

17 (24) (a) "Holdover" means a room, office, building, or other place approved by the board of crime  
18 control for the temporary detention and supervision of youth in a physically unrestricting setting for a period not  
19 to exceed 24 hours while the youth is awaiting a probable cause hearing, release, or transfer to an appropriate  
20 detention or shelter care facility.

21 (b) The term does not include a jail.

22 (25) (a) "Informal youth court records" means information or data, either in written or electronic form,  
23 maintained by youth court probation offices pertaining to a youth under the jurisdiction of the youth court and  
24 includes reports of preliminary inquiries, youth assessment materials, medical records, school records, and  
25 supervision records of probationers.

26 (b) The term does not include information provided by the youth court to the department of public  
27 health and human services' management information system.

28 (26) (a) "Jail" means a facility used for the confinement of adults accused or convicted of criminal

1 offenses. The term includes a lockup or other facility used primarily for the temporary confinement of adults  
2 after arrest.

3 (b) The term does not include a collocated juvenile detention facility that complies with 28 CFR,  
4 part 31.

5 (27) "Judge", when used without further qualification, means the judge of the youth court.

6 (28) "Juvenile home arrest officer" means a court-appointed officer administering or supervising  
7 juveniles in a program for home arrest, as provided for in Title 46, chapter 18, part 10.

8 (29) "Law enforcement records" means information or data, either in written or electronic form,  
9 maintained by a law enforcement agency, as defined in 7-32-201, pertaining to a youth covered by this chapter.

10 (30) (a) "Legal custody" means the legal status created by order of a court of competent jurisdiction  
11 that gives a person the right and duty to:

12 (i) have physical custody of the youth;

13 (ii) determine with whom the youth shall live and for what period;

14 (iii) protect, train, and discipline the youth; and

15 (iv) provide the youth with food, shelter, education, and ordinary medical care.

16 (b) An individual granted legal custody of a youth shall personally exercise the individual's rights  
17 and duties as guardian unless otherwise authorized by the court entering the order.

18 (31) "Necessary parties" includes the youth and the youth's parents, guardian, custodian, or  
19 spouse.

20 (32) (a) "Out-of-home placement" means placement of a youth in a program, facility, or home, other  
21 than a custodial parent's home, for purposes other than preadjudicatory detention.

22 (b) The term does not include shelter care or emergency placement of less than 45 days.

23 (33) (a) "Parent" means the natural or adoptive parent.

24 (b) The term does not include:

25 (i) a person whose parental rights have been judicially terminated; or

26 (ii) the putative father of an illegitimate youth unless the putative father's paternity is established by  
27 an adjudication or by other clear and convincing proof.

28 (34) "Probable cause hearing" means the hearing provided for in 41-5-332.

1           (35) "Regional detention facility" means a youth detention facility established and maintained by two  
2 or more counties, as authorized in 41-5-1804.

3           (36) "Restitution" means payments in cash to the victim or with services to the victim or the general  
4 community when these payments are made pursuant to a consent adjustment, consent decree, or other youth  
5 court order.

6           (37) "Running away from home" means that a youth has been reported to have run away from  
7 home without the consent of a parent or guardian or a custodian having legal custody of the youth.

8           (38) "Secure detention facility" means a public or private facility that:

9           (a) is used for the temporary placement of youth or individuals accused or convicted of criminal  
10 offenses or as a sanction for contempt of court, violation of the terms and conditions of the youth's conditional  
11 release agreement, or violation of a valid court order; and

12           (b) is designed to physically restrict the movements and activities of youth or other individuals held  
13 in lawful custody of the facility.

14           (39) "Serious juvenile offender" means a youth who has committed an offense that would be  
15 considered a felony offense if committed by an adult and that is an offense against a person, an offense against  
16 property, or an offense involving dangerous drugs.

17           (40) "Shelter care" means the temporary substitute care of youth in physically unrestricting facilities.

18           (41) "Shelter care facility" means a facility used for the shelter care of youth. The term is limited to  
19 the facilities enumerated in 41-5-347.

20           (42) "Short-term detention center" means a detention facility licensed by the department for the  
21 temporary placement or care of youth, for a period not to exceed 10 days excluding weekends and legal  
22 holidays, pending a probable cause hearing, release, or transfer of the youth to an appropriate detention facility,  
23 youth assessment center, or shelter care facility.

24           (43) "Substitute care" means full-time care of youth in a residential setting for the purpose of  
25 providing food, shelter, security and safety, guidance, direction, and, if necessary, treatment to youth who are  
26 removed from or are without the care and supervision of their parents or guardians.

27           (44) "Victim" means:

28           (a) a natural person who suffers property, physical, or emotional injury as a result of an offense

1 committed by a youth that would be a criminal offense if committed by an adult;

2 (b) an adult relative of the victim, as defined in subsection (44)(a), if the victim is a minor; and

3 (c) an adult relative of a homicide victim.

4 (45) "Youth" means an individual who is less than 18 years of age without regard to sex, as defined  
5 in ~~4-1-204~~ section 1, or emancipation.

6 (46) "Youth assessment" means a multidisciplinary assessment of a youth as provided in 41-5-  
7 1203.

8 (47) "Youth assessment center" means a staff-secured location that is licensed by the department  
9 of public health and human services to hold a youth for up to 10 days for the purpose of providing an immediate  
10 and comprehensive community-based youth assessment to assist the youth and the youth's family in  
11 addressing the youth's behavior.

12 (48) "Youth care facility" has the meaning provided in 52-2-602.

13 (49) "Youth court" means the court established pursuant to this chapter to hear all proceedings in  
14 which a youth is alleged to be a delinquent youth, a youth in need of intervention, or a youth alleged to have  
15 violated the terms and conditions of the youth's conditional release agreement and includes the youth court  
16 judge, juvenile probation officers, and assessment officers.

17 (50) "Youth detention facility" means a secure detention facility licensed by the department for the  
18 temporary substitute care of youth that is:

19 (a) (i) operated, administered, and staffed separately and independently of a jail; or

20 (ii) a collocated secure detention facility that complies with 28 CFR, part 31; and

21 (b) used exclusively for the lawful detention of alleged or adjudicated delinquent youth or as a  
22 sanction for contempt of court, violation of the terms and conditions of the youth's conditional release  
23 agreement, or violation of a valid court order.

24 (51) "Youth in need of intervention" means a youth who is adjudicated as a youth and who:

25 (a) commits an offense prohibited by law that if committed by an adult would not constitute a  
26 criminal offense, including but not limited to a youth who:

27 (i) violates any Montana municipal or state law regarding alcoholic beverages; or

28 (ii) continues to exhibit behavior, including running away from home or habitual truancy, beyond

1 the control of the youth's parents, foster parents, physical custodian, or guardian despite the attempt of the  
2 youth's parents, foster parents, physical custodian, or guardian to exert all reasonable efforts to mediate,  
3 resolve, or control the youth's behavior; or

4 (b) has committed any of the acts of a delinquent youth but whom the youth court, in its discretion,  
5 chooses to regard as a youth in need of intervention."

7 **Section 37.** Section 42-2-204, MCA, is amended to read:

8 **"42-2-204. Presumed knowledge of pregnancy -- duty to register to be afforded notice --**  
9 **putative and presumed fathers.** (1) A person who engages in sexual relations with a member of the opposite  
10 sex, as defined in ~~4-1-204~~ [section 1], is presumed to know that a pregnancy could result.

11 (2) In addition to any other notice to which the putative father is entitled, a putative father is entitled

21 of justice for staffing services and administrative purposes only.

22 (2) Task force members, including the presiding officer, must be appointed by the attorney general  
23 or a designee of the attorney general. The task force membership must include but is not limited to:

24 (a) an employee of the department of justice who has expertise in the subject of missing persons;

25 (b) a representative from each federally recognized Indian tribe in Montana;

26 (c) a member from the Montana highway patrol;

27 (d) a representative from the attorney general's office; and

28 (e) a representative from the office of public instruction.

1           (3)     While respecting the government-to-government relationship between the state and each tribe,  
2 the primary duties of the task force are to:

3           (a)     identify jurisdictional barriers between federal, state, local, and tribal law enforcement and  
4 community agencies;

5           (b)     work to identify causes that contribute to missing and murdered indigenous persons and make  
6 recommendations to federally recognized tribes in the state to reduce cases of missing and murdered  
7 indigenous persons;

8           (c)     work to identify strategies to improve interagency communication, cooperation, and  
9 collaboration to remove jurisdictional barriers and increase reporting and investigation of missing indigenous  
10 persons; and

11          (d)     administer the looping in native communities network grant program provided for in 44-2-412.

12          (4)     A vacancy on the task force must be filled in the manner of the original appointment.

13          (5)     By July 1 prior to each regular legislative session, the task force shall, in accordance with 5-11-  
14 210, prepare a written report of findings and recommendations for submission to the state-tribal relations  
15 committee provided for in 5-5-229. The report must include the following information:

16          (a)     the number of unique individuals reported to the missing and murdered indigenous persons  
17 database;

18          (b)     the number of unique individuals recovered as a result of the missing and murdered indigenous  
19 persons database;

20          (c)     the number of unique individuals recovered as a result of the looping in native communities  
21 network grant program;

22          (d)     the number of unique individuals searched for and recovered as a result of missing persons  
23 response teams;

24          (e)     the number of missing persons entries into the missing and murdered indigenous persons  
25 database by year;

26          (f)     an analysis by year of the characteristics of missing indigenous persons, including but not  
27 limited to age, gender, as provided in [section 1], child protective services involvement status, foster case  
28 status, duration of time missing, and estimated related cause;

- 1 (g) the number of actively missing indigenous persons by year;
- 2 (h) a description and the results of any noncompetitive grant awardee activities;
- 3 (i) a description of the activities and progress related to improving interagency communication,
- 4 cooperation, and collaboration and removing interjurisdictional barriers; and
- 5 (j) any other information the task force members find relevant to the task force's mission.
- 6 (6) In addition to the recommendations to federally recognized tribes in the state required under
- 7 subsection (3)(b), the task force may make recommendations to federal, state, and local agencies in carrying
- 8 out the task force's duties. (Terminates June 30, 2033--sec. 2, Ch. 624, L. 2023, sec. 3, Ch. 624, L. 2023, sec.
- 9 4, Ch. 624, L. 2023.)"

11 **SECTION 39. SECTION 44-2-412, MCA, IS AMENDED TO READ:**

12 **"44-2-412. (Temporary) Looping in native communities network grant program.** (1) There is a  
13 looping in native communities network grant program. The program is established to create a network in  
14 support of efforts by Montana tribes to identify, report, and find Native American persons who are missing. The  
15 grant program is administered by the missing indigenous persons task force established in 44-2-411.

16 (2) The grant program includes a competitive grant to be awarded to a tribal entity to create and  
17 administer a central administration point for the looping in native communities network. The missing indigenous  
18 persons task force shall develop the application and the criteria to award the grant to a tribal entity. The criteria  
19 must include:

20 (a) policies and standards for technology and equipment, including data storage and security of  
21 information entered into the network;

22 (b) standards for data verification;

23 (c) job qualifications and requirements for a data specialist to administer the network;

24 (d) development of a system to provide automatic initial alerts to law enforcement agencies and  
25 tribal and community organizations when a missing indigenous person report is made, including determining  
26 which law enforcement agencies will receive the automatic initial alert;

27 (e) development of a standard reporting form that includes space to provide the information  
28 specified in subsection (4) to be used by the data specialist; and

1 (f) administrative rights for a designee at each participating tribal agency.

2 (3) The grant program may include additional smaller, noncompetitive grants to be awarded to a  
3 qualifying tribal agency at each reservation that submits a complete application. The purpose of the grants  
4 awarded under this subsection is to provide matching funds for some or all of the costs required for the tribal  
5 agency to set up and maintain access to the looping in native communities network.

6 (4) The standard reporting form required under subsection (2)(e) must allow a data specialist to  
7 enter information about the missing indigenous person, including but not limited to the missing person's:

8 (a) name and any aliases or nicknames;

9 (b) gender, as provided in [section 1], age, height, weight, and other physical descriptive  
10 characteristics;

11 (c) last known location and related information, including the date of last contact with the missing  
12 indigenous person and the person with whom the missing indigenous person last made contact; and

13 (d) photographs, including photographs obtained from an online or social media profile.

16 **Section 40.** Section 45-5-625, MCA, is amended to read:

17 **"45-5-625. Sexual abuse of children.** (1) A person commits the offense of sexual abuse of children if  
18 the person:

19 (a) knowingly employs, uses, or permits the employment or use of a child in an exhibition of sexual  
20 conduct, actual or simulated;

21 (b) knowingly photographs, films, videotapes, develops or duplicates the photographs, films, or  
22 videotapes, or records a child engaging in sexual conduct, actual or simulated;

23 (c) knowingly, by any means of communication, including electronic communication or in person,  
24 persuades, entices, counsels, coerces, encourages, directs, or procures a child under 16 years of age or a  
25 person the offender believes to be a child under 16 years of age to engage in sexual conduct, actual or  
26 simulated, or to view sexually explicit material or acts for the purpose of inducing or persuading a child to  
27 participate in any sexual activity that is illegal;

28 (d) knowingly processes, develops, prints, publishes, transports, distributes, sells, exhibits, or

1 advertises any visual or print medium, including a medium by use of electronic communication in which a child  
2 is engaged in sexual conduct, actual or simulated;

3 (e) knowingly possesses any visual or print medium, including a medium by use of electronic  
4 communication in which a child is engaged in sexual conduct, actual or simulated;

5 (f) finances any of the activities described in subsections (1)(a) through (1)(d) and (1)(g), knowing  
6 that the activity is of the nature described in those subsections;

7 (g) possesses with intent to sell any visual or print medium, including a medium by use of  
8 electronic communication in which a child is engaged in sexual conduct, actual or simulated;

9 (h) knowingly travels within, from, or to this state with the intention of meeting a child under 16  
10 years of age or a person the offender believes to be a child under 16 years of age in order to engage in sexual  
11 conduct, actual or simulated; or

12 (i) knowingly coerces, entices, persuades, arranges for, or facilitates a child under 16 years of age  
13 or a person the offender believes to be a child under 16 years of age to travel within, from, or to this state with  
14 the intention of engaging in sexual conduct, actual or simulated.

15 (2) (a) Except as provided in subsection (2)(b), (2)(c), or (4), a person convicted of the offense of  
16 sexual abuse of children shall be punished by life imprisonment or by imprisonment in the state prison for a  
17 term not to exceed 100 years and may be fined not more than \$10,000.

18 (b) Except as provided in 46-18-219, if the victim is under 16 years of age, a person convicted of  
19 the offense of sexual abuse of children shall be punished by life imprisonment or by imprisonment in the state  
20 prison for a term of not less than 4 years or more than 100 years and may be fined not more than \$10,000.

21 (c) Except as provided in 46-18-219, a person convicted of the offense of sexual abuse of children  
22 for the possession of material, as provided in subsection (1)(e), shall be fined not to exceed \$10,000 or be  
23 imprisoned in the state prison for a term not to exceed 10 years, or both.

24 (3) An offense is not committed under subsections (1)(d) through (1)(g) if the visual or print  
25 medium is processed, developed, printed, published, transported, distributed, sold, possessed, or possessed  
26 with intent to sell, or if the activity is financed, as part of a sexual offender information or treatment course or  
27 program conducted or approved by the department of corrections.

28 (4) (a) If the victim was 12 years of age or younger and the offender was 18 years of age or older

1 at the time of the offense, the offender:

2 (i) shall be punished by imprisonment in a state prison for a term of 100 years. The court may not  
3 suspend execution or defer imposition of the first 25 years of a sentence of imprisonment imposed under this  
4 subsection (4)(a)(i) except as provided in 46-18-222(1) through (5), and during the first 25 years of  
5 imprisonment, the offender is not eligible for parole. The exception provided in 46-18-222(6) does not apply.

6 (ii) may be fined an amount not to exceed \$50,000; and

15 any nature transmitted or created in whole or in part by a wire, radio, electromagnetic, photoelectronic, or  
16 photo-optical system.

17 (b) "Sexual conduct" means:

18 (i) actual or simulated:

19 (A) sexual intercourse, whether between persons of the same or opposite sex, as defined in 4-4-  
20 ~~204~~ [section 1];

21 (B) penetration of the vagina or rectum by any object, except when done as part of a recognized  
22 medical procedure;

23 (C) bestiality;

24 (D) masturbation;

25 (E) sadomasochistic abuse;

26 (F) lewd exhibition of the genitals, breasts, pubic or rectal area, or other intimate parts of any  
27 person; or

28 (G) defecation or urination for the purpose of the sexual stimulation of the viewer; or

1 (ii) depiction of a child in the nude or in a state of partial undress with the purpose to abuse,  
2 humiliate, harass, or degrade the child or to arouse or gratify the person's own sexual response or desire or the  
3 sexual response or desire of any person.

4 (c) "Simulated" means any depicting of the genitals or pubic or rectal area that gives the  
5 appearance of sexual conduct or incipient sexual conduct.

6 (d) "Visual medium" means:

7 (i) any film, photograph, videotape, negative, slide, or photographic reproduction that contains or  
8 incorporates in any manner any film, photograph, videotape, negative, or slide; or

9 (ii) any disk, diskette, or other physical media that allows an image to be displayed on a computer  
10 or other video screen and any image transmitted to a computer or other video screen by telephone line, cable,  
11 satellite transmission, or other method."

12

13 **SECTION 41. SECTION 46-18-101, MCA, IS AMENDED TO READ:**

14 **"46-18-101. Correctional and sentencing policy.** (1) It is the purpose of this section to establish the  
15 correctional and sentencing policy of the state of Montana. Laws for the punishment of crime are drawn to  
16 implement the policy established by this section.

17 (2) The correctional and sentencing policy of the state of Montana is to:

18 (a) punish each offender commensurate with the nature and degree of harm caused by the offense

28 (b) Sentences should be commensurate with the punishment imposed on other persons

1 committing the same offenses.

2 (c) Sentencing practices must be neutral with respect to the offender's race, gender, as provided in  
3 [section 1], religion, national origin, or social or economic status.

4 (d) Sentencing practices must permit judicial discretion to consider aggravating and mitigating  
5 circumstances.

6 (e) Sentencing practices must include punishing violent and serious repeat felony offenders with  
7 incarceration.

8 (f) Sentencing practices must provide alternatives to imprisonment for the punishment of those  
9 nonviolent felony offenders who do not have serious criminal records.

10 (g) Sentencing and correctional practices must emphasize that the offender is responsible for  
11 obeying the law and must hold the offender accountable for the offender's actions.

12 (h) Sentencing practices must emphasize restitution to the victim by the offender. A sentence must  
13 require an offender who is financially able to do so to pay restitution, costs as provided in 46-18-232, costs of  
14 assigned counsel, as provided in 46-8-113, and, if the offender is a sex offender, costs of any chemical  
15 treatment.

16 (i) Sentencing practices should promote and support practices, policies, and programs that focus  
17 on restorative justice principles."

19 **Section 42.** Section 46-19-301, MCA, is amended to read:

20 **"46-19-301. Western Interstate Corrections Compact -- contents.** The Western Interstate  
21 Corrections Compact as contained herein is hereby enacted into law and entered into on behalf of this state  
22 with any and all other states legally joining therein in a form substantially as follows:

23 WESTERN INTERSTATE CORRECTIONS COMPACT

24 ARTICLE I

25 PURPOSE AND POLICY

26 The party states, desiring by common action to improve their institutional facilities and provide  
27 programs of sufficiently high quality for the confinement, treatment, and rehabilitation of various types of  
28 offenders, declare that it is the policy of each of the party states to provide such facilities and programs on the

1 basis of cooperation with one another, thereby serving the best interests of such offenders and of society. The  
2 purpose of this compact is to provide for the development and execution of such programs of cooperation for  
3 the confinement, treatment, and rehabilitation of offenders.

4 ARTICLE II

5 DEFINITIONS

6 As used in this compact, unless the context clearly requires otherwise:

7 (1) "state" means a state of the United States or, subject to the limitation contained in Article VII,  
8 Guam;

9 (2) "sending state" means a state party to this compact in which conviction was had;

10 (3) "receiving state" means a state party to this compact to which an inmate is sent for confinement  
11 other than a state in which conviction was had;

12 (4) "inmate" means a male or female, as defined in ~~4-4-204~~ section 1, offender who is under  
13 sentence to or confined in a prison or other correctional institution;

14 (5) "institution" means any prison, reformatory, or other correctional facility (including but not  
15 limited to a facility for the mentally ill or mentally defective) in which inmates may lawfully be confined.

16 ARTICLE III

17 CONTRACTS

18 (1) Each party state may make one or more contracts with any one or more of the other party  
19 states for the confinement of inmates on behalf of a sending state in institutions situated within receiving states.

20 Any such contract shall provide for:

21 (a) its duration;

22 (b) payments to be made to the receiving state by the sending state for inmate maintenance,  
23 extraordinary medical and dental expenses, and any participation in or receipt by inmates of rehabilitative or  
24 correctional services, facilities, programs, or treatment not reasonably included as part of normal maintenance;

25 (c) participation in programs of inmate employment, if any; the disposition or crediting of any  
26 payments received by inmates on account thereof; and the crediting of proceeds from or disposal of any  
27 products resulting therefrom;

28 (d) delivery and retaking of inmates;

1 (e) such other matters as may be necessary and appropriate to fix the obligations, responsibilities,  
2 and rights of the sending and receiving states.

3 (2) Prior to the construction or completion of construction of any institution or addition thereto by a  
4 party state, any other party state or states may contract therewith for the enlargement of the planned capacity  
5 of the institution or addition thereto, or for the inclusion therein of particular equipment or structures, and for the  
6 reservation of a specific percent of the capacity of the institution to be kept available for use by inmates of the  
7 sending state or states so contracting. Any sending state so contracting may, to the extent that moneys are  
8 legally available therefor, pay to the receiving state a reasonable sum as consideration for such enlargement of  
9 capacity or provision of equipment or structures and reservation of capacity. Such payment may be in a lump  
10 sum or in installments as provided in the contract.

11 (3) The terms and provisions of this compact shall be a part of any contract entered into by the  
12 authority of or pursuant thereto, and nothing in any such contract shall be inconsistent therewith.

13 ARTICLE IV

14 PROCEDURES AND RIGHTS

15 (1) Whenever the duly constituted judicial or administrative authorities in a state party to this  
16 compact, and which has entered into a contract pursuant to Article III, shall decide that confinement in or  
17 transfer of an inmate to an institution within the territory of another party state is necessary in order to provide  
18 adequate quarters and care or desirable in order to provide an appropriate program of rehabilitation or  
19 treatment, said officials may direct that the confinement be within an institution within the territory of said other  
20 party state, the receiving state to act in that regard solely as agent for the sending state.

21 (2) The appropriate officials of any state party to this compact shall have access at all reasonable  
22 times to any institution in which it has a contractual right to confine inmates for the purpose of inspecting the  
23 facilities thereof and visiting such of its inmates as may be confined in the institution.

24 (3) Inmates confined in an institution pursuant to the terms of this compact shall at all times be  
25 subject to the jurisdiction of the sending state and may at any time be removed therefrom for transfer to a  
26 prison or other institution within the sending state, for transfer to another institution in which the sending state  
27 may have a contractual or other right to confine inmates, for release on probation or parole, for discharge, or for  
28 any other purpose permitted by the laws of the sending state; provided that the sending state shall continue to

1 be obligated to such payments as may be required pursuant to the terms of any contract entered into under the  
2 terms of Article III.

3 (4) Each receiving state shall provide regular reports to each sending state on the inmates of that  
4 sending state in institutions pursuant to this compact including a conduct record of each inmate and certify said  
5 record to the official designated by the sending state in order that each inmate may have the benefit of the  
6 inmate's record in determining and altering the disposition of said inmate in accordance with the law which may  
7 obtain in the sending state and in order that the same may be a source of information for the sending state.

8 (5) All inmates who may be confined in an institution pursuant to the provisions of this compact  
9 shall be treated in a reasonable and humane manner and shall be cared for and treated equally with such  
10 similar inmates of the receiving state as may be confined in the same institution. The fact of confinement in a  
11 receiving state shall not deprive any inmate so confined of any legal rights which said inmate would have had if  
12 confined in an appropriate institution of the sending state.

13 (6) Any hearing or hearings to which an inmate confined pursuant to this compact may be entitled  
14 by the laws of the sending state may be had before the appropriate authorities of the sending state or of the  
15 receiving state if authorized by the sending state. The receiving state shall provide adequate facilities for such  
16 hearings as may be conducted by the appropriate officials of a sending state. In the event such hearing or  
17 hearings are had before officials of the receiving state, the governing law shall be that of the sending state and  
18 a record of the hearing or hearings as prescribed by the sending state shall be made. Said record together with  
19 any recommendations of the hearing officials shall be transmitted forthwith to the official or officials before  
20 whom the hearing would have been had if it had taken place in the sending state. In any and all proceedings  
21 had pursuant to the provisions of this subdivision, the officials of the receiving state shall act solely as agents of  
22 the sending state and no final determination shall be made in any matter except by the appropriate officials of  
23 the sending state. Costs of records made pursuant to this subsection shall be borne by the sending state.

24 (7) Any inmate confined pursuant to this compact shall be released within the territory of the  
25 sending state unless the inmate and the sending and receiving states shall agree upon release in some other  
26 place. The sending state shall bear the cost of such return to its territory.

27 (8) Any inmate confined pursuant to the terms of this compact shall have any and all rights to  
28 participate in and derive any benefits, incur or be relieved of any obligations, or have such obligations modified

1 or the inmate's status changed on account of any action or proceeding in which the inmate could have  
2 participated if confined in any appropriate institution of the sending state located within such state.

3 (9) The parent, guardian, trustee, or other person or persons entitled under the laws of the sending  
4 state to act for, advise, or otherwise function with respect to any inmate shall not be deprived of or restricted in  
5 the person's exercise of any power in respect of any inmate confined pursuant to the terms of this compact.

6 ARTICLE V

7 ACTS NOT REVIEWABLE IN RECEIVING STATE -- EXTRADITION

8 (1) Any decision of the sending state in respect of any matter over which it retains jurisdiction  
9 pursuant to this compact shall be conclusive upon and not reviewable within the receiving state, but if at the  
10 time the sending state seeks to remove an inmate from an institution in the receiving state there is pending  
11 against the inmate within such state any criminal charge or if the inmate is suspected of having committed  
12 within such state a criminal offense, the inmate shall not be returned without the consent of the receiving state  
13 until discharged from prosecution or other form of proceeding, imprisonment, or detention for such offense. The  
14 duly accredited officers of the sending state shall be permitted to transport inmates pursuant to this compact  
15 through any and all states party to this compact without interference.

16 (2) An inmate who escapes from an institution in which the inmate is confined pursuant to this  
17 compact shall be deemed a fugitive from the sending state and from the state in which the institution is situated.  
18 In the case of an escape to a jurisdiction other than the sending or receiving state, the responsibility for  
19 institution of extradition proceedings shall be that of the sending state, but nothing contained herein shall be  
20 construed to prevent or affect the activities of officers and agencies of any jurisdiction directed toward the  
21 apprehension and return of an escapee.

22 ARTICLE VI

23 FEDERAL AID

24 Any state party to this compact may accept federal aid for use in connection with any institution or  
25 program, the use of which is or may be affected by this compact or any contract pursuant hereto, and any  
26 inmate in a receiving state pursuant to this compact may participate in any such federally aided program or  
27 activity for which the sending and receiving states have made contractual provision, provided that, if such  
28 program or activity is not part of the customary correctional regimen, the express consent of the appropriate

1 official of the sending state shall be required therefor.

2 ARTICLE VII

3 ENTRY INTO FORCE

4 This compact shall enter into force and become effective and binding upon the states so acting when it  
5 has been enacted into law by any two contiguous states from among the states of Alaska, Arizona, California,  
6 Colorado, Hawaii, Idaho, Montana, Nebraska, Nevada, New Mexico, Oregon, Utah, Washington, and Wyoming.  
7 For the purposes of this article, Alaska and Hawaii shall be deemed contiguous to each other; to any and all of  
8 the states of California, Oregon, and Washington; and to Guam. Thereafter, this compact shall enter into force  
9 and become effective and binding as to any other of said states or any other state contiguous to at least one  
10 party state upon similar action by such state. Guam may become party to this compact by taking action similar  
11 to that provided for joinder by any other eligible party state and upon the consent of congress to such joinder.  
12 For the purposes of this article, Guam shall be deemed contiguous to Alaska, Hawaii, California, Oregon, and  
13 Washington.

14 ARTICLE VIII

15 WITHDRAWAL AND TERMINATION

16 This compact shall continue in force and remain binding upon a party state until it shall have enacted a  
17 statute repealing the same and providing for the sending of formal written notice of withdrawal from the  
18 compact to the appropriate officials of all other party states. An actual withdrawal shall not take effect until 2  
19 years after the notices provided in said statute have been sent. Such withdrawal shall not relieve the  
20 withdrawing state from its obligations assumed hereunder prior to the effective date of withdrawal. Before the  
21 effective date of withdrawal, a withdrawing state shall remove to its territory, at its own expense, such inmates  
22 as it may have confined pursuant to the provisions of this compact.

23 ARTICLE IX

24 OTHER ARRANGEMENTS UNAFFECTED

25 Nothing contained in this compact shall be construed to abrogate or impair any agreement or other  
26 arrangement which a party state may have with a nonparty state for the confinement, rehabilitation, or  
27 treatment of inmates or to repeal any other laws of a party state authorizing the making of cooperative  
28 institutional arrangements.

1 ARTICLE X

2 CONSTRUCTION AND SEVERABILITY

3 The provisions of this compact shall be liberally construed and shall be severable. If any phrase,  
4 clause, sentence, or provision of this compact is declared to be contrary to the constitution of any participating  
5 state or of the United States or the applicability thereof to any government, agency, person, or circumstance is  
6 held invalid, the validity of the remainder of this compact and the applicability thereof to any government,  
7 agency, person, or circumstance shall not be affected thereby. If this compact shall be held contrary to the  
8 constitution of any state participating therein, the compact shall remain in full force and effect as to the  
9 remaining states and in full force and effect as to the state affected as to all severable matters."

21 (a) Any decision of the sending state in respect of any matter over which it retains jurisdiction  
22 pursuant to this compact shall be conclusive upon and not reviewable within the receiving state, but if at the  
23 time the sending state seeks to remove an inmate from an institution in the receiving state there is pending  
24 against the inmate within such state any criminal charge or if the inmate is formally accused of having  
25 committed within such state a criminal offense, the inmate shall not be returned without the consent of the  
26 receiving state until discharged from prosecution or other form of proceeding, imprisonment or detention for  
27 such offense. The duly accredited officers of the sending state shall be permitted to transport inmates pursuant  
28 to this compact through any and all states party to this compact without interference.

12 clothing. Except when a particular kind of clothing is required because of a particular condition, residents must  
13 have the opportunity to select from various types of neat, clean, and seasonable clothing. The clothing must be  
14 considered the resident's throughout the resident's stay in the facility. Clothing, both in amount and type, must  
15 make it possible for residents to go out of doors in inclement weather, to go for trips or visits appropriately  
16 dressed, and to make a normal appearance in the community. The facility shall make provision for the  
17 adequate and regular laundering of the residents' clothing.

18 (7) Each resident has the right to keep and use the resident's own personal possessions except  
19 insofar as the clothes or personal possessions may be determined by the individual treatment planning team or  
20 the qualified intellectual disability professional to be dangerous either to the resident or to others.

1 (c) the physical facilities must meet all fire and safety standards established by the state and  
2 locality. In addition, the facility must meet the provisions of the life safety code of the national fire protection  
3 association that are applicable to it.

4 (d) there must be special facilities for nonambulatory residents to ensure their safety and comfort,  
5 including special fittings on toilets and wheelchairs. Appropriate provision must be made to permit  
6 nonambulatory residents to communicate their needs to staff.

7 (9) Residents have a right to receive prompt and adequate medical treatment for any physical or  
8 mental ailments or injuries or physical disabilities and for the prevention of any illness or disability. The medical  
9 treatment must meet standards of medical practice in the community. However, nothing in this subsection may  
10 be interpreted to impair other rights of a resident in regard to involuntary commitment for mental illness, use of  
11 psychotropic medication, use of hazardous, aversive, or experimental procedures, or the refusal of treatment.

12 (10) Corporal punishment is not permitted.

13 (11) The opportunity for religious worship must be accorded to each resident who desires worship.  
14 Provisions for religious worship must be made available to all residents on a nondiscriminatory basis. An  
15 individual may not be compelled to engage in any religious activities.

16 (12) Residents have a right to a nourishing, well-balanced diet. The diet for residents must provide  
17 at a minimum the recommended daily dietary allowance as developed by the national academy of sciences.  
18 Provisions must be made for special therapeutic diets and for substitutes at the request of the resident, the  
19 resident's parents, guardian, or next of kin, or the responsible person appointed by the court in accordance with  
20 the religious requirements of any resident's faith. Denial of a nutritionally adequate diet may not be used as  
21 punishment.

22 (13) Residents have a right to regular physical exercise several times a week. It is the duty of the  
23 facility to provide both indoor and outdoor facilities and equipment for exercise. Residents have a right to be  
24 outdoors daily in the absence of contrary medical considerations.

25 (14) Residents have a right, under appropriate supervision, to suitable opportunities for the  
26 interaction with members of the opposite sex, as defined in 4-1-204 [section 1], except when the individual  
27 treatment planning team or the qualified intellectual disability professional responsible for the formulation of a  
28 particular resident's habilitation plan writes an order to the contrary and explains the reasons for the order. The

1 order must be renewed monthly if the restriction is to be continued."

2

3 **Section 56.** Section 53-21-121, MCA, is amended to read:

4 **"53-21-121. Petition for commitment -- contents of -- notice of.** (1) The county attorney, upon the  
5 written request of any person having direct knowledge of the facts, may file a petition with the court alleging that  
6 there is a person within the county who is suffering from a mental disorder and who requires commitment  
7 pursuant to this chapter.

8 (2) The petition must contain:

9 (a) the name and address of the person requesting the petition and the person's interest in the  
10 case;

11 (b) the name of the respondent and, if known, the address, age, sex, as defined in ~~1-1-201~~  
12 [section 1], marital status, and occupation of the respondent;

13 (c) the purported facts supporting the allegation of mental disorder, including a report by a mental  
14 health professional if any, a statement of the disposition sought pursuant to 53-21-127, and the need for  
15 commitment;

16 (d) the name and address of every person known or believed to be legally responsible for the care,  
17 support, and maintenance of the respondent for whom evaluation is sought;

18 (e) the name and address of the respondent's next of kin to the extent known to the county  
19 attorney and the person requesting the petition;

20 (f) the name and address of any person whom the county attorney believes might be willing and  
21 able to be appointed as friend of respondent;

22 (g) the name, address, and telephone number of the attorney, if any, who has most recently  
23 represented the respondent for whom evaluation is sought; if there is no attorney, there must be a statement as  
24 to whether to the best knowledge of the person requesting the petition the respondent for whom evaluation is  
25 sought is indigent and unable to afford the services of an attorney;

26 (h) a statement of the rights of the respondent, which must be in conspicuous print and identified  
27 by a suitable heading; and

28 (i) the name and address of the mental health facility to which it is proposed that the respondent

1 may be committed, if known.

2 (3) Notice of the petition must be hand-delivered to the respondent and to the respondent's  
3 counsel on or before the initial appearance of the respondent before the judge or justice of the peace. The  
4 respondent's counsel shall meet with the respondent, explain the substance of the petition, and explain the  
5 probable course of the proceedings. Notice of the petition and the order setting the date and time of the hearing  
6 and the names of the respondent's counsel, professional person, and friend of respondent must be hand-  
7 delivered, mailed, or sent by a facsimile transmission to the person or persons legally responsible for care,  
8 support, and maintenance of the respondent, the next of kin identified in the petition, any other person identified  
9 by the county attorney as a possible friend of respondent other than the one named as the friend of respondent,  
10 the director of the department or the director's designee, and the mental health facility to which the respondent  
11 may be committed, if known. The notice may provide, other than as to the respondent and the respondent's  
12 counsel, that no further notice will be given unless written request is filed with the clerk of court."  
13

14 **Section 57.** Section 53-21-142, MCA, is amended to read:

15 **"53-21-142. Rights of persons admitted to facility.** Patients admitted to a mental health facility,  
16 whether voluntarily or involuntarily, have the following rights:

17 (1) Patients have a right to privacy and dignity.

18 (2) Patients have a right to the least restrictive conditions necessary to achieve the purposes of  
19 commitment. Patients must be accorded the right to appropriate treatment and related services in a setting and  
20 under conditions that:

21 (a) are the most supportive of the patient's personal liberty; and

22 (b) restrict the patient's liberty only to the extent necessary and consistent with the patient's  
23 treatment need, applicable requirements of law, and judicial orders.

24 (3) Patients have rights to visitation and reasonable access to telephone communications,  
25 including the right to converse with others privately, except to the extent that the professional person  
26 responsible for formulation of a particular patient's treatment plan writes an order imposing special restrictions.  
27 The written order must be renewed after each periodic review of the treatment plan if any restrictions are to be  
28 continued. Patients have an unrestricted right to visitation with attorneys, with spiritual counselors, and with

1 private physicians and other professional persons.

2 (4) Patients have an unrestricted right to send sealed mail. Patients have an unrestricted right to  
3 receive sealed mail from their attorneys, private physicians and other professional persons, the mental  
4 disabilities board of visitors, courts, and government officials. Patients have a right to receive sealed mail from  
5 others except to the extent that a professional person responsible for formulation of a particular patient's  
6 treatment plan writes an order imposing special restrictions on receipt of sealed mail. The written order must be  
7 renewed after each periodic review of the treatment plan if any restrictions are to be continued.

8 (5) Patients have an unrestricted right to have access to letter-writing materials, including postage,  
9 and have a right to have staff members of the facility assist persons who are unable to write, prepare, and mail  
10 correspondence.

11 (6) Patients have a right to wear their own clothes and to keep and use their own personal  
12 possessions, including toilet articles, except to the extent that clothes or personal possessions may be  
13 determined by a professional person in charge of the patient's treatment plan to be dangerous or otherwise  
14 inappropriate to the treatment regimen. The facility has an obligation to supply an adequate allowance of  
15 clothing to any patients who do not have suitable clothing of their own. Patients must have the opportunity to  
16 select from various types of neat, clean, and seasonable clothing. The clothing must be considered the patient's  
17 throughout the patient's stay at the facility. The facility shall make provision for the laundering of patient  
18 clothing.

19 (7) Patients have the right to keep and be allowed to spend a reasonable sum of their own money.

20 (8) Patients have the right to religious worship. Provisions for worship must be made available to  
21 all patients on a nondiscriminatory basis. An individual may not be required to engage in any religious activities.

22 (9) Patients have a right to regular physical exercise several times a week. The facility shall  
23 provide facilities and equipment for physical exercise. Patients have a right to be outdoors at regular and  
24 frequent intervals in the absence of contrary medical considerations.

25 (10) Patients have the right to be provided, with adequate supervision, suitable opportunities for  
26 interaction with members of the opposite sex, as defined in 4-1-204 [section 1], except to the extent that a  
27 professional person in charge of the patient's treatment plan writes an order stating that the interaction is  
28 inappropriate to the treatment regimen.

1           (11)    Patients have a right to receive prompt and adequate medical treatment for any physical  
2 ailments. In providing medical care, the mental health facility shall take advantage of whatever community-  
3 based facilities are appropriate and available and shall coordinate the patient's treatment for mental illness with  
4 the patient's medical treatment.

5           (12)    Patients have a right to a diet that will provide at a minimum the recommended daily dietary  
6 allowances as developed by the national academy of sciences. Provisions must be made for special  
7 therapeutic diets and for substitutes at the request of the patient or the friend of respondent in accordance with  
8 the religious requirements of any patient's faith. Denial of a nutritionally adequate diet may not be used as  
9 punishment.

10          (13)    Patients have a right to a humane psychological and physical environment within the mental  
11 health facilities. These facilities must be designed to afford patients with comfort and safety, promote dignity,  
12 and ensure privacy. The facilities must be designed to make a positive contribution to the efficient attainment of  
13 the treatment goals set for the patient. In order to ensure the accomplishment of this goal:

14           (a)    regular housekeeping and maintenance procedures that will ensure that the facility is  
15 maintained in a safe, clean, and attractive condition must be developed and implemented;

16           (b)    there must be special provision made for geriatric and other nonambulatory patients to ensure  
17 their safety and comfort, including special fittings on toilets and wheelchairs. Appropriate provision must be  
18 made to permit nonambulatory patients to communicate their needs to the facility staff.

19           (c)    pursuant to an established routine maintenance and repair program, the physical plant of each  
20 facility must be kept in a continuous state of good repair and operation in accordance with the needs of the  
21 health, comfort, safety, and well-being of the patients;

22           (d)    each facility must meet all fire and safety standards established by the state and locality. In  
23 addition, any hospital must meet the provisions of the life safety code of the national fire protection association  
24 that are applicable to hospitals. A hospital must meet all standards established by the state for general  
25 hospitals to the extent that they are relevant to psychiatric facilities.

26          (14)    A patient at a facility has the right:

27           (a)    to be informed of the rights described in this section at the time of admission and periodically  
28 after admission in language and terms appropriate to the patient's condition and ability to understand;

1 (b) to assert grievances with respect to infringement of the rights described in this section,  
2 including the right to have a grievance considered in a fair and timely manner according to an impartial  
3 grievance procedure that must be provided for by the facility; and

4 (c) to exercise the rights described in this section without reprisal and may not be denied  
5 admission to the facility as reprisal for the exercise of the rights described in this section.

6 (15) In order to assist a person admitted to a program or facility in the exercise or protection of the  
7 patient's rights, the patient's attorney, advocate, or legal representatives must be given reasonable access to:

8 (a) the patient;

9 (b) the program or facility areas where the patient has received treatment or has resided or the  
10 areas to which the patient has had access; and

11 (c) pursuant to the written authorization of the patient, records and information pertaining to the  
12 patient's diagnosis, treatment, and related services.

13 (16) A person admitted to a facility must be given access to any available individual or service that  
14 provides advocacy for the protection of the person's rights and that assists the person in understanding,  
15 exercising, and protecting the person's rights as described in this section.

16 (17) This section may not:

17 (a) obligate a professional person to administer treatment contrary to the professional's clinical  
18 judgment;

19 (b) prevent a facility from discharging a patient for whom appropriate treatment, consistent with the  
20 clinical judgment of a professional person responsible for the patient's treatment, is or has become impossible  
21 to administer because of the patient's refusal to consent to the treatment;

22 (c) require a facility to admit a person who has, on prior occasions, repeatedly withheld consent to  
23 appropriate treatment; or

24 (d) obligate a facility to treat a person admitted to the facility solely for diagnostic evaluation."  
25

26 **Section 58.** Section 53-24-310, MCA, is amended to read:

27 **"53-24-310. Definitions.** As used in 53-24-310 through 53-24-314, unless the context clearly  
28 indicates otherwise, the following definitions apply:

1 (1) "Alcohol and drug prevention or treatment facility" means a recovery residence, hospital, health  
2 or counseling center, or other entity providing alcohol and drug services.

3 (2) "Alcohol and drug services" includes evaluation, treatment, residential personal care,  
4 habilitation, rehabilitation, counseling, or supervision of persons with substance use disorders or services to  
5 persons designed to prevent substance use disorders that either receive funds from the department of public  
6 health and human services or assess fees for services provided.

7 (3) "Certified recovery residence" means a recovery residence, as defined in subsection (9), that  
8 has received certification or another form of approval from a certifying organization, as defined in subsection  
9 (4).

10 (4) "Certifying organization" means a recovery residence standards organization or an affiliate of a  
11 recovery residence standards organization that operates in the state of Montana and is recognized by the  
12 department of public health and human services.

13 (5) "Informed consent" means voluntary consent by an individual to a placement in a certified  
14 recovery residence only after full disclosure by a judge, justice of the peace, or magistrate of the following  
15 information:

16 (a) any limitations or prohibitions against narcotic medication associated with the certified recovery  
17 residence; and

18 (b) whether United States food and drug administration-approved medication-assisted treatment of  
19 substance use disorders, including the use of buprenorphine and suboxone, is limited or prohibited.

20 (6) "Levels of care" means the continuum of support ranging from nonclinical recovery residences  
21 to licensed clinical treatment.

22 (7) "Minor" means an individual under 18 years of age without regard to sex, as defined in [section  
23 1].

24 (8) "Qualified health care provider" means a person licensed as a physician, psychologist, social  
25 worker, clinical professional counselor, marriage and family therapist, addiction counselor, or another  
26 appropriate licensed health care practitioner.

27 (9) "Recovery residence" means a sober living home with a safe, family-like environment that  
28 promotes recovery from substance use disorders through services including but not limited to peer support,

1 mutual support groups, and recovery services.

2 (10) "Sober" means free of alcohol and drugs, except for prescription medications taken as directed  
3 by a licensed prescriber, including medications approved by the United States food and drug administration for  
4 the treatment of opioid use disorder.

5 (11) (a) "Substance use disorder" means the use of any chemical substance, legal or illegal, that  
6 creates behavioral or health problems, or both, resulting in operational impairment.

7 (b) This term includes alcoholism, drug dependency, or both, that endanger the health,  
8 interpersonal relationships, or economic functions of an individual or the public health, safety, or welfare."

10 **SECTION 59.** SECTION 53-30-312, MCA, IS AMENDED TO READ:

11 **"53-30-312. Creation of community corrections boards -- membership -- appointment -- terms --**

12 **compensation.** (1) A unit of local government, the governing bodies of two or more units of local government,

27 **"60-5-514. Business eligibility -- criteria -- restrictions.** (1) To be eligible for placement of a

28 business sign on a specific information sign panel, a business establishment shall meet standards for "GAS",

1 "FOOD", "LODGING", and "CAMPING" services in rules adopted by the department pursuant to guidelines in  
2 the Manual on Uniform Traffic Control Devices, as amended.

3 (2) (a) Each business identified on a specific information sign shall provide assurance of its  
4 conformity with all applicable laws concerning the provision of public accommodations without regard to race,  
5 color, sex, as defined in ~~4-4-204~~ [section 1], culture, social origin or condition, or political or religious ideas.

6 (b) If such a business violates any of these laws, it loses eligibility for business identification on a  
7 specific information sign.

8 (3) No business that owns any outdoor advertising structure in violation of the provisions of Title  
9 75, chapter 15, part 1, may be eligible for business identification on a specific information sign for 1 year after  
10 the illegal outdoor advertising structure is removed unless the owner voluntarily removes it within 45 days of  
11 receiving notification under 75-15-131."

13 **Section 61.** Section 60-5-522, MCA, is amended to read:

14 **"60-5-522. Business eligibility -- criteria -- restrictions.** (1) To be eligible for business identification  
15 on a tourist-oriented directional sign, a business establishment shall meet the following standards for a  
16 business, service, or activity:

17 (a) Gas, food, lodging, and camping services must:

18 (i) be licensed and approved by the state and local agencies regulating the particular type of  
19 business;

20 (ii) provide an acceptable level of service to the public;

22 Sunday; and

23 (iv) have a telephone and restroom facilities available for public use.

- 4 during the normal tourist season; and
- 5 (iii) provide a natural, recreational, historical, cultural, educational, or entertainment activity or a
- 6 unique or unusual commercial or nonprofit activity, from which the major portion of income or visitors is derived
- 7 during normal business seasons from motorists not residing in the immediate area of the activity.
- 8 (2) Priority under subsection (1)(a) must be given to businesses that are in continuous operation
- 9 for 12 months a year.
- 10 (3) (a) Each business identified on a tourist-oriented directional sign shall provide assurance of its
- 11 conformity with all applicable laws concerning the provision of public accommodations without regard to race,
- 12 color, sex, as defined in ~~4-4-204~~ section 1, culture, social origin or condition, or political or religious ideas.
- 13 (b) If a business violates any of these laws, it loses eligibility for business identification on a tourist-
- 14 oriented directional sign.
- 15 (4) A business that owns any outdoor advertising structure in violation of the provisions of Title 75,
- 16 chapter 15, part 1, may not be eligible for business identification on a tourist-oriented directional sign for 1 year
- 17 after the illegal outdoor advertising structure is removed unless the owner voluntarily removes it within 45 days
- 18 of receiving notification under 75-15-131."

20 **Section 62.** Section 61-5-107, MCA, is amended to read:

21 **"61-5-107. Application for license or motorcycle endorsement.** (1) Each application for a learner

22 license, driver's license, commercial driver's license, or motorcycle endorsement must be made on a form

23 furnished by the department. A voter registration form for mail registration as prescribed by the secretary of

24 state must be attached to each driver's license application. If the applicant wishes to register to vote, the

25 department shall accept the registration and forward the form to the election administrator.

26 (2) Each application must include the full legal name, date of birth, sex, as defined in ~~4-4-204~~

27 section 1, residence address of the applicant [and the applicant's social security number], must include a brief

28 description of the applicant, and must provide the following additional information:

1 (a) the name of each jurisdiction in which the applicant has previously been licensed to drive any  
2 type of motor vehicle during the 10-year period immediately preceding the date of the application;

3 (b) a certification from the applicant that the applicant is not currently subject to a suspension,  
4 revocation, cancellation, disqualification, or withdrawal of a previously issued driver's license or any driving  
5 privileges in another jurisdiction and that the applicant does not have a driver's license from another jurisdiction;

6 (c) a brief description of any physical or mental disability, limitation, or condition that impairs or  
7 may impair the applicant's ability to exercise ordinary and reasonable control in the safe operation of a motor  
8 vehicle on the highway;

9 (d) a brief description of any adaptive equipment or operational restrictions that the applicant relies  
10 upon or intends to rely upon to attain the ability to exercise ordinary and reasonable control in the safe  
11 operation of a motor vehicle on the highway, including the nature of the equipment or restrictions; and

12 (e) if the applicant is a foreign national whose presence in the United States is temporarily  
13 authorized under federal law, the expiration date of the official document issued to the applicant by the bureau  
14 of citizenship and immigration services of the department of homeland security authorizing the applicant's  
15 presence in the United States.

16 [(3) The department shall keep the applicant's social security number from this source confidential,  
17 except that the number may be used for purposes of subtitle VI of Title 49 of the U.S.C. or as otherwise  
18 permitted by state law administered by the department and may be provided to the department of public health  
19 and human services for use in administering Title IV-D of the Social Security Act.]

20 (4) (a) When an application is received from an applicant who is not ineligible for licensure under  
21 61-5-105 and who was previously licensed by another jurisdiction, the department shall request a copy of the  
22 applicant's driving record from each jurisdiction in which the applicant was licensed in the preceding 10-year  
23 period. The driving record may be transmitted manually or by electronic medium.

24 (b) When received, the driving records must be appended to the driver's record created and  
25 maintained in this state. The department may rely on information contained in driving records received under  
26 this section to determine the appropriate action to be taken against the applicant upon subsequent receipt of a

9 **Section 63.** Section 72-1-103, MCA, is amended to read:

10 **"72-1-103. General definitions.** Subject to additional definitions contained in the subsequent  
11 chapters that are applicable to specific chapters, parts, or sections and unless the context otherwise requires, in  
12 chapters 1 through 6, the following definitions apply:

13 (1) "Agent" includes an attorney-in-fact under a durable or nondurable power of attorney, an  
14 individual authorized to make decisions concerning another's health care, and an individual authorized to make  
15 decisions for another under a natural death act.

16 (2) "Application" means a written request to the clerk for an order of informal probate or  
17 appointment under chapter 3, part 2.

18 (3) "Beneficiary", as it relates to:

19 (a) a trust beneficiary, includes a person who has any present or future interest, vested or  
20 contingent, and also includes the owner of an interest by assignment or other transfer;

21 (b) a charitable trust, includes any person entitled to enforce the trust;

22 (c) a beneficiary of a beneficiary designation, refers to a beneficiary of:

23 (i) an account with POD designation or a security registered in beneficiary form (TOD); or

24 (ii) any other nonprobate transfer at death; and

25 (d) a beneficiary designated in a governing instrument, includes a grantee of a deed, a devisee, a  
26 trust beneficiary, a beneficiary of a beneficiary designation, a donee, and a person in whose favor a power of  
27 attorney or a power held in any individual, fiduciary, or representative capacity is exercised.

28 (4) "Beneficiary designation" refers to a governing instrument naming a beneficiary of:

1 (a) an account with POD designation or a security registered in beneficiary form (TOD); or

2 (b) any other nonprobate transfer at death.

3 (5) "Child" includes an individual entitled to take as a child under chapters 1 through 5 by intestate  
4 succession from the parent whose relationship is involved and excludes a person who is only a stepchild, a  
5 foster child, a grandchild, or any more remote descendant.

6 (6) (a) "Claims", in respect to estates of decedents and protected persons, includes liabilities of the  
7 decedent or protected person, whether arising in contract, in tort, or otherwise, and liabilities of the estate that  
8 arise at or after the death of the decedent or after the appointment of a conservator, including funeral expenses  
9 and expenses of administration.

10 (b) The term does not include estate taxes or demands or disputes regarding title of a decedent or  
11 protected person to specific assets alleged to be included in the estate.

12 (7) "Clerk" or "clerk of court" means the clerk of the district court.

13 (8) "Conservator" means a person who is appointed by a court to manage the estate of a protected  
14 person.

15 (9) "Court" means the district court in this state having jurisdiction in matters relating to the affairs  
16 of decedents.

17 (10) "Descendant" of an individual means all of the individual's descendants of all generations, with  
18 the relationship of parent and child at each generation being determined by the definition of child and parent  
19 contained in this code.

20 (11) "Devise" when used as a noun means a testamentary disposition of real or personal property  
21 and when used as a verb means to dispose of real or personal property by will.

22 (12) "Devisee" means a person designated in a will to receive a devise. For purposes of chapter 3,  
23 in the case of a devise to an existing trust or trustee or to a trustee or trust described by will, the trust or trustee  
24 is the devisee and the beneficiaries are not devisees.

25 (13) "Disability" means cause for a protective order as described by 72-5-409.

26 (14) "Distributee" means any person who has received property of a decedent from the decedent's  
27 personal representative other than as a creditor or purchaser. A testamentary trustee is a distributee only to the  
28 extent of distributed assets or increment to distributed assets remaining in the trustee's hands. A beneficiary of

1 a testamentary trust to whom the trustee has distributed property received from a personal representative is a  
2 distributee of the personal representative. For purposes of this provision, "testamentary trustee" includes a  
3 trustee to whom assets are transferred by will, to the extent of the devised assets.

4 (15) "Estate" includes the property of the decedent, trust, or other person whose affairs are subject  
5 to chapters 1 through 5 as originally constituted and as it exists from time to time during administration.

6 (16) "Exempt property" means that property of a decedent's estate that is described in 72-2-413.

7 (17) "Fiduciary" includes a personal representative, guardian, conservator, and trustee.

8 (18) "Foreign personal representative" means a personal representative appointed by another  
9 jurisdiction.

10 (19) "Formal proceedings" means proceedings conducted before a judge with notice to interested  
11 persons.

12 (20) "Governing instrument" means a deed; will; trust; insurance or annuity policy; account with  
13 POD designation; security registered in beneficiary form (TOD); pension, profit-sharing, retirement, or similar  
14 benefit plan; instrument creating or exercising a power of appointment or a power of attorney; or dispositive,  
15 appointive, or nominative instrument of any similar type.

16 (21) "Guardian" means a person who has qualified as a guardian of a minor or incapacitated person  
17 pursuant to testamentary or court appointment but excludes one who is merely a guardian ad litem.

18 (22) "Heirs", except as controlled by 72-2-721, means persons, including the surviving spouse and  
19 the state, who are entitled under the statutes of intestate succession to the property of a decedent.

20 (23) "Incapacitated person" has the meaning provided in 72-5-101.

21 (24) "Informal proceedings" means proceedings conducted without notice to interested persons by  
22 the clerk of court for probate of a will or appointment of a personal representative.

23 (25) "Interested person" includes heirs, devisees, children, spouses, creditors, beneficiaries, and  
24 any others having a property right in or claim against a trust estate or the estate of a decedent, ward, or  
25 protected person. The term also includes persons having priority for appointment as personal representative  
26 and other fiduciaries representing interested persons. The meaning as it relates to particular persons may vary  
27 from time to time and must be determined according to the particular purposes of and matter involved in any  
28 proceeding.

1 (26) "Issue" of a person means a descendant.

2 (27) "Joint tenants with the right of survivorship" includes co-owners of property held under  
3 circumstances that entitle one or more to the whole of the property on the death of the other or others but  
4 excludes forms of co-ownership registration in which the underlying ownership of each party is in proportion to  
5 that party's contribution.

6 (28) "Lease" includes an oil, gas, coal, or other mineral lease.

7 (29) "Letters" includes letters testamentary, letters of guardianship, letters of administration, and  
8 letters of conservatorship.

9 (30) "Minor" means a person who is under 18 years of age.

10 (31) "Mortgage" means any conveyance, agreement, or arrangement in which property is used as  
11 security.

12 (32) "Nonresident decedent" means a decedent who was domiciled in another jurisdiction at the  
13 time of death.

14 (33) "Organization" means a corporation, business trust, estate, trust, partnership, joint venture,  
15 association, government or governmental subdivision or agency, or any other legal or commercial entity.

16 (34) "Parent" includes any person entitled to take, or who would be entitled to take if the child died  
17 without a will, as a parent under chapters 1 through 5 by intestate succession from the child whose relationship  
18 is in question and excludes any person who is only a stepparent, foster parent, or grandparent.

19 (35) "Payor" means a trustee, insurer, business entity, employer, government, governmental agency  
20 or subdivision, or any other person authorized or obligated by law or a governing instrument to make payments.

21 (36) "Person" means an individual, a corporation, an organization, or other legal entity.

22 (37) "Personal representative" includes executor, administrator, successor personal representative,  
23 special administrator, and persons who perform substantially the same function under the law governing their  
24 status. "General personal representative" excludes special administrator.

25 (38) "Petition" means a written request to the court for an order after notice.

26 (39) "Proceeding" includes action at law and suit in equity.

27 (40) "Property" includes both real and personal property or any interest in that property and means  
28 anything that may be the subject of ownership.

1 (41) "Protected person" has the meaning provided in 72-5-101.

2 (42) "Protective proceeding" has the meaning provided in 72-5-101.

3 (43) "Record" means information that is inscribed on a tangible medium or that is stored in an  
4 electronic or other medium and is retrievable in perceivable form.

5 (44) "Security" includes any note; stock; treasury stock; bond; debenture; evidence of indebtedness;  
6 certificate of interest or participation in an oil, gas, or mining title or lease or in payments out of production  
7 under such a title or lease; collateral trust certificate; transferable share; voting trust certificate; in general, any  
8 interest or instrument commonly known as a security; any certificate of interest or participation; or any  
9 temporary or interim certificate, receipt, or certificate of deposit for or any warrant or right to subscribe to or  
10 purchase any of the foregoing.

11 (45) "Settlement", in reference to a decedent's estate, includes the full process of administration,  
12 distribution, and closing.

13 (46) "Sign" means, with present intent to authenticate or adopt a record other than a will:

14 (a) to execute or adopt a tangible symbol; or

15 (b) to attach to or logically associate with the record an electronic symbol, sound, or process.

16 (47) "Special administrator" means a personal representative as described by chapter 3, part 7.

17 (48) "State" means a state of the United States, the District of Columbia, the Commonwealth of  
18 Puerto Rico, or any territory or insular possession subject to the jurisdiction of the United States.

19 (49) "Successor personal representative" means a personal representative, other than a special  
20 administrator, who is appointed to succeed a previously appointed personal representative.

21 (50) "Successors" means persons, other than creditors, who are entitled to property of a decedent  
22 under the decedent's will or chapters 1 through 5.

23 (51) "Supervised administration" refers to the proceedings described in chapter 3, part 4.

24 (52) "Survive" means that an individual has neither predeceased an event, including the death of  
25 another individual, nor is considered to have predeceased an event under 72-2-114 or 72-2-712. The term  
26 includes its derivatives, such as "survives", "survived", "survivor", and "surviving".

27 (53) "Testacy proceeding" means a proceeding to establish a will or determine intestacy.

28 (54) "Testator" includes an individual of either sex, as defined in ~~4-1-204~~ [section 1].

1 (55) "Trust" includes an express trust, private or charitable, with additions to the trust, wherever and  
2 however created. The term also includes a trust created or determined by judgment or decree under which the  
3 trust is to be administered in the manner of an express trust. The term excludes other constructive trusts and  
4 excludes resulting trusts; conservatorships; personal representatives; trust accounts as defined in 72-6-111 and  
5 Title 72, chapter 6, parts 2 and 3; custodial arrangements pursuant to chapter 26; business trusts providing for  
6 certificates to be issued to beneficiaries; common trust funds; voting trusts; security arrangements; liquidation  
7 trusts; trusts for the primary purpose of paying debts, dividends, interest, salaries, wages, profits, pensions, or  
8 employee benefits of any kind; and any arrangement under which a person is nominee or escrowee for another.

9 (56) "Trustee" includes an original, additional, or successor trustee, whether or not appointed or  
10 confirmed by court.

11 (57) "Verification" has the meaning provided in 25-4-203 and may be proved by an unsworn written  
12 verification in accordance with 1-6-105.

13 (58) "Ward" means an individual described in 72-5-101.

14 (59) "Will" includes codicil and any testamentary instrument that merely appoints an executor,  
15 revokes or revises another will, nominates a guardian, or expressly excludes or limits the right of an individual  
16 or class to succeed to property of the decedent passing by intestate succession."  
17

18 **SECTION 64.** SECTION 72-17-106, MCA, IS AMENDED TO READ:

19 **"72-17-106. Statewide organ and tissue donation registry.** (1) The department of justice shall  
20 electronically transfer to the federally designated organ procurement organization all information that appears  
21 on the front of a driver's license, including the name, gender, as provided in [section 1], date of birth, and most  
22 recent address of any person who obtains a driver's license and who volunteers to donate organs or tissue  
23 upon death, as provided in 61-5-301. The department of justice may charge actual costs for the first transfer of  
24 information, as provided in subsection (5). However, all subsequent electronic transfers of donor information  
25 must be at no charge to the federally designated organ procurement organization.

26 (2) Information obtained by the federally designated organ procurement organization must be used  
27 for the purpose of establishing a statewide organ and tissue donation registry accessible to in-state, recognized  
28 cadaveric organ and cadaveric tissue agencies for the recovery or placement of organs and tissue and to

1 procurement agencies in another state when a Montana resident is a donor of an anatomical gift and is not  
2 located in the state at the time of death or immediately before the death of the donor.

3 (3) An organ or tissue donation organization may not obtain information from the organ and tissue  
4 donation registry for the purpose of fundraising. Organ and tissue donation registry information may not be  
5 further disseminated unless authorized in this section or by federal law. Dissemination of organ and tissue  
6 donation registry information may be made by the organ procurement organization to a recognized, in-state  
7 procurement agency for other tissue recovery or to an out-of-state, federally designated organ procurement  
8 organization.

9 (4) The federally designated organ procurement organization may acquire donor information from  
10 sources other than the department of justice.

11 (5) All reasonable costs associated with the creation and maintenance of the organ and tissue  
12 donation registry, as determined by the department of justice, must be paid by the organ and tissue  
13 procurement organizations. Any money collected by the department of justice must be deposited in an account  
14 in the state special revenue fund established by the department of justice for the purpose of the payment of  
15 reasonable costs associated with the development and maintenance of the organ and tissue donation registry  
16 and necessary for the initial installation and setup for electronic transfer of the donor information.

17 (6) An individual does not need to participate in the organ and tissue donation registry to be a  
18 donor of organs or tissue. The registry is intended to facilitate organ and tissue donation and not inhibit persons  
19 from being donors upon death."  
20

21 **SECTION 65.** SECTION 90-14-104, MCA, IS AMENDED TO READ:

22 **"90-14-104. Commission on community service.** (1) The governor shall appoint a commission on  
23 community service composed of up to 15 members.

24 (2) Members must include a representative from a tribal government and from at least four state  
25 agencies in the following functional areas:

- 26 (a) natural resources;  
27 (b) human services;  
28 (c) labor;

1 (d) K-12 education;

2 (e) higher education; and

3 (f) military affairs.

4 (3) Members may include representatives from local government, not-for-profit agencies, federal  
5 agencies, business, labor unions, volunteer groups, and private citizens.

6 (4) To the extent possible, membership of the commission must be balanced according to race,  
7 ethnicity, age, gender, as provided in [section 1], and disabilities.

8 (5) The commission shall assist in the development and coordination of state community service  
9 programs, integration of services, dissemination of information, recruitment of volunteers, recruitment and  
10 training of volunteer crewleaders, development of materials, and evaluation of and accountability for the  
11 services provided.

12 (6) Commission members are entitled to payment and reimbursement as provided in 2-15-122(5)."  
13

14 NEW SECTION. Section 66. Repealer. The following section of the Montana Code Annotated is  
15 repealed:

16 1-1-201. Terms of wide applicability.  
17

18 NEW SECTION. Section 67. Codification instruction. [Section 1] is intended to be codified as an  
19 integral part of Title 1, chapter 1, part 2, and the provisions of Title 1, chapter 1, part 2, apply to [section 1].  
20

21 NEW SECTION. Section 68. Severability. If a part of [this act] is invalid, all valid parts that are  
22 severable from the invalid part remain in effect. If a part of [this act] is invalid in one or more of its applications,  
23 the part remains in effect in all valid applications that are severable from the invalid applications.  
24

25 NEW SECTION. Section 69. Effective date. [This act] is effective on passage and approval.
