A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING PROPERTY TAX LAWS; PROVIDING FOR A PROPERTY TAX REBATE ON A PRINCIPAL RESIDENCE BASED ON A CERTAIN AMOUNT OF PROPERTY TAXES PAID FOR TAX YEAR 2024; TEMPORARILY REDUCING CLASS FOUR RESIDENTIAL PROPERTY TAX RATES; REVISING TAX RATES FOR CERTAIN CLASS FOUR RESIDENTIAL AND COMMERCIAL PROPERTY; PROVIDING A LOWER TAX RATE FOR CERTAIN OWNER-OCCUPIED RESIDENTIAL PROPERTY AND LONG-TERM RENTALS; PROVIDING A LOWER TAX RATE FOR A PORTION OF COMMERCIAL PROPERTY VALUE; PROVIDING ELIGIBILITY AND APPLICATION REQUIREMENTS; PROVIDING FOR AN APPEAL PROCESS; PROVIDING DEFINITIONS; PROVIDING RULEMAKING AUTHORITY; AMENDING SECTIONS 15-1-121, 15-6-134, 15-7-102, 15-15-101, 15-15-102, 15-15-103, 15-16-101, AND 15-17-125, AND 15-30-2120, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE DATES, APPLICABILITY DATES, AND A TERMINATION DATE DATES."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

NEW SECTION. Section 1. Definitions. As used in [sections 1 through 7 6] and 15-6-134, the following definitions apply:

- (1) "Homestead reduced tax rate" means the tax rate provided for in 15-6-134(3)(b)(i).
- (2) "Long-term rental" means class four residential property:
 - (a) that is a single-family dwelling unit, unit of a multiple-unit dwelling, trailer, manufactured home, or mobile home and the parcel on which the long-term rental improvements are located but not including any contiguous or adjacent parcels;
 - (b) that an owner can demonstrate was;

1 (I) _____ rented for periods of 28 days or more for at least ~~9~~ 7 months in each tax year for which the
2 rental property reduced tax rate is claimed; OR

3 (II) VACANT FOR NOT MORE THAN 5 MONTHS TO COMPLETE DOCUMENTED PROPERTY REPAIRS;

4 (c) that is occupied by tenants who use the dwelling as a residence during the year in which the
5 reduced tax rate is claimed; and

6 (d) for which the owner is current on payment of the assessed Montana property taxes when
7 claiming the reduced tax rate.

8 (3) "Owner" includes a purchaser under contract for deed as defined in 70-20-115, a grantor of a
9 trust indenture as defined in 71-1-303, and the trustee of a grantor trust that is revocable as defined in 72-38-
10 103.

11 (4) (a) "Principal residence" means class four residential property:

12 (i) that is a single-family dwelling unit, unit of a multiple-unit dwelling, trailer, manufactured home,
13 or mobile home and the parcel on which the principal residence improvements are located but not including any
14 contiguous or adjacent parcels;

15 (ii) in which an owner can demonstrate the owner owned and lived for at least 7 months of the
16 year for which the homestead reduced tax rate for a principal residence is claimed;

17 (iii) that is the only residence for which the owner claims the homestead reduced tax rate for that
18 year; and

19 (iv) for which the owner made payment of the assessed Montana property taxes.

20 (b) An owner who cannot meet the requirements of subsection (4)(a)(ii) because the owner's
21 principal residence changed during the tax year to another principal residence may still qualify for the
22 homestead reduced tax rate if the owner paid the Montana property taxes while residing in each principal
23 residence for a total of at least 7 consecutive months for each tax year.

24 (5) "Rental property reduced tax rate" means the tax rate provided for in 15-6-134(3)(b)(i) ~~and (ii)~~.

25 (6) ~~—~~ "Tax year 2025" means the period from January 1, 2025, through December 31, 2025.

26 (7)(6) "Tax year 2026" means the period from January 1, 2026, through December 31, 2026.

27 (8) ~~—~~ "Tax year 2027" means the period from January 1, 2027, through December 31, 2027.

1 ~~NEW SECTION. Section 2. — Homestead reduced tax rate transition period -- automatic~~
2 ~~qualification -- application for other property.~~ (1) For tax year 2025 and tax year 2026, a class four
3 residential property that is a principal residence automatically qualifies for the homestead reduced tax rate
4 provided for in 15-6-134(3) (b) if:

5 (a) — ~~the owner claimed and received a property tax rebate for tax year 2023 pursuant to Chapter~~
6 ~~47, Laws of 2023;~~

7 (b) — ~~the property did not change ownership after July 31, 2023; and~~

8 (c) — ~~the property remains the principal residence of the owner.~~

9 (2) — ~~The department shall maintain a website for property owners to verify if their property~~
10 ~~automatically qualifies for the homestead reduced tax rate for a principal residence described in subsection (1).~~

11 (3) — ~~The automatic qualification for the homestead reduced tax rate for a principal residence expire~~
12 ~~s after tax year 2026. Beginning in tax year 2027, the owner of a class four residential property that wishes to~~
13 ~~continue to receive the homestead reduced tax rate for a principal residence, regardless of whether the owner~~
14 ~~applied for and received a lower tax rate as provided in subsection (4), shall apply to the department as~~
15 ~~provided in [section 3].~~

16 (4) — ~~The owner of a class four residential property that do es not meet the requirements for~~
17 ~~automatic qualification in subsection (1) for the homestead reduced tax rate for a principal residence but that~~
18 ~~would otherwise qualify under [section 3] may apply for a temporary homestead reduced tax rate for a~~
19 ~~principal residence as provided in [section 3] that is applicable to tax years 2025 and 2026.~~

20 (5) — ~~An application for qualifying property under subsection (4) must be made by March 1, 2025, to~~
21 ~~qualify for a reduced tax rate in tax years 2025 and 2026 and by March 1, 2026, to qualify for a reduced tax rate~~
22 ~~in tax year 2026. If a temporary homestead reduced tax rate is granted under subsection (4), it remains~~
23 ~~effective through the end of tax year 2026.~~

24 (6) — ~~For tax year 2025 and tax year 2026, a class four residential property that qualified for the~~
25 ~~property tax assistance program provided for in 15-6-305 or the disabled veteran program provided for in 15-6-~~
26 ~~311 in tax year 2024 automatically qualifies for the homestead reduced tax rate if the property remains the~~
27 ~~principal residence of the owner.~~

1 NEW SECTION. Section 2. Homestead reduced tax rate -- application -- limitations. (1) Except
2 ~~as provided in 15-6-134(3)(b)(iii), there~~ THERE is a homestead reduced tax rate provided for in 15-6-134(3)(b)(i)
3 for a principal residence as provided in this section.

4 (2) (a) Beginning in tax year ~~2027~~ 2026, the owner of a principal residence may apply to the
5 department to receive the homestead reduced tax rate. THE OWNER OF A PRINCIPAL RESIDENCE WHO APPLIED FOR
6 AND RECEIVED THE REBATE PROVIDED FOR IN [SECTIONS 9 THROUGH 11] FOR TAX YEAR 2024 AUTOMATICALLY
7 QUALIFIES FOR THE HOMESTEAD REDUCED TAX RATE UNLESS SUBSECTIONS (2)(C)(I) THROUGH (2)(C)(III) APPLY TO THE
8 PRINCIPAL RESIDENCE FOR WHICH THE REBATE WAS CLAIMED. THE OWNER OF A PRINCIPAL RESIDENCE WHO DID NOT
9 RECEIVE A REBATE UNDER [SECTIONS 9 THROUGH 11], SHALL APPLY AS PROVIDED IN THIS SECTION TO RECEIVE THE
10 HOMESTEAD REDUCED TAX RATE IN TAX YEAR 2026.

11 (b) To receive the homestead reduced tax rate for the tax year in which the application is first
12 made, the owner shall apply electronically THROUGH THE DEPARTMENT'S WEBSITE or by mail on a form prescribed
13 by the department ~~and postmarked by~~ BETWEEN DECEMBER 1 OF THE IMMEDIATELY PRECEDING YEAR AND March 1.
14 APPLICATIONS SUBMITTED BY MAIL MUST BE POSTMARKED BY MARCH 1. Approved applications received
15 electronically or postmarked after March 1 apply to the following tax year.

16 (c) Once approved, the homestead reduced tax rate remains effective until the end of the tax year
17 in which any of the following events occur:

- 18 (i) there is a change in ownership of the property;
- 19 (ii) the owner no longer uses the dwelling as a principal residence; or
- 20 (iii) the owner applies for a homestead reduced tax rate for a different principal residence.

21 (d) If a homestead reduced tax rate is terminated pursuant to subsection (2)(c) or [section 5 4], any
22 remaining property taxes due for the year in which the homestead reduced tax rate is terminated must be
23 based on the tax rate in effect on January 1 of the year in which the homestead reduced tax rate was
24 terminated.

25 (e) An application for a homestead reduced tax rate must be submitted on a form prescribed by the
26 department and must contain:

- 27 (i) a written declaration made under penalty of perjury that the applicant owns and maintains the
28 land and improvements as the principal residence as defined in [section 1]. The application must state the

1 penalty provided for in [section 4].

2 (ii) the geocode or other property identifier of the principal residence for which the applicant is
3 requesting the homestead reduced tax rate;

4 (iii) the social security number of the applicant; and

5 (iv) any other information required by the department that is relevant to the applicant's eligibility.

6 (3) (a) Except as provided in subsection (3)(b), class four residential property owned by an entity is
7 not eligible to receive the homestead reduced tax rate.

8 (b) The trustee of a grantor revocable trust may apply for a homestead reduced tax rate for a
9 principal residence on behalf of the trust if the dwelling meets the definition of a principal residence for the
10 grantor.

11 (C) CLASS FOUR RESIDENTIAL PROPERTY LOCATED ON FEE LAND WITHIN THE EXTERIOR BOUNDARIES OF
12 AN INDIAN RESERVATION WITHIN THIS STATE IS AUTOMATICALLY ELIGIBLE FOR THE HOMESTEAD REDUCED TAX RATE
13 PROVIDED FOR IN THIS SECTION AND IS NOT REQUIRED TO SUBMIT AN APPLICATION PURSUANT TO SUBSECTION (2).

14 (4) The department shall notify the owner if the homestead reduced tax rate is applied to the
15 property or if the application was denied.

16
17 NEW SECTION. Section 3. Rental property reduced tax rate -- application -- limitations. (1)
18 There is a rental property reduced tax rate provided for in 15-6-134(3)(b) for a long-term rental as provided in
19 this section.

20 (2) (a) ~~The~~ BEGINNING IN TAX YEAR 2026, THE owner of a long-term rental may apply to the
21 department to receive the rental property reduced tax rate. The application must be made by an individual
22 owner or, for an entity owner, by an authorized representative of the entity.

23 (B) THE DEPARTMENT SHALL MAIL A NOTICE TO POTENTIAL CLAIMANTS BY OCTOBER 30, 2025, FOR TAX
24 YEAR 2026. RECEIPT OF A NOTICE DOES NOT ESTABLISH THAT A TAXPAYER OR PROPERTY OWNER IS ELIGIBLE TO
25 RECEIVE THE RENTAL PROPERTY REDUCED TAX RATE, AND A TAXPAYER WHO DOES NOT RECEIVE A NOTICE MAY STILL BE
26 ELIGIBLE TO CLAIM THE RENTAL PROPERTY REDUCED TAX RATE. ALL TAXPAYERS, REGARDLESS OF THE RECEIPT OF
27 NOTICE, SHALL APPLY FOR A REDUCED RATE AS PROVIDED IN THIS SUBSECTION (2).

28 (b)(C) To receive the rental property reduced tax rate for the tax year in which the application is first

1 made, the owner or authorized representative shall apply electronically THROUGH THE DEPARTMENT'S WEBSITE or
2 by mail on a form prescribed by the department and ~~postmarked by~~ BETWEEN DECEMBER 1 OF THE IMMEDIATELY
3 PRECEDING YEAR AND March 1. ~~Approved applications~~ APPLICATIONS received electronically or postmarked after
4 March 1 apply to the following tax year.

5 ~~(e)~~(D) Once approved, the rental property reduced tax rate remains effective until the end of the tax
6 year in which any of the following events occur:

7 (i) there is a change in ownership of the property;

8 (ii) the property is no longer rented to tenants as a dwelling;

9 (iii) the terms of the lease change and the property no longer qualifies as a long-term rental as

10 defined in [section 1]; ~~and~~ OR

11 (iv) the owner fails to submit a ~~complete~~ reapplication to the department as required in subsection

12 (4).

13 ~~(d)~~(E) If a rental property reduced tax rate is terminated pursuant to subsection ~~(2)(e)~~ (2)(D) or
14 [section ~~5~~ 4], any remaining property taxes due for the year in which the rental property reduced tax rate is
15 terminated must be based on the tax rate in effect on January 1 of the year in which the rental property reduced
16 tax rate was terminated.

17 (3) An application for a rental property reduced tax rate must be submitted on a form prescribed by
18 the department and must contain:

19 (a) a written declaration made under penalty of perjury that the applicant owns and maintains the
20 land and improvements as a long-term rental as defined in [section 1]. The application must state the penalty
21 provided for in [section 4].

22 (b) the geocode or other property identifier for the long-term rental for which the applicant is
23 requesting the rental property reduced tax rate;

24 (c) the social security number or taxpayer identification number of the applicant;

25 (d) the income and expense information for the long-term rental for the immediately preceding
26 year, including the amount of rent charged each month; and

27 (e) any other information required by the department that is relevant to the applicant's eligibility.

28 (4) To continue receiving the rental property reduced tax rate, the owner of a qualifying long-term

1 rental shall reapply annually as provided in subsection (3) AS REQUIRED BY THE DEPARTMENT. BEGINNING IN 2028,
2 THE DEPARTMENT SHALL REQUIRE REAPPLICATION OF 20% OF LONG-TERM RENTALS EACH YEAR.

3 (5) Periods of short-term vacancy not exceeding ~~3~~ 5 months in a 12-month period do not disqualify
4 a long-term rental from receiving the rental property reduced tax rate.

5 (6) The department shall notify the owner if the rental property reduced tax rate is applied to the
6 property or if the application was denied.

7
8 **NEW SECTION. Section 4. Homestead and rental property reduced tax rates -- improper**
9 **approval -- penalty for false or fraudulent application.** (1) Except as provided in subsection (2), if the
10 department determines that an application for a homestead reduced tax rate or a rental property reduced tax
11 rate was improperly approved OR THAT THE PROPERTY NO LONGER QUALIFIES FOR THE REDUCED RATE, the
12 department shall revise the assessment for each year the homestead reduced tax rate or the rental property
13 reduced tax rate was improperly granted subject to the assessment revision procedure established in 15-8-601.

14 (2) (a) A person who files a false or fraudulent application for a homestead reduced tax rate
15 provided for in [section 2 ~~or~~ 3] or for a rental property reduced tax rate provided for in [section 4 3] is subject to
16 criminal prosecution under the provisions of 45-7-202.

17 (3) (a) If a person is determined to have filed a false or fraudulent application, the department shall
18 revise the assessment of the property subject to the assessment revision procedure established in this section
19 and 15-8-601 and assess a penalty as provided in this subsection (3). The penalty is equal to three times the
20 base penalty amount calculated under subsection (3)(b) plus interest at the rate provided in 15-16-102
21 calculated from the original due date of the taxes, until paid.

22 (b) The base penalty amount is equal to the property tax due for each year the homestead
23 reduced tax rate or the rental property reduced tax rate was improperly received, determined using the tax rate
24 provided for in 15-6-134(3)(a), the appraised value, and the mill levies in effect for the year, less the actual
25 property taxes paid in the year.

26 (c) The revised assessment and penalty must be assessed against a person who filed a false or
27 fraudulent application even if the person no longer owns the property.

28 (4) If the person who filed a false or fraudulent application no longer owns the property associated

1 with the false or fraudulent application, the penalty plus interest provided for in subsection (3) may be recovered
2 as any other tax owed the state. If the penalty plus interest becomes due and owing, the department may issue
3 a warrant for distraint as provided in Title 15, chapter 1, part 7.

4 (5) Except as provided in subsection (4), if the department determines that a false or fraudulent
5 application was made, the department shall send the revised assessment with the additional penalty amount as
6 determined under subsection (3) to the county treasurer in the county where the property is located.

7 (6) The county treasurer shall distribute property taxes, penalty, and interest collected under this
8 section proportionally to the affected taxing jurisdictions.

9 (7) A revised assessment made under this section must be made within 10 years after the end of
10 the calendar year in which the original application was made.

11

12 NEW SECTION. **Section 5. Appeal of denial of reduced tax rate.** (1) (a) If the department denies
13 an application for a homestead reduced tax rate or a rental property reduced tax rate, the owner may request
14 an informal review of the denial by submitting an objection on written or electronic forms provided by the
15 department for that purpose in a manner prescribed by the department. The objection must be made no later
16 than 30 days after the date of the denial notification sent pursuant to [section 23(4) or 4 3(6)].

17 (b) The property owner may request that the department consider extenuating circumstances to
18 grant an application for the homestead reduced tax rate or the rental property reduced tax rate. Extenuating
19 circumstances include but are not limited to extraordinary, unusual, or infrequent events that are material in
20 nature and of a character different from the typical or customary, and that are not expected to recur.

21 (c) After the informal review, the department shall determine the correct status of the homestead
22 reduced tax rate or the rental property reduced tax rate and notify the taxpayer of its determination by mail or
23 electronically. In the notification, the department shall state its reasons for accepting or denying the application.

24 (2) If a property owner is aggrieved by the determination made by the department after the review
25 provided for in subsection (1), the property owner has the right to first appeal to the county tax appeal board
26 and then to the Montana tax appeal board, whose findings are final subject to the right of review in the courts.
27 An appeal to the county tax appeal board, pursuant to 15-15-102, must be filed within 30 days from the date on
28 the notice of the department's determination. If the county tax appeal board or the Montana tax appeal board

1 determines that the homestead reduced tax rate or the rental property reduced tax rate should apply, the
2 department shall adjust the taxable value of the property in accordance with the board's order.

4 NEW SECTION. Section 6. Rulemaking authority. The department shall adopt rules that are
5 necessary to implement and administer [sections 1 through 7 6].

7 NEW SECTION. SECTION 7. LEGISLATIVE FINDINGS -- LOCAL GOVERNMENT CHARTERS AND FIXED MILL

8 LEVY LIMITS SUPERSEDED -- DEFINITION. (1) (A) THE LEGISLATURE FINDS THAT MOST LOCAL GOVERNMENTS SET MILL

9 LEVIES THAT ADJUST DOWNWARD WHEN TAXABLE VALUE INCREASES UNDER 15-10-420. THIS FLOATING MILL LEVY

10 CONCEPT AUTOMATICALLY LOWERS THE NUMBER OF MILLS LEVIED AGAINST A TAXPAYER WHEN PROPERTY VALUES

11 INCREASE, WHICH MITIGATES INCREASES IN PROPERTY VALUES. HOWEVER, WHEN MILL LEVIES ARE FIXED, THE OPPOSITE

12 OCCURS WHEN PROPERTY VALUES INCREASE, AND PROPERTY TAXES ARE NOT AUTOMATICALLY MITIGATED FOR

13 TAXPAYERS THAT ARE LEVIED BASED ON A FIXED MILL LEVY.

14 (B) THE LEGISLATURE FINDS FURTHER THAT IT IS PROHIBITED UNDER ARTICLE VIII, SECTION 2, OF THE

15 MONTANA CONSTITUTION, FROM SUSPENDING OR CONTRACTING AWAY THE POWER TO TAX. THE LEGISLATURE ALSO

16 RECOGNIZES AND RESPECTS THE POWER OF LOCAL GOVERNMENTS UNDER ARTICLE XI, SECTION 5, OF THE MONTANA

17 CONSTITUTION TO ADOPT, AMEND, REVISE, OR ABANDON A CHARTER.

18 (2) AS A MATTER OF POLICY, THE LEGISLATURE INTENDS TO SUPERSEDE LOCAL GOVERNMENT CHARTERS

19 THAT FIX MILL LEVY LIMITS FOR THE LIMITED PURPOSE OF EXERCISING THE POWER TO TAX WHILE ALSO MAINTAINING

20 LOCAL GOVERNMENT REVENUE SOURCES WITHOUT RAISING TAXES ON RESIDENTIAL TAXPAYERS. HAVING CONSIDERED

21 ALL OPTIONS ON A STATEWIDE BASIS, THE LEGISLATURE FINDS THE STATUTORY STRUCTURE OF THE PROPERTY TAX HAS

22 EVOLVED SIGNIFICANTLY SINCE THE PASSAGE OF INITIATIVE MEASURE NO. 105 ON NOVEMBER 4, 1986, AND THE

23 ENACTMENT OF 15-10-420 BY THE LEGISLATURE IN 1999. GIVEN THE SIGNIFICANT CHANGE IN THE STRUCTURE OF THE

24 PROPERTY TAX AND THE RISING COST OF RESIDENTIAL PROPERTY IN THE LAST 5 YEARS, THERE IS A COMPELLING

25 INTEREST TO ALL THE CITIZENS OF THE STATE TO LOWER RESIDENTIAL PROPERTY TAX RATES FOR PRIMARY RESIDENCES,

26 WHICH CAN ONLY BE ACCOMPLISHED BY THIS SECTION AND 15-10-420.

27 (3) AFTER [THE EFFECTIVE DATE OF THIS SECTION], A LOCAL GOVERNMENT WITH A MILL LEVY LIMIT OF A

28 SPECIFIC NUMBER OF MILLS THAT MAY BE IMPOSED, EITHER BY CHARTER OR BY VOTER APPROVAL MAY:

1 (3) A local government with a charter form of government that includes a mill levy limit of a specific
2 number of mills that may be imposed in the charter shall levy the number of mills in fiscal year 2026 and
3 subsequent tax years that will generate the amount of property taxes assessed in fiscal year 2025, without
4 amending or revising the charter. In fiscal years after 2026, the local government shall levy the number of mills
5 levied in fiscal year 2026.

6 (4) A taxing entity with a local mill levy limit of a specific number of mills that may be imposed for
7 public safety that was authorized by the voters before [the effective date of this section] may:

8 (A) ELECT TO TRANSITION A VOTED MILL public safety LEVY TO A DOLLAR-BASED MILL LEVY EQUAL TO THE
9 AMOUNT OF PROPERTY TAXES ASSESSED IN FISCAL YEAR 2025 AND THEREAFTER SUBJECT TO THE PROVISIONS OF 15-
10 10-420(1)(A); OR

11 (B) LEVY THE NUMBER OF MILLS IN FISCAL YEAR 2026 THAT WILL GENERATE THE AMOUNT OF PROPERTY
12 TAXES ASSESSED IN FISCAL YEAR 2025. IN FISCAL YEARS AFTER 2026, THE LOCAL GOVERNMENT SHALL LEVY THE
13 NUMBER OF MILLS LEVIED IN FISCAL YEAR 2026.

14 (5) As used in this section, "public safety" means police, fire, and emergency medical services.
15

16 **NEW SECTION. SECTION 8. REIMBURSEMENT FOR LOSS OF REVENUE FROM CERTAIN FIXED MILL LEVIES --**

17 **definition.** (1) THE DEPARTMENT SHALL REIMBURSE EACH TAXING ENTITY AS PROVIDED IN THIS SECTION FOR THE
18 REVENUE LOSS RESULTING FROM THE TAX RATE REDUCTIONS IN 15-6-134 AS AMENDED BY [THIS ACT] FOR THE
19 FOLLOWING LEVIES:

20 (A) LEVIES OF A LOCAL GOVERNMENT WITH A CHARTER FORM OF GOVERNMENT THAT INCLUDES A MILL
21 LEVY LIMIT OF A SPECIFIC NUMBER OF MILLS THAT MAY BE IMPOSED IN THE CHARTER; AND

22 (B) LEVIES STATED AS A SPECIFIC MILL LEVY AUTHORIZED BY VOTERS for public safety BEFORE [THE

10 (4) (5) THE DEPARTMENT SHALL DISTRIBUTE THE REIMBURSEMENTS WITH THE ENTITLEMENT SHARE
11 PAYMENTS UNDER 15-1-121(7).

12 (6) AS USED IN THIS SECTION, "PUBLIC SAFETY" MEANS POLICE, FIRE, AND EMERGENCY MEDICAL
13 SERVICES.

15 NEW SECTION. SECTION 9. DEFINITIONS. AS USED IN [SECTIONS 9 THROUGH 11], THE FOLLOWING
16 DEFINITIONS APPLY:

17 (1) "MONTANA PROPERTY TAXES" MEANS THE AD VALOREM PROPERTY TAXES, SPECIAL ASSESSMENTS,
18 AND OTHER FEES IMPOSED ON PROPERTY CLASSIFIED UNDER 15-6-134 THAT IS A SINGLE-FAMILY DWELLING UNIT, UNIT

27 (3) (A) "PRINCIPAL RESIDENCE" MEANS, SUBJECT TO THE PROVISIONS OF SUBSECTION (3)(B), A DWELLING:
28 (I) IN WHICH AN OWNER CAN DEMONSTRATE THE OWNER OWNED AND LIVED FOR AT LEAST 7 MONTHS OF

1 THE YEAR FOR WHICH THE PROPERTY TAX REBATE IS CLAIMED;

2 (II) THAT IS THE ONLY RESIDENCE FOR WHICH THE TAXPAYER CLAIMS THE PROPERTY TAX REBATE; AND

6 PRINCIPAL RESIDENCE CHANGED DURING THE TAX YEAR TO ANOTHER PRINCIPAL RESIDENCE MAY STILL CLAIM THE

7 PROPERTY TAX REBATE IF THE TAXPAYER PAID THE MONTANA PROPERTY TAXES WHILE RESIDING IN EACH PRINCIPAL

8 RESIDENCE FOR A TOTAL OF AT LEAST 7 CONSECUTIVE MONTHS FOR THE 2024 TAX YEAR.

9 (4) "TAX YEAR 2024" MEANS THE PERIOD JANUARY 1, 2024, THROUGH DECEMBER 31, 2024.

11 **NEW SECTION. SECTION 10. PROPERTY TAX REBATE -- MANNER OF CLAIMING -- LIMITATIONS -- APPEALS.**

12 (1) SUBJECT TO THE CONDITIONS PROVIDED FOR IN [SECTIONS 9 THROUGH 11], THERE IS A REBATE OF MONTANA

13 PROPERTY TAXES IN THE AMOUNT OF \$400 OR THE AMOUNT OF TOTAL PROPERTY TAXES PAID, WHICHEVER IS LESS, FOR

14 TAX YEAR 2024.

15 (2) THE REBATE PROVIDED FOR IN SUBSECTION (1) IS FOR MONTANA PROPERTY TAXES ASSESSED TO AND

16 PAID BY A TAXPAYER OR TAXPAYERS ON PROPERTY THEY OWNED AND OCCUPIED AS A PRINCIPAL RESIDENCE DURING

17 TAX YEAR 2024.

18 (3) THE DEPARTMENT SHALL MAIL A NOTICE TO POTENTIAL CLAIMANTS BY JUNE 30, 2025, FOR TAX YEAR

19 2024. RECEIPT OF A NOTICE DOES NOT ESTABLISH THAT A TAXPAYER OR PROPERTY OWNER IS ELIGIBLE FOR A REBATE,

20 AND A TAXPAYER WHO DOES NOT RECEIVE A NOTICE MAY STILL BE ELIGIBLE TO CLAIM A REBATE. ALL TAXPAYERS,

21 REGARDLESS OF THE RECEIPT OF NOTICE, SHALL CLAIM A REBATE AS PROVIDED IN SUBSECTION (5).

22 (4) EXCEPT AS PROVIDED IN SUBSECTIONS (5)(C) AND (5)(D), A SINGLE-FAMILY DWELLING UNIT, UNIT OF A

23 MULTIPLE-UNIT DWELLING, TRAILER, MANUFACTURED HOME, OR MOBILE HOME AND AS MUCH OF THE SURROUNDING

24 LAND, NOT EXCEEDING 1 ACRE THAT IS OWNED BY AN ENTITY IS NOT ELIGIBLE TO CLAIM THE REBATE.

25 (5) (A) (I) ALL CLAIMS FOR THIS PROPERTY TAX REBATE MUST BE SUBMITTED TO THE DEPARTMENT

26 ELECTRONICALLY OR BY MAIL.

27 (II) ELECTRONIC CLAIMS MUST BE SUBMITTED BETWEEN AUGUST 15, 2025, AND OCTOBER 1, 2025,

28 THROUGH THE DEPARTMENT'S WEBSITE.

1 (III) CLAIMS SUBMITTED BY MAIL MUST BE MADE ON A FORM PRESCRIBED BY THE DEPARTMENT AND
2 POSTMARKED BY OCTOBER 1.

3 (IV) THE DEPARTMENT MAY GRANT AN EXTENSION OF TIME IF THE CLAIMANT ESTABLISHES GOOD CAUSE
4 FOR MISSING THE OCTOBER 1 DEADLINE. THE DEPARTMENT'S AUTHORITY TO CONSIDER AN APPLICATION TERMINATES
5 ON DECEMBER 1, 2025, AND ANY APPLICATIONS OR REQUESTS FOR EXTENSION RECEIVED AFTER THAT DATE MAY NOT
6 BE PROCESSED.

7 (B) SUBJECT TO SUBSECTIONS (5)(C) AND (5)(D), A CLAIM FOR REBATE MUST BE SUBMITTED, UNDER
8 PENALTY OF FALSE SWEARING AND THE PENALTIES PROVIDED IN [SECTION 11], ON A FORM PRESCRIBED BY THE
9 DEPARTMENT AND MUST CONTAIN:

10 (I) AN AFFIRMATION THAT THE CLAIMANT OWNS AND MAINTAINS THE LAND AND IMPROVEMENTS AS THE
11 PRINCIPAL RESIDENCE AS DEFINED IN [SECTION 9];

12 (II) THE GEOCODE OR OTHER PROPERTY IDENTIFIER FOR THE PRINCIPAL RESIDENCE THAT THE CLAIMANT IS
13 REQUESTING THE REBATE ON;

14 (III) THE SOCIAL SECURITY NUMBER OF THE CLAIMANT AND THE CLAIMANT'S SPOUSE; AND

15 (IV) ANY OTHER INFORMATION AS REQUIRED BY THE DEPARTMENT THAT IS RELEVANT TO THE CLAIMANT'S
16 ELIGIBILITY.

17 (C) THE PERSONAL REPRESENTATIVE OF THE ESTATE OF A DECEASED TAXPAYER MAY EXECUTE AND FILE
18 THE CLAIM FOR REBATE ON BEHALF OF A DECEASED TAXPAYER WHO QUALIFIES FOR THE REBATE.

19 (D) THE TRUSTEE OF A GRANTOR REVOCABLE TRUST MAY FILE A CLAIM ON BEHALF OF THE TRUST IF THE
20 DWELLING MEETS THE DEFINITION OF A PRINCIPAL RESIDENCE FOR THE GRANTOR.

21 (6) ONLY ONE REBATE WILL BE ISSUED TO A TAXPAYER FOR THE MONTANA PROPERTY TAXES PAID BY THE
22 TAXPAYER FOR TAX YEAR 2024.

23 (7) IF A DEBT IS DUE AND OWING TO THE STATE, THE DEPARTMENT MAY OFFSET THE REBATE IN THIS
24 SECTION AS PROVIDED IN SECTIONS 15-30-2629, 15-30-2630, 17-4-105, OR AS OTHERWISE PROVIDED BY LAW.

25 (8) IF A PROPERTY TAX REBATE IS DENIED BY THE DEPARTMENT, THE CLAIMANT IS ENTITLED TO A WRITTEN
26 EXPLANATION WHY THE APPLICATION WAS DENIED. A CLAIMANT MAY MAKE A WRITTEN APPEAL OF A DENIAL TO A
27 MANAGEMENT LEVEL EMPLOYEE OF THE DEPARTMENT, WHO SHALL ISSUE A FINAL DECISION THAT IS NOT APPEALABLE.
28 APPEALS OCCURRING UNDER THIS SUBSECTION (8) ARE NOT SUBJECT TO THE PROVISIONS CONTAINED IN 15-1-211.

2 **NEW SECTION. SECTION 11. PROPERTY TAX REBATE -- PENALTY FOR FALSE OR FRAUDULENT CLAIM. (1)**

3 EXCEPT AS PROVIDED IN SUBSECTION (2), IF THE DEPARTMENT DISCOVERS THAT A REBATE PAID TO A TAXPAYER
4 EXCEEDED THE AMOUNT ALLOWED BY [SECTIONS 9 THROUGH 11], THE DEPARTMENT MAY, WITHIN 1 YEAR FROM THE
5 DATE THE REBATE WAS TRANSMITTED TO THE TAXPAYER, ASSESS THE TAXPAYER FOR THE DIFFERENCE. THE
6 ASSESSMENT IS SUBJECT TO THE UNIFORM DISPUTE REVIEW PROCEDURE ESTABLISHED IN 15-1-211.

7 (2) A PERSON WHO FILES A FALSE OR FRAUDULENT CLAIM FOR A PROPERTY TAX REBATE UNDER
8 [SECTIONS 9 THROUGH 11] IS SUBJECT TO CRIMINAL PROSECUTION UNDER THE PROVISIONS OF 45-7-202. IF A FALSE OR
9 FRAUDULENT CLAIM HAS BEEN PAID BY THE DEPARTMENT, THE AMOUNT PAID MAY BE RECOVERED AS ANY OTHER TAX
10 OWED THE STATE, TOGETHER WITH A PENALTY OF 300% OF THE REBATE CLAIMED AND INTEREST ON THE AMOUNT OF
11 THE REBATE CLAIMED PLUS PENALTY AT THE RATE OF 12% A YEAR, UNTIL PAID. IF THIS REBATE PLUS PENALTY BECOMES
12 DUE AND OWING, THE DEPARTMENT MAY ISSUE A WARRANT FOR DISTRAINT AS PROVIDED IN TITLE 15, CHAPTER 1, PART
13 7.

15 **SECTION 12. SECTION 15-1-121, MCA, IS AMENDED TO READ:**

16 **"15-1-121. Entitlement share payment -- purpose -- appropriation.** (1) As described in 15-1-
17 120(3), each local government is entitled to an annual amount that is the replacement for revenue received by
18 local governments for diminishment of property tax base and various earmarked fees and other revenue that,
19 pursuant to Chapter 574, Laws of 2001, amended by section 4, Chapter 13, Special Laws of August 2002, and
20 later enactments, were consolidated to provide aggregation of certain reimbursements, fees, tax collections,
21 and other revenue in the state treasury with each local government's share. The reimbursement under this
22 section is provided by direct payment from the state treasury rather than the ad hoc system that offset certain
23 state payments with local government collections due the state and reimbursements made by percentage splits,
24 with a local government remitting a portion of collections to the state, retaining a portion, and in some cases
25 sending a portion to other local governments.

26 (2) The sources of dedicated revenue that were relinquished by local governments in exchange for
27 an entitlement share of the state general fund were:

28 (a) personal property tax reimbursements pursuant to sections 167(1) through (5) and 169(6),

- 2 (b) vehicle, boat, and aircraft taxes and fees pursuant to:

- 10 (vii) Title 61, chapter 3, part 7;
- 11 (viii) 5% of the fees collected under 61-10-122;
- 12 (ix) 61-10-130;
- 13 (x) 61-10-148; and
- 14 (xi) 67-3-205;
- 15 (c) gaming revenue pursuant to Title 23, chapter 5, part 6, except for the permit fee in 23-5-
- 16 612(2)(a);
- 17 (d) district court fees pursuant to:
- 18 (i) 25-1-201, except those fees in 25-1-201(1)(d), (1)(g), and (1)(j);
- 19 (ii) 25-1-202;
- 20 (iii) 25-9-506; and
- 21 (iv) 27-9-103;
- 22 (e) certificate of title fees for manufactured homes pursuant to 15-1-116;
- 23 (f) financial institution taxes collected pursuant to the former provisions of Title 15, chapter 31, part
- 24 7;
- 25 (g) all beer, liquor, and wine taxes pursuant to:
- 26 (i) 16-1-404;
- 27 (ii) 16-1-406; and
- 28 (iii) 16-1-411;

- 1 (h) late filing fees pursuant to 61-3-220;
- 2 (i) title and registration fees pursuant to 61-3-203;
- 3 (j) veterans' cemetery license plate fees pursuant to 61-3-459;
- 4 (k) county personalized license plate fees pursuant to 61-3-406;
- 5 (l) special mobile equipment fees pursuant to 61-3-431;
- 6 (m) single movement permit fees pursuant to 61-4-310;
- 7 (n) state aeronautics fees pursuant to 67-3-101; and
- 8 (o) department of natural resources and conservation payments in lieu of taxes pursuant to former
9 Title 77, chapter 1, part 5.

10 (3) Except as provided in subsection (7)(b), the total amount received by each local government in
11 the prior fiscal year as an entitlement share payment under this section is the base component for the
12 subsequent fiscal year distribution, and in each subsequent year the prior year entitlement share payment,
13 including any reimbursement payments received pursuant to subsection (7), is each local government's base
14 component. The sum of all local governments' base components is the fiscal year entitlement share pool.

15 (4) (a) Except as provided in subsections (4)(b)(iv) and (7)(b), the base entitlement share pool
16 must be increased annually by an entitlement share growth rate as provided for in this subsection (4). The
17 amount determined through the application of annual growth rates is the entitlement share pool for each fiscal
18 year.

19 (b) By October 1 of each year, the department shall calculate the growth rate of the entitlement
20 share pool for the next fiscal year in the following manner:

21 (i) The department shall calculate the entitlement share growth rate based on the ratio of two
22 factors of state revenue sources for the first, second, and third most recently completed fiscal years as
23 recorded on the statewide accounting, budgeting, and human resource system. The first factor is the sum of the
24 revenue for the first and second previous completed fiscal years received from the sources referred to in
25 subsections (2)(b), (2)(c), and (2)(g) divided by the sum of the revenue for the second and third previous
26 completed fiscal years received from the same sources multiplied by 0.75. The second factor is the sum of the
27 revenue for the first and second previous completed fiscal years received from individual income tax as
28 provided in Title 15, chapter 30, and corporate income tax as provided in Title 15, chapter 31, divided by the

1 sum of the revenue for the second and third previous completed fiscal years received from the same sources
2 multiplied by 0.25.

3 (ii) Except as provided in subsections (4)(b)(iii) and (4)(b)(iv), the entitlement share growth rate is
4 the lesser of:

5 (A) the sum of the first factor plus the second factor; or

6 (B) 1.03 for counties, 1.0325 for consolidated local governments, and 1.035 for cities and towns.

7 (iii) In no instance can the entitlement growth factor be less than 1. Subject to subsection (4)(b)(iv),
8 the entitlement share growth rate is applied to the most recently completed fiscal year entitlement payment to
9 determine the subsequent fiscal year payment.

10 (iv) The entitlement share growth rate, as described in this subsection (4), is:

11 (A) for fiscal year 2018, 1.005;

12 (B) for fiscal year 2019, 1.0187;

13 (C) for fiscal year 2020 and thereafter, determined as provided in subsection (4)(b)(ii). The rate
14 must be applied to the entitlement payment for the previous fiscal year as if the payment had been calculated
15 using entitlement share growth rates for fiscal years 2018 and 2019 as provided in subsection (4)(b)(ii).

16 (5) As used in this section, "local government" means a county, a consolidated local government,
17 an incorporated city, and an incorporated town. A local government does not include a tax increment financing
18 district provided for in subsection (8). The county or consolidated local government is responsible for making an
19 allocation from the county's or consolidated local government's share of the entitlement share pool to each
20 special district within the county or consolidated local government in a manner that reasonably reflects each
21 special district's loss of revenue sources for which reimbursement is provided in this section. The allocation for
22 each special district that existed in 2002 must be based on the relative proportion of the loss of revenue in
23 2002.

24 (6) (a) The entitlement share pools calculated in this section, the amounts distributed under 15-1-
25 123(4) for local governments, the funding provided for in subsection (8) of this section, and the amounts
26 distributed under 15-1-123(5) for tax increment financing districts are statutorily appropriated, as provided in 17-
27 7-502, from the general fund to the department for distribution to local governments.

28 (b) (i) The growth amount is the difference between the entitlement share pool in the current fiscal

1 year and the entitlement share pool in the previous fiscal year. The growth factor in the entitlement share must
2 be calculated separately for:

3 (A) counties;

4 (B) consolidated local governments; and

5 (C) incorporated cities and towns.

6 (ii) In each fiscal year, the growth amount for counties must be allocated as follows:

7 (A) 50% of the growth amount must be allocated based upon each county's percentage of the prior
8 fiscal year entitlement share pool for all counties; and

9 (B) 50% of the growth amount must be allocated based upon the percentage that each county's
10 population bears to the state population not residing within consolidated local governments as determined by
11 the latest interim year population estimates from the Montana department of commerce as supplied by the
12 United States bureau of the census.

13 (iii) In each fiscal year, the growth amount for consolidated local governments must be allocated as
14 follows:

15 (A) 50% of the growth amount must be allocated based upon each consolidated local
16 government's percentage of the prior fiscal year entitlement share pool for all consolidated local governments;
17 and

18 (B) 50% of the growth amount must be allocated based upon the percentage that each
19 consolidated local government's population bears to the state's total population residing within consolidated
20 local governments as determined by the latest interim year population estimates from the Montana department
21 of commerce as supplied by the United States bureau of the census.

22 (iv) In each fiscal year, the growth amount for incorporated cities and towns must be allocated as
23 follows:

24 (A) 50% of the growth amount must be allocated based upon each incorporated city's or town's
25 percentage of the prior fiscal year entitlement share pool for all incorporated cities and towns; and

26 (B) 50% of the growth amount must be allocated based upon the percentage that each city's or
27 town's population bears to the state's total population residing within incorporated cities and towns as
28 determined by the latest interim year population estimates from the Montana department of commerce as

1 supplied by the United States bureau of the census.

2 (v) In each fiscal year, the amount of the entitlement share pool before the growth amount or
3 adjustments made under subsection (7) are applied is to be distributed to each local government in the same
4 manner as the entitlement share pool was distributed in the prior fiscal year.

5 (7) (a) If the legislature enacts a reimbursement provision that is to be distributed pursuant to this
6 section, the department shall determine the reimbursement amount as provided in the enactment and add the
7 appropriate amount to the entitlement share distribution under this section. The total entitlement share
8 distributions in a fiscal year, including distributions made pursuant to this subsection, equal the local fiscal year
9 entitlement share pool. The ratio of each local government's distribution from the entitlement share pool must
10 be recomputed to determine each local government's ratio to be used in the subsequent year's distribution
11 determination under subsections (6)(b)(ii)(A), (6)(b)(iii)(A), and (6)(b)(iv)(A).

12 (b) For fiscal year 2018 and thereafter, the growth rate provided for in subsection (4) does not
13 apply to the portion of the entitlement share pool attributable to the reimbursement provided for in 15-1-123(1)
14 and (2). The department shall calculate the portion of the entitlement share pool attributable to the
15 reimbursement in 15-1-123(1) and (2), including the application of the growth rate in previous fiscal years, for
16 counties, consolidated local governments, and cities and, for fiscal year 2018 and thereafter, apply the growth
17 rate for that portion of the entitlement share pool as provided in 15-1-123(3).

18 (c) The growth amount resulting from the application of the growth rate in 15-1-123(3) must be
19 allocated as provided in subsections (6)(b)(ii)(A), (6)(b)(iii)(A), and (6)(b)(iv)(A) of this section.

20 (d) The growth rate provided for in subsection (4) does not apply to the portion of the entitlement
21 share pool attributable to the reimbursement provided for in [section 8].

22 (8) (a) Except for a tax increment financing district entitled to a reimbursement under 15-1-123(5),
23 if a tax increment financing district was not in existence during the fiscal year ending June 30, 2000, then the
24 tax increment financing district is not entitled to any funding. If a tax increment financing district referred to in
25 subsection (8)(b) terminates, then the funding for the district provided for in subsection (8)(b) terminates.

26 (b) One-half of the payments provided for in this subsection (8)(b) must be made by November 30
27 and the other half by May 31 of each year. Subject to subsection (8)(a), the entitlement share for tax increment
28 financing districts is as follows:

13 rendering a decision must be electronically recorded and preserved for 1 year. If the decision of the county
14 board is appealed, the record of the proceedings, including the electronic recording of all testimony and the
15 deliberation of the county tax appeal board, must be forwarded, together with all exhibits, to the Montana board.
16 The date of the hearing, the proceedings before the county board, and the decision must be entered upon the
17 minutes of the county board, and the county board shall notify the applicant of its decision by mail within 3 days.
18 A copy of the minutes of the county board must be transmitted to the Montana board no later than 3 days after

6 conducted within 6 months of the valuation date. If the county tax appeal board does not use the appraisal
7 provided by the taxpayer in conducting the appeal, the county board shall provide to the taxpayer the reason for
8 not using the appraisal."

7 comparison to the amount due for each mill levy in the prior year; and

8 (viii) a notice of the availability of all the property tax assistance programs available to property
9 taxpayers, including the intangible land value assistance program provided for in 15-6-240, the property tax
10 assistance programs under Title 15, chapter 6, part 3, the homestead reduced tax rate provided for in [section 3
11 2], the rental property reduced tax rate provided for in [section 4 3], and the residential property tax credit for
12 the elderly under 15-30-2337 through 15-30-2341.

13 (b) If a tax lien is attached to the property, the notice must also include, in a manner calculated to
14 draw attention, a statement that a tax lien is attached to the property, that failure to respond will result in loss of
15 property, and that the taxpayer may contact the county treasurer for complete information.

16 (c) The information required in subsection (2)(a)(vii) may be posted on the county treasurer's
17 website instead of being included on the written notice.

18 (3) The municipality shall, upon request of the county treasurer, provide the information to be
19 included under subsection (2)(a)(iii) ready for mailing.

20 (4) The notice in every case must be given as provided in 7-1-2121. Failure to publish or post
21 notices does not relieve the taxpayer from any tax liability. Any failure to give notice of the tax due for the
22 current year or of delinquent tax will not affect the legality of the tax.

2 section. Upon attachment of a tax lien, the county is the possessor of the tax lien unless the tax lien is assigned
3 pursuant to 15-17-323.

25 the recovered amount did not reduce the taxpayer's Montana income tax in the year deducted;

28 (m) payments from the Montana end of watch trust as provided in 2-15-2041;

1 (n) (i) subject to subsection (9), a portion of military pensions or military retirement income as
2 calculated pursuant to subsection (8) that is received by a retired member of:

3 (A) the armed forces of the United States, as defined in 10 U.S.C. 101;

4 (B) the Montana army national guard or the army national guard of other states;

5 (C) the Montana air national guard or the air national guard of other states; or

6 (D) a reserve component, as defined in 38 U.S.C. 101, of the United States armed forces; and

7 (ii) subject to subsection (9), up to 50% of all income received as survivor benefits for military
