Description of fiscal impact: As amended, HB 217 increases the fee for a non-resident migratory bird license and generates associated additional revenue.

FISCAL ANALYSIS

Assumptions:

- Effective March 1, 2024, this bill increases the fee for a nonresident migratory game bird license from \$50 to \$150.
- Youth migratory game bird licenses are set at half the adult license price.
- Based on the average number of licenses sold between March and June, the increase in revenue will be \$49,852 in FY 2024. The ongoing revenue will be \$527,300.
- An appropriation is not necessary as this program is funded in HB 5.
