4 A BILL FOR AN ACT ENTITLED: "AN ACT REVISING THE TAX RATES APPLICABLE TO NET LONG-TERM
5 CAPITAL GAINS; AMENDING SECTIONS 15-30-2103 AND 15-30-2120, MCA; AND PROVIDING A DELAYED
6 EFFECTIVE DATE AND AN APPLICABILITY DATE."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

9
10 **Section 1.** Section 15-30-2103, MCA, is amended to read:

11 **"15-30-2103. (Temporary) Rate of tax.** (1) Except as provided in 15-30-3704 there must be levied,
12 collected, and paid for each tax year upon the taxable income of each taxpayer subject to this tax, after making
13 allowance for exemptions and deductions as provided in this chapter, a tax on the brackets of taxable income
14 as follows:

- 15 (a) on the first \$2,900 of taxable income or any part of that income, 1%;
- 16 (b) on the next \$2,200 of taxable income or any part of that income, 2%;
- 17 (c) on the next \$2,700 of taxable income or any part of that income, 3%;
- 18 (d) on the next \$2,700 of taxable income or any part of that income, 4%;
- 19 (e) on the next \$3,000 of taxable income or any part of that income, 5%;
- 20 (f) on the next \$3,900 of taxable income or any part of that income, 6%;
- 21 (g) on any taxable income in excess of \$17,400 or any part of that income, [6.75%].

22 (2) By November 1 of each year, the department shall multiply the bracket amount contained in
23 subsection (1) by the inflation factor for the following tax year and round the cumulative brackets to the nearest
24 \$100. The resulting adjusted brackets are effective for that following tax year and must be used as the basis for
25 imposition of the tax in subsection (1) of this section. (Bracketed language is temporarily amended to "6.9%" on
26 occurrence of contingency for income tax years 2022 and 2023 until December 31, 2023--secs. 8, 10, Ch. 488,

2 (1) Except as provided in ~~15-30-3704 and subsection (2) of this section~~ subsections (2) and (3), there must be
3 levied, collected, and paid for each tax year ~~upon~~on the Montana taxable income of each taxpayer subject to
4 this chapter a tax on the brackets of taxable income as follows:

5 (a) for every married individual who files a joint return and for every surviving spouse:

6 (i) on the first \$41,000 of Montana taxable income or any part of that income, 4.7%;

7 (ii) on any Montana taxable income in excess of \$41,000 or any part of that income, 6.5%;

8 (b) for every head of household:

9 (i) on the first \$30,750 of Montana taxable income or any part of that income, 4.7%;

10 (ii) on any Montana taxable income in excess of \$30,750 or any part of that income, 6.5%;

11 (c) for every individual other than a surviving spouse or head of household who is not a married
12 individual:

13 (i) on the first \$20,500 of Montana taxable income or any part of that income, 4.7%;

14 (ii) on any Montana taxable income in excess of \$20,500 or any part of that income, 6.5%;

15 (d) for every married individual who does not make a joint return and for every estate or trust not
16 exempt from taxation under the Internal Revenue Code:

17 (i) on the first \$20,500 of Montana taxable income or any part of that income, 4.7%;

18 (ii) on any Montana taxable income in excess of \$20,500 or any part of that income, 6.5%.

19 (2) Except as provided in 15-30-3704 and subsection (3) of this section, that portion of a
20 taxpayer's Montana taxable income that consists of net long-term capital gains after accounting for amounts
21 included in taxable income that is not net long-term capital gains is subject to a tax on the brackets of net long-
22 term capital gains as follows:

23 (a) for every married individual who files a joint return and for every surviving spouse:

24 (i) on the first \$41,000 less nonqualified taxable income of net long-term capital gains, 3.0%;

25 (ii) on net long-term capital gains that exceed \$41,000 less nonqualified taxable income or any
26 part of that income, 4.1%, except that if the total nonqualified taxable income is \$41,000 or greater, all of the net
27 long-term capital gains are taxed at 4.1%;

15 **(ii)** on any net long-term capital gains that exceed \$20,500 less nonqualified taxable income or any
16 part of that income, 4.1%, except that if the total nonqualified taxable income is \$20,500 or greater, all of the net
17 long-term capital gains are taxed at 4.1%.

26 term capital gains."

1 **Section 2.** Section 15-30-2120, MCA, is amended to read:

2 **"15-30-2120. (Effective January 1, 2024) Adjustments to federal taxable income to determine**

3 **Montana taxable income.** (1) The items in subsection (2) are added to and the items in subsection (3) are
4 subtracted from federal taxable income to determine Montana taxable income.

5 (2) The following are added to federal taxable income:

6 (a) to the extent that it is not exempt from taxation by Montana under federal law, interest from
7 obligations of a territory or another state or any political subdivision of a territory or another state and exempt-
8 interest dividends attributable to that interest except to the extent already included in federal taxable income;

9 (b) that portion of a shareholder's income under subchapter S. of Chapter 1 of the Internal
10 Revenue Code that has been reduced by any federal taxes paid by the subchapter S. corporation on the
11 income;

12 (c) depreciation or amortization taken on a title plant as defined in 33-25-105;

13 (d) the recovery during the tax year of an amount deducted in any prior tax year to the extent that
14 the amount recovered reduced the taxpayer's Montana income tax in the year deducted;

15 (e) an item of income, deduction, or expense to the extent that it was used to calculate federal
16 taxable income if the item was also used to calculate a credit against a Montana income tax liability;

17 (f) a deduction for an income distribution from an estate or trust to a beneficiary that was included
18 in the federal taxable income of an estate or trust in accordance with sections 651 and 661 of the Internal
19 Revenue Code, 26 U.S.C. 651 and 661;

20 (g) a withdrawal from a medical care savings account provided for in Title 15, chapter 61, used for
21 a purpose other than an eligible medical expense or long-term care of the employee or account holder or a
22 dependent of the employee or account holder;

23 (h) a withdrawal from a first-time home buyer savings account provided for in Title 15, chapter 63,
24 used for a purpose other than for eligible costs for the purchase of a single-family residence;

25 (i) for a taxpayer that deducts the qualified business income deduction pursuant to section 199A
26 of the Internal Revenue Code, 26 U.S.C. 199A, an amount equal to the qualified business income deduction
27 claimed; and

2 Revenue Code, 26 U.S.C. 164(a)(3), an additional amount equal to the state income tax deduction claimed, not
3 to exceed the amount required to reduce the federal itemized amount computed under section 161 of the
4 Internal Revenue Code, 26 U.S.C. 161, to the amount of the federal standard deduction allowable under

14 (ii) railroad retirement benefits;

15 (c) (i) salary received from the armed forces by residents of Montana who are serving on active
16 duty in the regular armed forces and who entered into active duty from Montana;

17 (ii) the salary received by residents of Montana for active duty in the national guard. For the
18 purposes of this subsection (3)(c)(ii), "active duty" means duty performed under an order issued to a national
19 guard member pursuant to:

20 (A) Title 10, U.S.C.; or

21 (B) Title 32, U.S.C., for a homeland defense activity, as defined in 32 U.S.C. 901, or a contingency
22 operation, as defined in 10 U.S.C. 101, and the person was a member of a unit engaged in a homeland
23 defense activity or contingency operation.

24 (iii) the amount received pursuant to 10-1-1114 or from the federal government by a service
25 member, as defined in 10-1-1112, as reimbursement for group life insurance premiums paid;

26 (iv) the amount received by a beneficiary pursuant to 10-1-1201; and

27 (v) all payments made under the World War I bonus law, the Korean bonus law, and the veterans'

12 education expenses, as defined in 15-62-103, of a designated beneficiary;

13 (f) interest and other income related to contributions that were made prior to January 1, 2024, that
14 are retained in a first-time home buyer savings account provided for in Title 15, chapter 63, and any withdrawal
15 for payment of eligible costs for the first-time purchase of a single-family residence;

16 (g) for each taxpayer that has attained the age of 65, an additional subtraction of \$5,500;

17 (h) the amount of a scholarship to an eligible student by a student scholarship organization
18 pursuant to 15-30-3104;

19 (i) a payment received by a private landowner for providing public access to public land pursuant
20 to Title 76, chapter 17, part 1;

21 (j) the amount of any refund or credit for overpayment of income taxes imposed by this state or
22 any other taxing jurisdiction to the extent included in gross income for federal income tax purposes but not
23 previously allowed as a deduction for Montana income tax purposes;

24 (k) the recovery during the tax year of any amount deducted in any prior tax year to the extent that
25 the recovered amount did not reduce the taxpayer's Montana income tax in the year deducted; and

4 (4) (a) A taxpayer who, in determining federal taxable income, has reduced the taxpayer's
5 business deductions:

6 (i) by an amount for wages and salaries for which a federal tax credit was elected under sections
7 38 and 51(a) of the Internal Revenue Code, 26 U.S.C. 38 and 51(a), is allowed to deduct the amount of the
8 wages and salaries paid regardless of the credit taken; or

9 (ii) for which a federal tax credit was elected under the Internal Revenue Code is allowed to
10 deduct the amount of the business expense paid when there is no corresponding state income tax credit or
11 deduction, regardless of the credit taken.

12 (b) The deductions in subsection (4)(a) must be made in the year that the wages, salaries, or
13 business expenses were used to compute the credit. In the case of a partnership or small business corporation,
14 the deductions in subsection (4)(a) must be made to determine the amount of income or loss of the partnership
15 or small business corporation.

16 (5) (a) An individual who contributes to one or more accounts established under the Montana
17 family education savings program or to a qualified tuition program established and maintained by another state
18 as provided in section 529(b)(1)(A)(ii) of the Internal Revenue Code, 26 U.S.C. 529(b)(1)(A)(ii), may reduce
19 taxable income by the lesser of \$3,000 or the amount of the contribution. In the case of married taxpayers, each
20 spouse is entitled to a reduction, not in excess of \$3,000, for the spouses' contributions to the accounts.

21 Spouses may jointly elect to treat half of the total contributions made by the spouses as being made by each
22 spouse. The reduction in taxable income under this subsection (5)(a) applies only with respect to contributions
23 to an account of which the account owner is the taxpayer, the taxpayer's spouse, or the taxpayer's child or
24 stepchild if the taxpayer's child or stepchild is a Montana resident. The provisions of subsection (2)(d) do not
25 apply with respect to withdrawals of contributions that reduced federal taxable income.

27 in 15-62-208.

2 achieving a better life experience program or to a qualified program established and maintained by another
3 state may reduce taxable income by the lesser of \$3,000 or the amount of the contribution. In the case of
4 married taxpayers, each spouse is entitled to a reduction, not to exceed \$3,000, for the spouses' contributions
5 to the accounts. Spouses may jointly elect to treat one-half of the total contributions made by the spouses as
6 being made by each spouse. The reduction in taxable income under this subsection (6)(a) applies only with
7 respect to contributions to an account for which the account owner is the taxpayer, the taxpayer's spouse, or
8 the taxpayer's child or stepchild if the taxpayer's child or stepchild is a Montana resident. The provisions of
9 subsection (2)(d) do not apply with respect to withdrawals of contributions that reduced taxable income.

10 (b) Contributions made pursuant to this subsection (6) are subject to the recapture tax provided in
11 53-25-118.

12 (7) By November 1 of each year, the department shall multiply the subtraction from federal taxable
13 income for a taxpayer that has attained the age of 65 contained in subsection (3)(g) by the inflation factor for
14 that tax year, rounding the result to the nearest \$10. The resulting amount is effective for that tax year and must
15 be used as the basis for the subtraction from federal taxable income determined under subsection (3)(g)."
