4 A BILL FOR AN ACT ENTITLED: "AN ACT REVISING LAWS RELATED TO BICYCLES; PROVIDING
5 REGULATIONS FOR ELECTRICALLY ASSISTED BICYCLES; EXCLUDING ELECTRICALLY ASSISTED
6 BICYCLES FROM THE DEFINITIONS OF "OFF-HIGHWAY VEHICLE", "MOPED", AND "MOTOR VEHICLE";
7 REVISING THE DEFINITION OF "ELECTRICALLY ASSISTED BICYCLE"; AMENDING SECTIONS 23-2-801,
8 61-1-101, AND 61-8-102, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11

12 NEW SECTION. Section 1. Electrically assisted bicycle. (1) Beginning January 1, 2024, a
13 manufacturer or distributor of electrically assisted bicycles as defined in 61-8-102 shall apply a label that is
14 permanently affixed, in a prominent location, to each electrically assisted bicycle. The label must contain the
15 classification number, top assisted speed, and motor wattage of the electrically assisted bicycle and must be
16 printed in arial font in at least 9-point font size.

17 (2) A person may not tamper with or modify an electrically assisted bicycle in order to change the
18 motor-powered speed capability or engagement of an electrically assisted bicycle unless the label required in
19 subsection (1) indicating the classification is replaced after modification.

20 (3) An electrically assisted bicycle must comply with the equipment and manufacturing
21 requirements of the United States consumer product safety commission as set forth in 16 CFR, part 1512, as of
22 December 12, 2022.

23 (4) An electrically assisted bicycle must operate in a manner in which the electric motor is
24 disengaged or ceases to function when the rider stops pedaling or when the brakes are applied.

25 (5) (a) Except as provided in subsections (5)(b) and (5)(c), an electrically assisted bicycle may be
26 ridden, with the motor in operation, in public lands or places managed by the state where bicycles that are
27 solely human powered are allowed, including but not limited to streets, highways, roadways, bicycle lanes, and

1 ~~bicycle or~~ shared-use paths, and natural surface trails.

2 (b) Following notice and a public hearing, a local authority or state agency having jurisdiction over
3 a bicycle or shared-use path may prohibit the motorized operation of a class 1 electrically assisted bicycle on
4 that path if it finds that a restriction is needed for safety reasons or compliance with other laws or legal
5 obligations.

6 (c) A local authority or state agency having jurisdiction over a bicycle or shared-use path may
7 prohibit the motorized operation of a class 2 or class 3 electrically assisted bicycle on that path.

8 (6) No person under 16 years of age may operate a class 3 electrically assisted bicycle. A person
9 under 16 years of age may ride as a passenger on a class 3 electrically assisted bicycle that is designed to
10 accommodate passengers.

11 (7) All class 3 electrically assisted bicycles must be equipped with a speedometer that displays the
12 speed the bicycle is traveling in miles an hour.

14 **Section 2.** Section 23-2-801, MCA, is amended to read:

15 **"23-2-801. Definition.** (1) As used in this part, "off-highway vehicle" means a self-propelled vehicle
16 used for recreation or cross-country travel on public lands, trails, easements, lakes, rivers, or streams. The term
17 includes but is not limited to motorcycles, quadricycles, dune buggies, amphibious vehicles, air cushion
18 vehicles, and any other means of land transportation deriving motive power from any source other than muscle
19 or wind.

20 (2) ~~Off-highway vehicle~~ The term does not include:

21 (a) vehicles designed primarily for travel on, over, or in the water;

22 (b) snowmobiles; ~~or~~

23 (c) except as provided in 23-2-804, vehicles otherwise issued a certificate of title and registered

1 **"61-1-101. Definitions.** As used in this title, unless the context indicates otherwise, the following
2 definitions apply:

3 (1) (a) "Authorized agent" means a person who has executed a written agreement with the
4 department and is specifically authorized by the department to electronically access and update the
5 department's motor vehicle titling, registration, or driver records, using an approved automated interface, for
6 specific functions or purposes on behalf of a third party.

7 (b) For purposes of this subsection (1), "person" means an individual, corporation, partnership,
8 limited partnership, limited liability company, association, joint venture, state agency, local government unit,
9 another state government, the United States, a political subdivision of this or another state, or any other legal or
10 commercial entity.

11 (2) "Authorized agent agreement" means the written agreement executed between an authorized
12 agent and the department that sets the technical and operational program standards, compliance criteria,
13 payment options, and service expectations by which the authorized agent is required to operate in performing
14 specific motor vehicle or driver-related record functions.

15 (3) "Autocycle" means a three-wheeled motorcycle that is equipped with safety belts, roll bars or
16 roll hoops, a steering wheel, and seating that does not require the operator to straddle or sit astride it.

17 (4) "Bus" means a motor vehicle designed for carrying more than 10 passengers and used for the
18 transportation of persons and any other motor vehicle, other than a taxicab, designed and used for the
19 transportation of persons for compensation.

20 (5) (a) "Business entity" means a corporation, association, partnership, limited liability partnership,
21 limited liability company, or other legal entity recognized under state law.

22 (b) The term does not include an individual.

23 (6) (a) "Camper" means a structure designed to be mounted in the cargo area of a truck or
24 attached to an incomplete vehicle for the purpose of providing shelter for persons. The term includes but is not
25 limited to a cab-over, half cab-over, noncab-over, telescopic, and telescopic cab-over.

26 (b) The term does not include a truck canopy cover or topper.

27 (7) "CDLIS driver record" means the electronic record of a person's commercial driver's license

3 agency of another jurisdiction that establishes a verifiable record of ownership between an identified person or

6 (9) "Commercial driver's license" means:

17 (iv) "school bus" has the meaning provided in 49 CFR 383.5.

18 (11) "Commission" means the state transportation commission.

19 (12) "Custom-built motorcycle" means a motorcycle that is equipped with:

20 (a) an engine that was manufactured 20 years prior to the current calendar year and that has been
21 altered from the manufacturer's original design; or

22 (b) an engine that was manufactured to resemble an engine 20 or more years old and that has
23 been constructed in whole or in part from nonoriginal materials.

24 (13) "Custom vehicle" means a motor vehicle other than a motorcycle that:

25 (a) (i) was manufactured with a model year after 1948 and that is at least 25 years old; or

26 (ii) was built to resemble a vehicle manufactured after 1948 and at least 25 years before the
27 current calendar year, including a kit vehicle intended to resemble a vehicle manufactured after 1948 and that is

4 (14) "Customer identification number" means:

5 (a) a driver's license or identification card number when the customer is an individual who has
6 been issued a driver's license or identification card by a state driver licensing authority;

7 (b) a federal employer or tax identification number when the customer is a business entity that has
8 been issued a federal employer or tax identification number;

9 (c) the identification number assigned by the secretary of state to a business entity authorized to
10 do business in this state under Title 35 if the customer is a business entity that does not have a federal
11 employer or tax identification number other than a social security number; or

12 (d) if the customer has not been issued one of the numbers described in subsections (14)(a)
13 through (14)(c), a number assigned to the customer by the department when a transaction is initiated under this

15 (15) (a) "Dealer" means a person that, for commission or profit, engages in whole or in part in the
16 business of buying, selling, exchanging, or accepting on consignment new or used motor vehicles, trailers,
17 semitrailers, pole trailers, travel trailers, motorboats, sailboats, snowmobiles, off-highway vehicles, or special
18 mobile equipment that is not registered in the name of the person.

19 (b) The term does not include the following:

20 (i) receivers, trustees, administrators, executors, guardians, or other persons appointed by or
21 acting under a judgment or order of any court of competent jurisdiction;

22 (ii) employees of the persons included in subsection (15)(b)(i) when engaged in the specific
23 performance of their duties as employees; or

24 (iii) public officers while performing or in the operation of their duties.

25 (16) "Declared weight" means the total unladen weight of a vehicle plus the weight of the maximum
26 load to be carried on the vehicle as stated by the registrant in the application for registration.

27 (17) "Department" means the department of justice acting directly or through its duly authorized

2 (18) "Dolly or converter gear" means a device consisting of one or two axles with a fifth wheel and
3 trailer tongue used to support the forward end of a semitrailer, converting a semitrailer into a trailer.

4 (19) "Domiciled" means a place where:

5 (a) an individual establishes residence;

6 (b) a business entity maintains its principal place of business;

7 (c) the business entity's registered agent maintains an address; or

8 (d) a business entity most frequently uses, dispatches, or controls a motor vehicle, trailer,
9 semitrailer, or pole trailer that it owns or leases.

10 (20) "Downgrade" means the removal of a person's privilege to operate a commercial motor vehicle,
11 as maintained by the department on the individual Montana driving record and the CDLIS driver record for that
12 person.

13 (21) "Driver" means a person who drives or is in actual physical control of a vehicle.

14 (22) "Driver's license" means a license or permit to operate a motor vehicle issued under or granted
15 by the laws of this state, including:

16 (a) any temporary license or learner license;

17 (b) the privilege of any person to drive a motor vehicle, whether or not the person holds a valid
18 license;

19 (c) any nonresident's driving privilege;

20 (d) a motorcycle endorsement; or

21 (e) a commercial driver's license.

22 (23) "Electric personal assistive mobility device" means a device that has two nontandem wheels, is
23 self-balancing, and is designed to transport only one person with an electric propulsion system that limits the
24 maximum speed of the device to 12½ miles an hour.

25 (24) "For hire" means an action performed for remuneration of any kind, whether paid or promised,
26 either directly or indirectly, or received or obtained through leasing, brokering, or buy-and-sell arrangements
27 from which a remuneration is obtained or derived for transportation service.

(f) exhibits a manufacturer's compliance with 49 CFR, part 565, or displays a 17-character vehicle identification number as provided in 49 CFR, part 565; and

(g) is equipped as provided in 61-9-432.

(34) "Low-speed restricted driver's license" means a license limited to the operation of a low-speed electric vehicle or a golf cart issued under or granted by the laws of this state, including:

(b) the privilege of a person to drive a low-speed electric vehicle or golf cart under the authority of 61-5-122, whether or not the person holds a valid driver's license; and

(c) a nonresident's similarly restricted driving privilege.

(35) "Manufactured home" has the meaning provided in 15-24-201.

(36) "Manufacturer" includes any person engaged in the manufacture of motor vehicles, trailers, semitrailers, pole trailers, travel trailers, motorboats, sailboats, snowmobiles, or off-highway vehicles as a regular business.

(37) "Manufacturer's certificate of origin" means the original paper record produced and issued by the manufacturer of a vehicle or, if in a medium authorized by the department, an electronic record created and transmitted by the manufacturer of a vehicle to the manufacturer's agent or a licensed dealer.
